SPECIAL INFORMATION ISSUE

- * Trips planned so far for early 1966
- * Basic Society information in lieu of 1965 Year Book

It was decided by the Committee some time ago that for various reasons such as cost, time and labour spent, the lateness of the AGM, and the questionable value of the publication itself that there should be no Year Book for 1965. It was decided, however, that the useful information normally contained in the Year Book should be published in the Newsletter from time to time -- eg. the 1964/5 Financial Statement appeared in the issue of 15th September 1965.

No complete address list has now been published for fifteen months, and whilst the Constitution remains unaltered from that which appeared in the 1964 Year Book, the numerous changes in the By-Laws are probably unknown to many members. In view of the proposed rejuvenation of the Society it is felt that perhaps most of the more important items normally included in the Year Book should appear in one rather than several Newsletters.

Because of the many amendments therein, and the apparent ignorance of their content anyway, members are requested to carefully read the By-Laws so as to acquaint themselves with the duties and privileges associated with membership of the Society.

Let us as a group have one New Year's Resolution (and keep it !) that in 1966 SUSS shall be a success not only in the number of trips but in the manner of these trips; that as members we shall act as such and not selfishly individually; that we shall, as far as is practicable, fulfil our obligations in respect of organising and running trips (ie. giving adequate notice, submitting trip reports, etc); that borrowed equipment shall be returned promptly; and that we shall conduct the Society, trips, and ourselves in a manner such that we can justifiably be proud of being members of SUSS.

BY - LAWS

A. MEMBERSHIP

1. Applications

When an application for admission to membership of the Society is submitted, this application shall be considered at the Committee Meeting next following, at which meeting a report, either written or verbal, shall be received from at least one of the Trip Leaders of the applicant's official trips.

2. (Rescinded).

3. Badges

Badges shall be hired out to members for a deposit of 5/- (50c). Each badge must at all times remain in the possession of the member to whom it is issued. The Committee may at its discretion, recall any badge and may refund the 5/- (50c).

4. (Rescinded).

5. Publications

The Society shall publish a Newsletter to be known as SUSS, issued at least once every two months. All copies posted to the private address of members, correspondents, and subscribers will be forwarded regularly. The price of 6d.(5c) per issue shall be included in the annual subscription of all classes of membership and this money shall be set aside for the periodical and shall be separately accounted for in the Annual Balance Sheet and be duly audited. Non-members of the Society may receive all publications of the Society upon payment of the Corresponding Membership fee. This fee includes the above subscription to the Newsletter SUSS.

6. Prospective Members

Prospective Members may receive the Society's circulars and other information for a period of six months after payment of a fee of 2/6d.(25c). If a Prospective Member becomes a Full Member or an Associate Member within six months of paying the fee then the 2/6d.(25c) will be deducted from his appropriate membership fee.

7. Discipline

The Committee may at its discretion, suspend the membership of a person alleged to either have breached the rules of the Society or refused to have obeyed the decisions of the Committee and/or General Meeting and whose alleged conduct reflects unfavourably on the Society, until the question of disciplinary action under Clause 7 of the Constitution has been dealt with within a period of 50 days after the suspension.

B. MEETINGS

1. Meeting Procedure

The procedure followed at meetings shall be that laid down by Joske in the current edition of "Law and Procedure at Meetings".

2. Committee Meetings

The Secretary shall notify Committee Members in writing of the details of coming Committee Meetings at least one week in advance.

3. (Rescinded).

C. DUTIES

1. Financial Statements

A financial statement shall be submitted at each Committee Meeting by the Treasurer. This statement shall contain details of all financial transactions and accounts for payment, transacted since the last Committee Meeting.

2. Trip Leaders

The duties of the Trip Leader shall be:

(a) To give full details of a proposed trip to the Publicity Officer 14 days in advance of the departure date.

(b) To submit a duly authorised request for permission to visit the area, if it is under restricted access, at least 10 days before the proposed departure date.

(c) To make sure that any Prospective member or non-member attending the trip is issued with a copy of the S.U.S.S. Code of Ethics and undertakes to abide by the Society's rules. (Amendment 8.12.65)

(d) To be thoroughly conversant with the firelighting and other regulations governing the area he is visiting and to see that the trip abides by these regulations.

(e) To reprimand anyone on the trip breaking the Society's rules or local regulations or behaving in any way that could discredit the Society.

(f) To forward a Trip Report together with Trip Fees within 14 days of the completion of the trip. Any Trip Leader who fails to submit a Trip Report or remit these Fees within one month of the completion of the trip shall, at the discretion of the Committee, be deemed to have resigned his status as Trip Leader. (Amendment 8.12.65)

(g) To see that all S.U.S.S. equipment borrowed for the trip is returned to the Equipment Officer within 7 days of the completion of the trip. (Amendment 8.12.65)

(h) To make known to the Safety Officer any perils, hazards, or misadventures encountered on the trip.

6. Trip Reports

Suitably worded Reports of all Tourist Cave Trips shall be sent to the Director and either sent to or left at the resort.

7. Area Directors

All Area Directors and the Subcommittee for Remote and Inaccessible Places shall submit a report to the Committee for publication in the Journal and all recent developments shall be submitted to the Secretary for publication in the Newsletter.

8. Safety Officer

At each A.G.M. a Safety Officer shall be elected. The duties of the Safety Officer shall be:

(a) To keep up to date with current overseas and local safety practices.

(b) To regularly inspect equipment and report on its condition to the Committee and Equipment Officer.

(Amendment 8.12.65)

(c) To make recommendations of safe practices and ensure that they are carried out.

(Amendment 9.7.64)

(d) To act as Society representative on the A.S.F. Safety Subcommittee.

(e) To organise Search and Rescue trips and field days as directed by the Committee.

(Amendment 8.12.65)

9. Equipment Officer

The Committee shall appoint an Equipment Officer. His duties shall be:

(a) To store the Society's equipment.

(b) To lend equipment as outlined in Section E of these By-Laws, and record borrowings on the appropriate form.

(c) To inspect equipment on issue and return.

(d) To report to the Safety Officer any damage to equipment and to the Committee any failure to return equipment.

(Section 9, Amendment 8.12.65)

D. TRIPS

1. Official Trips

(a) An official trip shall be defined as one for which approval of at least two members of the Committee has been gained in writing; approval to be submitted to the Secretary and Publicity Officer not less than 14 days in advance of the departure date. Only on official trips may members use the Society's name to gain any privileges. If proposing to visit an area with restricted access a duly authorised request for permission conforming with the appropriate authority's requirements for such requests shall be submitted to that authority at least 10 days in advance of the departure date.

(b) A limit on the number attending an official trip shall only be imposed where either the nature of the area or the nature of the proposed work make such a limit essential.

(c) Providing that such a limit on any trip has not been filled, any member of the Society shall be entitled to join such a trip up to that limit.

(d) All members shall give prior notification to the Trip Leader of their intended participation in a trip, and shall obey the reasonable requests of the Trip Leader while on that trip.

(Amendment 8.12.65)

(e) No trip application may be authorised by any Committee member, unless the intending Trip Leader has been authorised as a Trip Leader by the Committee.

(f) Before considering any person as a Trip Leader the Committee shall be satisfied that the applicant has sufficient sense of responsibility and discipline to conduct the activities of a trip in a safe manner, and to ensure the conservation of any cave or cave reserve visited. In addition the Committee shall be satisfied that the applicant is:

(i) Sufficiently experienced in the practical aspects of caving to capably lead a party, under the variety of caving conditions likely to be encountered.

(ii) Familiar with the topics discussed in SUSS Journal (Volume 6 Number 3) pertaining to caving technique, safety precautions, and design, choice, use and care of caving equipment.

(iii) Proficient in the use of knots listed in the SUSS Journal (Volume 6 Number 3) and the Fisherman's Knot, and is aware of the advantages and disadvantages of each.

(iv) Familiar with basic first aid techniques and the procedures associated with caving emergencies.

(Section f, Amendment 1.10.64)

(g) The Committee shall from time to time, and in any case at least once annually, re-examine the list of authorised Trip Leaders with a view to appointing additional Trip Leaders and revoking the appointment of those who have failed to fulfil their obligations under the By-Laws.

3. Trip Fees

Non-members of the Society may attend trips at the discretion of the Trip Leader on payment to him of a Trip Fee of 5/-(50c). Members and Prospective members wishing to attend shall have priority over any non-member.

4. General Trips

(a) A General Trip shall be defined as a trip organised by the Committee with transport arranged for all members who wish to attend.

(b) (Rescinded 8.12.65).

5. Liquor on trips

No person shall be in possession of liquor on any S.U.S.S. trip without having first obtained permission of the Trip Leader.

6. (Rescinded 8.12.65).

7. No firearms shall be taken or discharged on trips.

E. EQUIPMENT

1. The Ian Carpenter Equipment Pool

(a) An equipment pool entitled the "Ian Carpenter Equipment Pool" shall be established.

(b) The equipment pool shall make equipment available to members or intending members of S.U.S.S. at the discretion of the Equipment Officer, and to non-members of S.U.S.S. at

the discretion of the Committee, when a deposit, fixed at a Committee Meeting, shall be received by the Equipment Officer.

(c) Borrowers shall be responsible for the return of equipment to the Equipment Officer in the condition in which it was received. On such return, the deposit shall be refunded. Failing such return, the borrower shall be responsible to the Society for the cost of repair or replacement of the equipment, unless the Committee waives this responsibility.

(d) The borrower of any item of SUSS equipment shall report to the Equipment Officer any faults or damage in that equipment which is likely to affect its future safe and efficient use, the report to be made no later than when the item is returned to the Equipment Officer.

(e) The pool shall be maintained by grants of Society funds made at a Committee Meeting. (Amendment 8.12.65)

2. Deposit on Equipment

Society equipment may be loaned on lodgement with the Equipment Officer of a deposit of 10/-(\$1) per item.

F. CAVES

1. Blasting in Caves

Any blasting to be carried out underground by a member of the Society will require the approval of the Committee at a Meeting before it is carried out.

2. Naming of Caves

Approval of the Committee shall be required before the name is given to a new cave.

G. SUSS PRODUCTIONS

Leaving Home ? ? ?

With the advent of address labels for the Newsletter wrappers, it is imperative that members notify the Assistant Secretary, Geoff Butlin (462213 or Box 35, The Union) PROMPTLY of any change of address or other vital statistics so that appropriate alterations can be made in the master address list, to ensure speedy delivery of subsequent Circulars.

S.U.S.S. CODE OF ETHICS

This Code was adopted by the Committee on 5th December 1960, not as a firm statement of how members should behave, but as a guide to the responsibilities which are an integral part of being a speleologist. It is obvious from the substance of this Code, that members ought to regard this as a firm basis of conduct to be followed on trips, etc.

RESPONSIBILITIES TO THE COMMUNITY

Members should be conservation minded at all times, above, as well as below ground. Members should not damage or deface the caves either accidentally or by design, especially being careful not to:

- (i) walk over clean cave formation in boots or muddy footwear.
- (ii) break or deface cave formation.
- (iii) leave rubbish (especially carbide or flashbulbs) lying around in any cave.
- (iv) write or leave markings on the walls and roof of any cave except to unobtrusively record a new discovery.

Members should see that on any S.U.S.S. trip no offense is given to the public, property owners or to those who control the caves. Some means of achieving this are:

- (i) Carefully observe the established rules of good camping conduct. Eg. Don't use others' fires, wood or water without invitation, and when you do use them do your share of replacing. Use dead wood as far as possible for tent poles. Leave a campsite in such a condition that it is difficult to tell whether it has been camped on recently. Bury carbide, rubbish and human waste well away from camp and tracks. Bury food scraps rather than leaving them on a dead fire or throwing them into a creek. Burn, bash and bury all tins. Always wash or swim well downstream from where drinking water is obtained. Put out all fires with water.
- (ii) Close all gates on properties and reserves after use.
- (iii) Take care to avoid any interference to stock and crops.
- (iv) Gratefully acknowledge any hospitality received.

RESPONSIBILITIES TO THE SOCIETY

In order to continue to visit caving areas, which are all under Government or private control, it is essential that S.U.S.S. maintains a high reputation. It is the responsibility of every member to see that nothing occurs on a trip to discredit S.U.S.S. It is even more important that silly stories, either real or imaginary, that reflect unfavourably on S.U.S.S. not be started or spread by members. It is essential that good relations be maintained with other Speleological Societies. When visiting an area in which other Societies are interested, notify them and invite their members to attend.

RESPONSIBILITIES TO FELLOW S.U.S.S. MEMBERS

No member should ever do anything to endanger the safety of

others attending a caving trip. Furthermore, a member should not annoy other members or visitors attending a trip and so interfere with their enjoyment of the trip. Members should realise their responsibility to other members, present and future, not to compromise the good reputation of S.U.S.S.

TOURIST BUREAU PERMIT REQUIREMENTS

Before running a trip to an area directly controlled by the Government (eg. Jenolan) the Trip Leader must obtain a Permit from the N.S.W. Government Tourist Bureau in writing. The Bureau requirements for such permits are summarised hereunder. The K.S.P. requirements (ie. for Yarrangobilly) are essentially the same. Members should also remember that they must not trespass on or enter areas under private control before obtaining permission from the owner, lessee, etc., of such area.

1. The group to visit the caves must come from an accredited Speleological Society.
2. The object of the visit must be demonstrably scientific.
3. The majority of the members of the group must be experienced spelcologists.
4. The maximum number of members on any one trip must be twelve of whom four can be prospective members of the Society.
5. Each trip must be under the leadership of a fully experienced speleologist who will be responsible to ensure that, on the trip members of the group observe all the tenets of caving ethics as practised by caving organisations throughout the world.
6. Applications for permission to undertake cave trips must be lodged with the Department at least seven days in advance of the date of the proposed trip. The application should be signed by the Secretary of the Society.
7. Each application should indicate the purpose of the trip and must contain a list of the persons comprising the group.
8. Upon arrival at the resort the group Leader must report to the Manager, Senior Guide, Superintendent or caretaker as the case might be.

Editorial Note on the implications of these requirements.

1. While S.U.S.S. fulfils the requirement of being an accredited Speleological Society, any trip to a Government-controlled area MUST be an Official Trip and comply with the Society's By-Laws relating to such trips (see especially By-Law D 1).
2. On trips to Government-controlled areas no non-members or non-Prospective members can participate (and this means girl-friends who are not members !).
3. Unless we religiously comply with these requirements we may find bona-fide applications refused in future; it is essential that S.U.S.S. maintain a justifiably high reputation with the Tourist Bureau. Remember these rules are mainly designed to ensure conservation of caves and caving areas.
