

## ..EDITORIAL..

The majority of cave divers just want to keep on diving and it is to be hoped that this will be the unifying aim. We need continuing emphasis on good landowner relationships in order to maintain present access arrangements and re-open holes currently closed. Doug has done a lot of work finding out what the landowners and government bodies want. Your job is easy: read the centre pages and follow the access instructions.

# 4 Advanced Category 3 now called Category 4

At the instigation of the Mount Gambier Council, a proposal to re-name Advanced Category 3 as 'Category 4' was passed at the CDAA National Committee meeting held in Mount Gambier on the weekend of 12/13 December 1987.

Members holding an Adv Cat 3 card will eventually be provided with their new Cat 4 card, and the Constitution and Regulations will be amended soon to reflect this change.

Reprinted from Guidelines No 29 are the rules for becoming Category 4:

#### CATEGORY 4 - APPLICATIONS - NEW RULES

To apply for Category 4 rating you should submit a list of 20 Category 3 dives (or equivalent) to the CDAA Committee. You must have been a Category 3 diver for at least 12 months, and you must have dived at least once in Pines, Fossil and Allendale East sinkholes. You must have done at least two dives in Englebrechts East. The remainder of the dives may have been done at Mount Gambier or at any other location (eg Nullabor or Jenolan).

The overall requirement is to demonstrate adequate expertise in cave diving, and each application will be evaluated by the National Testing Officer and the Committee. A \$5 card update fee applies to an upgrade to Category 4.

" COMPUTER COMPUTER " .. RECORDS .. NEW COMPUTER FOR CDAA RECORDS

As many of you will be aware, there have been a few troubles with our mailing list, and several notified changes of address did not get through, resulting in members missing out on 'Guidelines'. There is also now a new requirement to be able to produce lists of members' names and category for the various landowners.

Well, dear members, here it is at last! The solution to all these problems. The CDAA has purchased a Personal Computer (PC) which will be used by the National Records Officer (Peter Girdler). The PC cost \$2870 and for the technically-minded members, it is a Lazer XT Turbo with a 20 Mbyte hard disc, 5.25 inch 360 kByte floppy drive, high resolution green screen and a dot-matrix printer.

The computer will enable quick updating of records and the production of an up to date mailing list. All of the information currently stored on cards will be transferred to the computer, and as an added bonus, the new style membership cards will be printed directly by the computer.

We will now be able to obtain information from the computerized system which was simply not available from the old card system in the past. For example, it will be possible to extract various statistics on members.

#### PRESIDENT'S REPORT

The main objective for the remainder of the 1987/88 year will be to gather all the documentation and produce the new Training Manual.

Published in the last Guidelines was a list of the all the topics to be included in the Manual. At the recent National Committee meeting (December 1987), general members who have definite skills relating to these topics were identified and letters have been forwarded seeking their contributions. We hope to have some draft information by the March 1988 National Committee meeting, at which time the final format of the Manual will be finalised.

'Part of the Training package will encompass an accepted sinkhole being deemed as classified for training. That sinkhole will be Gouldens and negotiations are currently underway with the Lands Department.

Some of the areas under negotiation are:

- a. Pre-requisites for scuba divers wishing to train in Gouldens ie CDAA membership, basic pool training first, etc
- b. The safeguard conditions relating to the experience of the people who will accompany possible non-categorized divers into the hole when training.
- c. The numbers of people likely to avail themselves of the venue. ie the effect on the hole's environment.
- d. What work has to be done to the site. ie platform, entry/exit paving, climbing pitons and so on.

As in the past, please feel free to pass your comments on to me.

On Sunday 13 Dec 87 the South Eastern Region representative and myself visited Reg and Mary Watson. We discussed the diver-property agreement drafted last year which Reg has been looking into.

Aside of some reasonable additions, all of which can be easily fitted into the current format, general acceptance of the agreement was reached.

In addition to this Reg has consulted with Greg Muller from the Mount Gambier City Corporation (who handled the CDAA-Council Deed) and has been advised that a CDAA-Landowner agreement should also be entered into.

I have finished that additional document and Reg should have it as you read this report. I am confident that it will also meet with the same approval.

I can assure you that Reg is as eager to finalise this matter as we all are, but his reponsibility to the property owners takes precedence.

Again, Thanks for your patience.

#### Secretary's Report

This report incorporates the salient points from the National Committee meeting held in Mount Gambier on Saturday 12 December 1987.

Present: Peter Girdler, Lance Mitchell, John Vanderleest, Doug MacLeod, Cheryl Bass, Nick Jones. Apologies: Max Marriott, Judi Minervini, Ian Ploenges, Ian Lewis

Many of the matters discussed have already been covered elsewhere in Guidelines, either in the 'News' or in the President's Report. Other points discussed were as follows:

- CDAA Application Form. A new Application Form will be designed and it should be easier for candidates and Eaminers to fill in correctly.
- Category 1 cards no longer require a photograph, but they must be b. sent back to the Records Officer for upgrading to Category 2.
- Mount Gambier Council Agreement. The Mount Gambier Council Agreement is being slightly amended to remove the old equipment standards which were inadvertently included in the Agreement. Some members have pointed out that they shouldn't have to sign to say they will be weraing a snorkel, wet suit and bourdon tube depth gauge when a snorkel will cause snagging, they always use a dry suit and they don't possess a bourdon tube. As these alterations do not alter the spirit of the Agreement, it is not expected that the Mount Gambier Council will have any objections.

The Agreement is printed in full in this issue of Guidelines.

- ASF/CDAA Agreement. A draft agreement between the Australian Spelaeological Federation and the CDAA was examined. The ASF cannot recommend that the CDAA standards be THE cave diving standard until the CDAA recommends/requires the use of independent (dual) air supplies for all penetration diving (such as in Englebrechts East and West) .
- Independent Air Supplies. The Committee recommended to the Examiners that the theory and practise of independent (dual) air supplies be included in the Category 3 test.
- Reduced Fee for Couples. It was decided not to introduce reduced fees for couples (both being members of the CDAA), as was requested by a member. The only possible saving to the CDAA would be if only one Guidelines was sent (and in fact many couples like to each receive their own copy) and there are many other costs involved in running the CDAA (apart from producing Guidelines), and these costs should be borne by each member. Finally, with the changing pattern of society the CDAA would probably end up with additional administrative costs if relationships changed.
- Leave of Absence. Two members have written requesting suspension of CDAA membership whilst overseas. Again it was decided that for those few people affected, the administrative problems of introducing this and working out who qualifies, etc, would not be cost effective.

Cave Divers Association of AUSTRALIA. It was suggested that h. Australian regions may be able to organise their own qualification system for their particular cave diving conditions, and then it would be necessary to organise whatever cross over requirement was needed to become a Mount Gambier cave diver.

In addition a number of items were also discussed relating to specific problems as sent in by individuals and also there was the usual free ranging discussion on all matters relating to the CDAA. The Committee meeting was greatly facilitated by arranging for the Committee members to all stay under one roof.

# ACCESS..ACCESS..ACCESS

#### SINKHOLES ACCESS ARRANGEMENTS

Permission to dive any sinkhole must be obtained.

Updated information on how to obtain permission to dive on private land has been gathered by Mr Doug MacLeod and is summarized in the chart.

Current procedures for gaining access to government land is also tabulated. But, be warned, these procedures are under review. Any changes will be published in Guidelines.

There should be no need to remind you how important it is that we all go about our diving in the right way. A few divers have stepped outside these guidelines and have been duly penalised. But the trouble is that landowners remember these few divers and forget the hundreds of divers who are following the rules.

### PROTOCOL FOR DIVING IN THE SINKHOLES OF MOUNT GAMBIER REGION

#### General Rules to be observed on all Properties

- 1. Permission to enter remains the perogative of the landowner or landowner representative.
- 2. Stock must not be disturbed unnecessarily.
- 3. Drive with care and stay on existing tracks.
- 4. All gates opened must be closed.
- 5. Any rubbish carried in must be taken out.
- 6. Smoking is prohibited when the grass is dry and during summer; the exception to this rule is on Horse and Cart and Tea Tree where smoking is PROHIBITED AT ALL TIMES.
- 7. No dogs allowed.
- 8. Additional rules apply on certain properties and are listed alongside the contact information.

#### DIVING DEED

THIS DEED is made on the date in Item 1 of the Schedule hereto <u>BETWEEN</u> the person named and described in Item 2 of the Schedule (hereinafter together with his or her administrators and executors is called the "Diver") of the first part <u>AND CITY OF MOUNT GAMBIER</u> of 10 Watson Terrace Mount Gambier in the State of South Australia ("the Council") of the second part

#### WHEREAS

- A. The Council is the owner of certain land known as the Englebrecht Cave Reserve (the "Reserve") on which there exists underwater caves known as sinkholes, there being an easterly sinkhole and a westerly sinkhole on the Reserve;
- B. The Diver wishes to dive in either or both of the sinkholes on the Reserve from time to time using scuba or other means of diving and other equipment;
- C. The Council will permit the Diver to dive at the Reserve if the Diver complies with certain conditions and the requirements of the CAVE DIVERS' ASSOCIATION OF AUSTRALIA INCORPORATED (the "Association") and indemnifies the Council against claims made against the Council as a result of granting such permission;

#### NOW IT IS HEREBY AGREED AS FOLLOWS:

- 1. In consideration of the payment of the sum of FIVE DOLLARS (\$5.00) to the Council by the Diver, the Council will permit the Diver to enter the Reserve and dive in any sinkhole thereon provided that the Diver complies at all times with the terms of this deed and all the requirements of the Association.
- 2. The Council may refuse permission to enter the Reserve and/or dive in any or both of the sinkholes thereon at any time and such refusal may relate to days, occasions or sinkholes or be general in its nature.
- The Diver enters and remains on the Reserve and in any sinkhole thereon solely at the Diver's risk.
- 4. The Diver acknowledges that he or she is aware of the risk of silting of the water in the sinkholes on the Reserve and that visibility may be lost in consequence thereof.

- 5. The Diver shall take all reasonable steps to acquaint himself or herself with the characteristics of the sinkholes on the Reserve prior to diving therein.
- 6. The Diver agrees that he or she has undertaken proper training and testing programmes so that prior to diving in any particular sinkhole the Diver has satisfied the Association and has passed tests which show that the Diver is capable of diving in that sinkhole safely and is aware of the dangers and characteristics of that particular sinkhole and is capable of handling and facing those dangers and characteristics and without derogating from the generality of the foregoing is aware of the dangers and likelihood of silting of the waters and the reduction in visibility and other dangers and hazards of deep water diving including nitrogen narcosis and the bends and further is capable of using hand lines to exist from a sinkhole safely in conditions of low or zero visibility.
- 7. The Diver agrees that he or she will not dive in any sinkhole on the Reserve unless -
  - (1) the Diver is a current member of the Association and is accompanied on any dive by a current member;
  - (2) the Diver has been tested by and has current approval from the Association to dive in the sinkhole in which the Diver proposes to dive; and
  - (3) the Diver is equipped in the manner specified by the Association.
- The Diver will not dive below thirty seven (37) metres or the maximum diving depth stipulated by the Council, whichever is the lesser depth.
- 9. The Diver agrees that he or she will not make any claim or initiate any proceedings against the Council or any of the Council's officers servants or agents which may result from or relate to the Diver's presence on the Reserve or the Diver diving in any sinkhole thereon.
- 10. The Diver agrees that he or she will indemnify and hold harmless and will keep indemnified and held harmless the Council and the Council's servants and agents and any lessee of the Reserve from and against all claims, demands, costs, damages, losses, expenses, actions or proceedings arising out of, connected with or in any way related to -
  - (1) this deed; and/or

- (2) any diving that the Diver may do in any sinkhole on the Reserve; and/or
- (3) the presence of the Diver on the Reserve; and/or
- (4) any advice or information given to the Diver by the Council or the Council's officers servants or agents or any lessee of the Reserve.
- 11. The Diver agrees that he or she will comply with any requirements of the Council relating to any conduct of the Diver on the Reserve.
- 12. (1) The Diver shall ensure that prior to each and every occasion on which he or she desires to dive in either or both of the sinkholes, the following information is inserted into the Record Book of Dives which the Council maintains:

The Diver's name, current Association membership number, current Association Category Rating, and expiry date of the Diver's Association membership card and the date or dates on which and the sinkhole or sinkholes in which the Diver proposes to dive.

- (2) After the information is inserted the Diver shall sign his or her name in the book to signify that the information is true and correct.
- (3) For the purposes of this clause the word "occasion" means any period of up to and including seven days.
- 13. The Diver shall produce his or her current Association membership card to any officer of the Council upon being requested so to do by that officer, when the information in Clause 12 is being entered in to the Record Book of Dives or the Diver has requested keys to allow access to either or both of the sinkholes, or when the Diver is on the Reserve.
- 14. The Diver agrees that if he or she is given any key or keys to provide access to sinkholes on the Reserve then he or she undertakes to ensure that any gate or door which provides such access will be locked immediately after passage through it (unless the Council or any lessee of the Reserve stipulates otherwise) and the Diver undertakes to ensure that any such key or keys are kept in safe custody and are subsequently returned to the custody of the Council in accordance with any stipulation or request made by an officer of the Council.

# 15. The Diver will ensure that no damage is sustained to the property of the Council or any lessee of the Reserve by the Diver or persons accompanying him or her and that any property will be left after any dive in the same or better state as found on entry.

- 16. The Diver agrees that he or she will use the equipment on the dive as contained in the attached Specification of Recommended Equipment and acknowledges that the Specification and the Plan of the sinkhole or sinkholes attached hereto have been provided to the Council by the Association as a guide only to diving in the sinkhole or sinkholes and that the Specifications are minimum requirements only and further agrees that he or she will not hold the Council responsible for errors or omissions in the Specification or the Plan.
- 17. The Diver hereby acknowledges by his or her execution hereof that he or she has read and fully understands the obligations stated in this deed.

#### REGULATIONS

#### AMENDMENT LIST NO 4

#### DATED 12 JAN 1988

This is Amendment List No 4 to the Regulations of the CDAA dated August 1986 which were originally issued with Guidelines No 25.

The following amendments are required as a result of renaming 'Advanced Category 3' to 'Category 4':

#### Regulations 38, 54 and 64

- 38. Category cards issued are Category 1, Category 2, Category 3 and Category 4.
- 54. A Special Visitor Permit may be issued for any category up to and including Category 4.

#### Category 4 Diving

- 64. For an Category 4 dive, the group of divers shall appoint a responsible adult to act as a surface member who will hold the key at the dive site until all divers in the group return safely.
- 2. The following amendment is required because records are now kept at a National level (on a computer), rather than at a State level:

#### Regulation 58

- 58. Records of members will be kept at a National level.
- 3. The following amendment is required to ensure that independent air supplies are used for penetration diving. This will bring the CDAA in line with the Australian Spelaeological Federation and the rest of the international cave diving community.
  - 64A. Each member whilst diving in a Category 4 sinkhole shall have an independent (dual) air supply.

#### MULLAMULLANG CAVE

Many Australians regard the Nullarbor Plain as a vast area devoid of anything of interest. Nothing could be further from the truth as the Nullarbor is a thick belt of limestone riddled with caves and sinkholes. Some of these caves contain water, although in all cases the water is fairly inaccessible being some 100m beneath the ground surface.

A recent expedition succeeded in adding 150m of underwater passage to Mullamullang Cave. Mullamullang is a very extensive cave system having some 11km of passages. An extensive survey was made of the cave in the sixties by the Cave Exploration Group of South Australia. Numerous small lakes were discovered. All these lakes had been snorkelled over the years but our intention was to dive in as many as possible. Hopefully one would lead to a new undiscovered section of dry passage.

A party of 10 cavers was involved in the exploration. Two lightweight sets of diving gear were used - 38cf tanks, single piece wetsuits, small high power torches, minimal weight belts (rocks were used to supplement these on the dive), and of course a guideline reel and the obligatory underwater camera to show others where we had been. Food, water, and sleeping bags were also needed as we planned to stay overnight in the cave. Water in the caves proved to be unsuitable for drinking as it was too brackish.

The most promising lakes in the cave were close to the end of the main cave system (some 4.5 kilometres into the cave). The plan was to walk in halfway, camp the night, leave a store of water and food and the sleeping gear at the camp site and continue on with the dive gear and enough food and water until we returned. Once the end of the cave was reached we would progressively work our way back diving in each of the lakes we had passed on the way in. Hopefully one of the lakes would sump through to another air chamber and an extension of Mullamullang Cave.


After an initial easy sandy section, the going starts to get pretty tough after the one mile cairn is passed. About 35 rockpiles, the steepest about 60m high, need to be negotiated before the end of the cave is reached.

A small lake at the end of the cave was dived first, then Lake Sh'bula, both without success. Grotto Lake was then checked by one diver. After some minutes, when the lead diver had not returned, we realized that it must "go", so the second diver was put in to follow up the first. The lake is some 40m long and then sumps and runs for another 110m. At this point there is a rockpile blocking the sump and by swimming upwards an air chamber is reached. Diving gear was left and attempts were made to negotiate the

rockpile without success. The divers started back and discovered another small air chamber on the SE edge of the sump. This was filled with many salt crystal formations but once again there was no way this chamber could be negotiated. By this stage air supplies were running low so no more diving could be safely contemplated. We had dived in three of the thirteen odd lakes at the end of Mullamullang Cave and had succeeded in adding another 150m to the end of the cave. Unfortunately no further extension to the dry cave was discovered.

The party exited the cave some 24 hours after entering and taking some 6 hours on the return journey from Grotto Lake.
