

2006 AUSTRALIAN DIVE SHOW ANNOUNCED FOR MELBOURNE

The organisers of the OZTeK4 Dive Exhibition & Conference held in Sydney on the 12-13 March 2005 are please to announce the dates & venue for the 2006 Australian Dive Show.

The 2006 Australian Dive Show will be an all encompassing Dive Show, scheduled for the 20-22nd October 2006 at the Melbourne Exhibition Centre & Convention Centre in the heart of downtown Melbourne in Victoria. With space for over 100 exhibitors and focusing on all aspects of diving the 2006 Australian Dive Show will also feature the OZTeK5 Conference and will be the highlight of the Asia Pacific diving calendar.

In choosing Melbourne the organisers recognise the strong involvement in the diving industry in Victoria and the fact that the last major Dive Industry event in Melbourne was in 1993. With a long tradition starting with the pioneering Oceans Shows of the 1980's the divers in Melbourne strongly supported the second OZTeK Conference in 2000 as part of the BIA Boat & Dive Show and the organisers anticipate a record attendance at the 2006 Australian Dive Show and adjoining OZTeK5 Conference.

The three day schedule will include an industry only Trade Day on the Friday with Public Entry to the Dive Show on the Saturday and Sunday. The Friday will also include Industry targeted seminars while the weekend will incorporate the OZTeK Conference & Workshop sessions. Additional complimentary events will be announced over the coming months including a Dive Industry Party and the acclaimed Gala Awards Dinner run on the closing Sunday evening.

Scheduled for the latter part of October the 2006 Australian Dive Show will be held 3 weeks before DEMA, allowing the Australian Dive Industry to preview the latest in diving equipment and developments before their release in the US market. By incorporating the successful OZTeK Conference into the Dive Show the exhibition will include the full range of diving technology and, following on the success of OZTeK4 in Sydney earlier this year, many exhibitors have already pre-booked space. The Exhibition Floor Plan will offer a wide selection of display options with Equipment Manufacturers & Distributors, Dive Travel Destinations, Training Agencies, Retail Dive Stores, Underwater Photographics & Videography, Commercial Diving, Rebreathers and more.

The Melbourne Exhibition & Convention Centre offers a superb venue on the shores of the Yarra River, close to the Crown Casino, central hotels and Melbourne's excellent public transport system. Accommodation packages will be announced along later this year.

The Cavern Sinkhole Diving Course

There's a saying that takes on more urgency the older I get "You only regret what you don't do." The time had finally
come to cross off one more potential regret - the
Cavern/Sinkhole diving course.

Completing the cavern/sinkhole course and seeing firsthand what everybody raves about in SA's Mt Gambier has been a goal of mine for a number of years. After one false start and another clash of dates I finally got the green light to do the course with CDAA instructor Brian Cornell and "student" instructor Paul Leslie from DIS. Joining me as students were three others, all keen divers with Deep and EANx backgrounds.

On a Tuesday night we attended the DIS shop in Ringwood for a night of theory, covering topics such as CDAA history, natural history, equipment considerations, buoyancy and anti-silting, gas management (rule of thirds), decompression, access procedures, dive planning, hazards, and accident analysis. Given the background of the students a fair amount of the theory was almost revision, although the CDAA history and environmental considerations with sinkholes was all new.

Saturday morning we all fronted up at Oueenscliff Dive Centre for two days of fun and games. After some more theory covering communications and reel and guideline use, we turned the backvard of ODC into a spider's web - lines going everywhere, tied off to anything and everything. Upturned chairs, railings, door knobs, you name it we tied off on it. Then came the fun part (for the spectators!) where we practiced following that same line back to the beginning (ie. the cave exit) with eyes closed to simulate a siltout. Instantly those upturned chairs and low branches became hazards, with a few bumps and scratches the result. After a couple of hours of drills on how to reel out, tie off or wrap the line. lock and abandon, and the all-important finding our way back with eyes closed we were ready for the pool session. All of us students have very similar gear configuration - twin cylinders, backplate and wing, 7' hose, canister light - so that made things very quick when reviewing equipment considerations. Streamlining and eliminating entanglement points is a key point in caverns and caves, so get rid of all those danglies if you want to do the course.

QDC have an indoor pool that starts shallow and has a sharp drop to around 3m. This was to be our home for the next few hours. We spent a few minutes getting our buoyancy sorted, as fresh water requires less weight than the ocean. Personally I went from 9lbs on my weightbeit to none at all, although I did go back to 6lbs for the pool session due to the exteme shallowness. In the pool we covered reel use, line placement techniques, reel locking and abandonment, blackout line following and air sharing while following a line. In everything we did we had to demonstrate good buoyancy and anti-silting techniques. The first time I

was "silted out" I realised that the value of that tiny piece of 3mm line was infinitly more than what Bunnings charge for it. It is instantly the most important asset you have apart from air; it is literally your lifeline. After many combinations of mask off, blacked out or both, plus out of air drills thrown in for good measure we emerged tired but satisfied. Saturday night saw the typical shenanigans of a group of divers in a local pub, and somehow we all managed to be back in the pool on Sunday morning to do it all again.

The next Tuesday was another theory night at DIS headquarters where we also did the exam. A few pages of multiple choice questions, plus a few pages of written answers. No answers tonight though, that would have to wait until Mt Gambier.

And if you don't know where the Bellum Hotel is, it's that pub on the road to Port McDonnel just next to the turn off to Little Blue! Unfortunately tonight we learned that one of our group wouldn't be joining us due to personal reasons, so our two buddy pairs were now one threesome. With gear all sorted, tanks filled, travel logistics organised we departed. Only four more sleeps! It is a long way to Mt Gambier. Any way you look at it it is 5 - 6 hours from Melbourne. And there is a suprising amount of "stuff" to pack into your car. Two people with all their dive gear and luggage fitted (just) into a standard sedan. In Mt Gambier we were joined by DIS regulars Chappy and Chris, who took the opportunity to do some "pleasure dives" in some of the sinkholes. As it turned out they only dived in two sites, more on that later.... Accompanying Brian was another CDAA instructor, the "world famous" (his words) Stan Bugg who was along to help out Brian and Paul. Their Navara twin cab was packed to the roof. I'm not quite sure how two people can have that much gear to fill the back of a Navara ute - I've taken a family of 5 away for a week and had spare room - but they did it.

Saturday morning we met at Goulden's Hole, a popular training site. A smallish sinkhole that bottoms out around 24m, the water is a reasonable 15 degrees C, with ~5m vis (before we got there!) We spent a couple of minutes checking our buoyancy and trim, and generally heaping pity on the sole wetsuit diver of the group. He took it well, claiming the water wasn't cold at all... (denial?) Chappy and Chris headed off to Little Blue Sinkhole for a dive. My first impressions of a freshwater sinkhole - dark and eerie. The lack of vegetation was certainly different to the ocean, sort of a "moonscape" atmosphere particularly when the sinkhole started to undercut. Nothing there except me and the yabbies. So into the drills and skills - reel out, tving off and communicating via torch and hand signals, all the while maintaining perfect (!) buoyancy and trim to minimise the silt. And there was no escaping the watchful eye of Paul and Brian. For these drills we buddied up as a twosome, with the third person off with Stan demonstrating finning techniques - modified flutter, frog kick, and helicopter turns. Put those hands away! The drills continued, losing masks, siltouts and out of air scenarios the whole day. Those instructors ought to upgrade their gear, it kept failing at an alarming rate!

At lunch we warmed up a bit (amazing how cold it gets even in a drysuit) while Stan and Brian whipped out their portable compressor to refill their tanks. So that explains *some* of their gear... Over lunch we went over the exams and discussed where we went wrong. A few silly mistakes, but not enough to knock any of us back, so that was good news.

Dive two was again in Gouldens, for more of the above. We were also joined by Chappy and Chris for the afternoon. Another satisfying session, with all our skills becoming more refined as the day progressed. The instructors were happy, and so were we! Back to the motel to dry our undergarments (the arms get wet with all the reel and line work) and our poor wetsuit diver obviously got prime position in front of the heater to dry his wetsuit. Sunday morning we met at Little Blue Sinkhole. This is the local swimming hole, probably 50 metres diameter and about 39m deep, full of all sorts of rubbish - a car, petrol bowser, old tyres, signposts, trees, everything. It does have fabulous access with steps and a pontoon making entry/exit super easy for divers. This was a deep dive, and our task here was to plan the dive

using tables, calculating turn time, turn pressure with rule-of-thirds, the sequence of our group (who reels out, etc) and also managing a stage cylinder. On this dive the wetsuit diver was no longer the "target", it was me as I was using smaller 7L cylinders and the others twin 12's. Limiting factor = me! Well we'll see - this was also a no-deco dive, so it would either be turned on time or pressure.

Dive planned, slate written up, S-drills completed, we descended the shot line. At around 15m in very murky water we passed through a thermocline with the 15 degree water dropping to a chilly 12 degrees. Our torches made little impact until the bottom suddenly appeared. Diver two clipped off the stage cylinder. I tied off the reel, and off we went into the gloom, tying off on street signs and rocks and branches. We stayed close to the wall as our imposed depth limit of 30m meant there was nothing to tie off to out in the middle (depth 39m). Our turn time was quickly reached (NOT air pressure - woohoo!) so we turned the dive. Back to the shot line we went, simply reeling in the line the way we came. In the murky water the advantages of a line are very apparent - whilst the green glow above always indicated a direct ascent, it is nice to have a sense of position with the line.

Back up the shot we ascended, with diver 3 managing the stage as well, to our planned deco stops. Here is a huge difference and advantage over ocean diving - deco stops are incredibly simple! No surge or swell to muck up your depth, you just hang there effortlessly. On the deco stops our instructor's regs again failed, necessitating donating the long hose. And his way of saying thanks was to make us perform a mask clear! We exited the water right on schedule. On the surface we were debriefed and again the instructors were quite happy at our performance. Whilst we were on our dive Chappy and Chris also dived at Little Blue. Upon surfacing Chappy realised he had lost the wide angle lens from his camera, somewhere in Little Blue sinkhole.... Guess where they would be diving that afternoon. And the next morning. Search and Recovery anyone?

After lunch we were back at Goulden's Hole for a climbing session. A number of sites at Mt Gambier require access via wirerope ladders and lowering gear via ropes and slings, so a basic understanding of appropriate techniques and gear is essential. Back in the water we underwent the "stress test", plus in-water gear removal and donning, valve shutdowns, and some more mask off, blacked out, out of air drills for good measure. We slept very soundly that night... I hung out until 8.30, and I think the

other 2 were in bed by 9. Very exhausting!

Monday morning was the highlight of the weekend. We were booked on the 8am slot at Piccaninnee Ponds, a dive site about 30km south east of Mt Gambier. This is the one I was waiting for: gin-clear water and a spectacular white limestone cavern that apparently rates as one of the best dives in the world. As we geared up we listened to our experienced instructors Stan and Brian who told us all the "back in my day" stories about the site. Stan, with 97 dives at this site alone (I think he helped dig the chasm ;-) , noted that he would often arrive at 7am to find cars already there and divers in the water. "If you weren't here by 9am there was no point" as all the early divers had silted the site out. Nowadays at Pics access is controlled, with slots at 8, 11, 2 and 5. Each slot has a strict one hour limit, ie. we had to be out

of the water at 9am, which then gives 2 hours for the silt to settle before the next group.

Gearing up is done in a shelter, next to a toilet block, and then it is an easy walk across a boardwalk to a pontoon. All these site improvements are typically done by CDAA volunteers working in conjunction with local councils and landowners. This dive was simply for the "wow" factor - no skills or drills thank goodness! Dropping off the pontoon into the first pond it is a 50m surface swim across to the chasm. We descended, past the reeds and down a narrow fissure called the "Chasm" to the "Dogleg" at around 36m. This is the CDAA depth limit for this site, as beyond the Dogleg it enters a dark zone, narrow and silty which drops to 100+ metres. Some people have had very lucky escapes from beyond the dogleg (eg. Tom Mount recounts his escape from here in the preface of the IANTD Cave Diving Manual); others have not been so lucky, thus the CDAA limit. Rangers know how to read dive computers, and depth offenders will be reported and banned. Harsh perhaps, however CDAA policies exist for our protection! Turning back up the Chasm to around 14m we enter the Cathedral. In here our five bright dive torches really get to shine. lighting up the massive white limestone cavern. It is huge, and absolutely beautiful in crystal clear water! With Paul and Brian keeping an eye on their students, we buzzed all through the Cathedral, looking into nooks and crannies and just generally awe-struck at the whole experience. Working our way slowly around the walls of the cathedral we reached the ceiling at -6m. Here it is a simple process to insert a little air in your wing and just lie there held against the ceiling to do the 6m deco stop. After a few minutes watching a freshwater eel we exited the Cathedral, and gently swam back through the clear ponds at 3m effectively doing the 3m deco stop.

Gearing down we all swap superlatives about the dive, quite bubbling about the experience. A short drive to Port MacDonnell for an air fill and a coffee, via Ewens Ponds for a look, and we then headed back to Little Blue for a repeat of yesterdays dive but taking into consideration the repetitive nitrogen. At Little Blue we find an extremely happy Chappy and Chris, who have somehow pulled off the impossible and found the lost camera lens in the silt.

As it turned out the dive plan was exactly the same as yesterday, with the roles changed. I managed the stage cylinder today, and today we managed to travel about twice as far as yesterday in the same time. Obviously our skills are becoming more refined. On this dive one of our instructors "took the opportunity" to give us real-life experience at getting entangled in the line, with it wrapping around his fins straps. No names mentioned as I don't want to ruin the "world famous" reputation!! Back on the surface, we are four happy lads - no longer students but now official Cavern/Sinkhole Divers, and Paul is now a Cavern/Sinkhole Instructor.

So this is what people rave about. I can honestly say this was the most enjoyable and satisfying course I have completed to date. The skills, the sites, and the potential future diving it opens up are just fantastic. The rubbish-filled sinkholes I can take or leave, but Pics is a spectacular dive and will certainly be on my list for future trips. And Kilsbys. And The Shaft. And...

FINDINGS FROM THE INVESTIGATION INTO TRI-MIX DIVES IN THE SHAFT...

Under the CDAA Constitution and Regulations, claims have been levelled against three CDAA members. It is usual practice not to name members in the findings or report in as much detail as we have here. It was felt that because of the public airings of names and the claims it was decided to expand on the normal format.

In the claim against the National Director, he gave permission for the following...

A claim was made against the National Director of wrong doing under Policy Number 6 "Whistleblowing". The National Director presented the findings from the Investigations Officer which was received on Wednesday 18th May to the Directors not involved. Their finding agreed with the Investigations Officer, that the National Director had nothing to answer and had carried out the position, which was to investigate the claims.

A number of people were named in the claims submitted by a member, to the Investigations Officer. Each case was looked at and the I.O. released a 25 page report which needed to be read carefully and his findings compared with the Constitution and Regulations. Reference was made to Policy Number 6 in regard to these allegations especially the "Natural Justice" section and previous history.

When claims have been made previously they have usually been verbal and then followed up with a written report. In this case the web has been used naming the accused for everyone to see. Findings are the property of the National Director as per the Constitution and the accused and accusers are not named. Members are advised of the results and attention drawn to the "crime" and punishment if

applicable as per the CDAA Constitution.

A CDAA member made a number of claims which are listed below.

- 1. A trimix course was run in November 2004, under the auspices of another training agency, and which included CDAA members;
- There may have been breaches of the "code of Ethical Conduct of CDAA Representatives", "Abuse of Office", CDAA Representative's Behaviour as Diving Members of the Association and Conflict of Interest clauses.
- 3. Additionally the "CDAA Special Site Access Bulletin No 6 The Shaft" outlines the requirements for special access to Guides outside the normal diving dates, it was claimed that this was not adhered to on either the Tri-mix Course or on the "Caves Alive" weekend.
- 4. If the above breaches occurred involving the Tri-mix course in the Shaft, a Director may have breached the "Whistleblowing" clause in the above mentioned code of conduct by failing to properly expose and deal sufficiently with the issue;
- 5. The insurance status of a member at the time of the course was conducted, was uncertain;
- 6. The 'General Regulations Section 1.3 CDAA Sites requiring Cave Diving Supervision, sub-section 3 Cave Diving Supervisors

No8/a" may not have been adhered to over the two weekends of Tri-mix diving.

Accordingly, the Directorate referred the above claims to the Investigations Officer, who found –

That there was some ambiguity in the interpretation between the Investigations Officer and the Directors, of CDAA Policy #1, which allows the use of different equipment than that sanctioned under the Australian Standards.

Further ambiguity occurred between the CDAA website and Regulations, which did not contain the Shaft Access Bulletin, apparently due to an error of omission some years ago. The Investigations Officer found that there was no case to answer under the "Whistleblowing" clause after being supplied with evidence that the National Director had fulfilled his role in line with

This was proven through records that enquiries into the matter were begun in January 2005 and "no case to answer" was found. Documents showed that enquiries had been made with parties that had made claims, full discussion was held and the matter dismissed by the Directors. After another complaint a full Directors meeting was held and the Directors discussed the matter fully and again stated there was no case to answer. The Directors were satisfied that the dives were within CDAA policy and for the good of the Association and "Natural Justice" was required. Many weeks later as the rumour mill started out of control, complaints again came from the same individuals. It was explained what had happened and our investigation of the matters but again the Directors were bombarded with accusations and questions. To appease these

members the National Director requested the Investigations Officer to start proceedings.

The Insurance matter was found to concern the training agency and not the CDAA. Issues with record keeping were noted and a policy for CDAA members teaching other courses or participating in them under CDAA access will be written.

No basis was found to the other claims.

Findings:

Two of the members will make statements to the Directors and members about the Tri-mix course and that in future clear communication with the Directors and members will be held. Prior approval to protect the Association and its members will now be required from all members wishing to Tri-mix dive in CDAA sites from the Tri-mix Access Officer who will notify all of the Directors.

A policy will be written.

There will be a requirement that when non CDAA courses are being held and CDAA member access is used, notification and permission from the Directorate will be needed. A policy will be written

The ambiguities found and others that may exist are to be altered so that common documents are relevant to each other. The Tri-mix Policy will now be finished with additional features that were noted lacking in the Investigation.

This will now close the matter.

Timeline...

As there have been claims of delays, the list of events is listed.

- Investigation initiated January 2005
- Directors discussions February March 2005
- Directors Meeting March 2005
- Investigation requested with Investigations Officer March '05
- Draft Report from Investigations Officer May 2005
- Further input from Directors & persons interviewed May '05

- Discussions and Constitution/ Regulations reference/ history/Landowner agreements – 19th & 20th May 2005
- Teleconference between Directors 23rd May 2005
- Decision on Final Report by Directors 25th May 2005
- Members named in Report notified 25th May 2005
- Investigations Officer Notified 25th May 2005
- Other members under investigation notified of findings 26th May 2005

The members now have 14 days to respond. This will be 9th June. This document will be published in Guidelines June edition and

then on the web site if no appeal is lodged as per the CDAA Constitution.

The full report will remain the property of the CDAA and is not to be disclosed. The above summary, in the opinion of the National Committee represents a balance between the rights of a CDAA member to question the application of CDAA rules and Regulations, the requirement of the Directorate to investigate where the questions are considered well-founded, and the rights of individuals named to be protected from undue or unwarranted disclosure (as protected under the provisions of the Federal Privacy Act)

It is hoped that this puts this matter to rest and the parties abide by the findings of this investigation. The Shaft is a valuable asset for the CDAA and our relationship with the Landowner should not be jeopardised. Public dissemination of these matters went a long way towards possibly destroying the future access for Tri-mix diving in this site and future site negotiations. The fact that

Tri-mix diving in this site and future site negotiations. The fact that whilst under the pressure of investigation the members negotiated access for all

tri-mix qualified divers is example of their good intentions. We now have Tri-mix access, under the Landowners conditions, in the Shaft. The CDAA owes a debt of gratitude to these members.

TRAILER TRASH?

"First I wanted it to be completely lockable, with stowage room in the bottom for twenty or so cylinders (a must when I am teaching or for the Nullarbor to carry "G's") and an area for the compressor".

I can't help but wonder at the amount of time and expense that has gone into dive trailers. Some are cheap box trailers that probably carry the lawn clippings on weekends, when the other half insists on the jungle being cut to a reasonable height. Others trailers I have seen really show a lot of thought and care, take for example the inaugural NATDIR "Best Trailer" award recipient Neil and Lyn Vincent's unit. What a spectacular appendage this is, made from checkerplate that gleams when the lucky owners pull up at a site to start unpacking. The compressor is mounted inside and it comes with its own snorkel (intake) and drain holes. Special lockable drawers along the side, a huge lower level to carry the heavy stuff, like an inflatable boat or extra cylinders. This is "A" trailer, check out the long draw bar, the fit out inside, the coupling, the lights and the placement of the spare tyre. So much thought has gone into this that now it's become a challenge for others to beat.

A lot of time and effort went into the choice for winner. I examined so many trailers I started seeing them in my sleep! JDZ received a NATDIR "Special" Mention, because it needed so much done to it, his compressor no longer has to be referred to as old because it's now historic. Gary Barclay and Linda Claridge managed the NATDIR "Most Useful" award with their erectable toilet tent and their huge white board on the back door. The NATDIR "Most Gathered Around" award went to Paul Axton for his pop out kitchen, very nifty all he and Lorraine do is pull up and pull out and the next thing you know the kettle is on the boil!

A NATDIR "Special Mention" went to the members of the Limestone Cowboys for the most stickers and finally the NATDIR "PPP" award went to Geoff Chambers and Terri Allen who use an open trailer and forgot to tie down the goods in the back! Gets a lot lighter that way! So what are we looking for in 2006 – 2007? Soft springing, multiple tie downs or mesh to attach gear, lockup cupboards, easy towing, brakes, paint jobs, room for Nullarbor expeditions - size doesn't count though as much as practicality!

With all this in mind I set about designing my own unit. First I wanted it to be completely lockable, with stowage room in the bottom for twenty or so cylinders (a must when I am teaching or for the Nullarbor to carry "G's") and an area for the compressor. I attached coated mesh standing out from the back wall about 50mm so that I could clip everything clippable to it for easy reference. As there would be a side for Jane and one for me (no arguing about who's is who's gear) we each needed space for two sets of twins to standup fully assembled as we use 75's and 50's) plus our stage tanks and "hottie". I measured it all out and found that a 6 x 4 with two tradesmans tool boxes that open all the way to the bottom were the answer. This left a centre area for wet gear (drysuits etc). By dividing the under floor space it allowed me to have to lift up hatches installed. This kept petrol, compressor and motor oil and tools out of the way. Next came the need to sit on the side so that easy donning and doffing was manageable, so heavy steel checkerplate was used for side steps and guards. What eventuated was a sitting spot on the guard which easily allowed us to put our gear on and simply walk away with it. Having all accessories clipped to the mesh behind enabled a left and a right side for donning everything appropriately. The compressor was mounted on an extra long draw bar that was built to take the extra weight and stress. By enclosing the compressor and having slide off panels this allows air circulation and easy access. Brakes were a necessity (meaning Jane said "Or else!") The future will see a charging point on each side with a solar panel on the roof and a drinking water/shower installed on the roof. Oh, Jane I will also





NATIONAL DIRECTORS REPORT

June 2005...

What fantastic news....the Standards Director – George Yarra and Site Director - Rob Brennan have for us. The opening of The Shaft for trimix diving! This has taken a long time and if it wasn't for the dedication of these two, ably supported by Steve Trewavas, we would still be dithering around. This has come about even though these members have needed to defend their actions against claims of improper behaviour and violations to our Regs and Stds. Pretty tough when you put yourself out for the benefit of members so that everyone can gain access for Trimix diving! Read their reports and the Directors Investigative notice for more information.

Five years ago the Directorate decided to follow the Australian Standard and implement a number of changes which would enable the CDAA to use the Standard as an umbrella, this would afford some protection, provided it was followed, in a court of law. It seems that when we make decisions that protect you, such as insisting that our Instructors and Guides conform to the Australian Standard we (Directors) suffer the backlash. George Yarra our Standards Director, acting on behalf of the National Committee, made the decision to bring the Instructors up to date (this was a move decided on by the Directorate about 5 years ago and not enforced). By requiring Instructors and Guides to produce evidence of current Instructor/Divemaster status, First Aid Certification and Oxygen qualifications, it has caused some to baulk. Now that's fine if they don't want to teach or Guide under the CDAA banner, then they simply don't have to renew, it's their choice. Currently we have only received negatives from two Instructors and have a few in the process of renewal, so even though some don't like it they have still conformed to safe practices when it was mandatory. If we have to lose a couple it's a shame but we all must consider the ramifications if we don't accept safe work practices. George has personally copped some abuse for this move the fact is he's doing the job he was elect-

Once again I can report that the Association is very healthy, financially we are in a very good position and should be able to offset any increases in our expenses. These funds can be used to improve site access and repair current facilities with the aim of making it more comfortable and easier for members. Heike Apps, the Business Director will be presenting the draft report soon, followed by the audited accounts when returned.

Heike has been working with the other Directors to bring the paperwork we rely on up to date so you'll notice some changes. (Check the web site and download the changes to your manuals).

Courses are producing new members and our Instructors have enjoyed trouble free access and conditions. I have never seen Mt Gambier so crowded with divers. We currently have over 730 members pretty evenly spread across the levels. A point of concern is the decrease in membership from WA and NSW, I feel that this trend must be addressed with better representation in those States. The lack of members in these States is mirrored by the number of Instructors available, Victoria is over represented and even SA is falling behind, especially with Instructors. Does this mean Vic's will again call for an annexing of Mt Gambier to become part of Victoria?

Negotiations are still going on for access to sites and we hope to have good news in the next Guidelines. Some of our reserve funds will be needed to facilitate this. Great work behind the scenes has been done by Rob Brennan and other members who will be mentioned later, to get us this close.

As National Director it is my responsibility to negotiate our insurance. I am hoping that full cover will be gained this year in all areas. On going negotiations are looking positive. Although we are covered, a better cover was available before the HIH collapse and I am hoping to achieve this again. Costs will increase but protection is a priority. History shows that we really require three policies and currently we can only obtain two.

The Directorate began a process that would bring the CDAA up to date with teaching Standards and be acceptable world wide, an area we are steadily falling behind in. I'm sure that most members would agree that a lot of the teaching standards are very old fashioned and still refer to equipment that is not in general use, and worse, we do not teach using current equipment and procedures for use. It has been noted how many members and others we come into contact with are taking "alternative" courses and they state it is to learn the most up to date teaching, which we don't offer. At the last Annual General Meeting a member queried why there were different types of courses being run at the Cavern/Sinkhole level. The National Committee addressed this question and was informed that there were at least three different versions being

run by Instructors plus there were a lot of "interpretations" of the Standards. An advisory body was formed after requesting volunteers make themselves available. The first proposal for a Standard Course has now been put to the Instructors for feed back.

There is no doubt that we have the safest record of all Cave Diving organisations but that doesn't mean we should be complacent. Some Instructors have taken the initiative and implemented their own changes, others have been happy to get people through as guickly and easily as possible. It is time to tighten our approach to teaching. Read the article about Stan Bugg's course in this issue and ask yourself, "Did I get or do I offer this quality training?" I know that a lot of students go through the "system" using the bare minimum of equipment and in a very short time. This can affect the quality of their training, for instance, when they dive Kilsby's, we see them floundering around because they have minimal twin tank use and probably no real training! Next, they turn up for a cave course and are "out of their depth" I know that there's a lot who agree and it's time to voice your concerns to the Directors. Are we teaching a dive course or a technical course, you know the answer it's a technical course, so why do we want to push through as many as possible in the guickest time? Maybe it just suits the Instructor, but what about you? What's worse is that we actually allow this in our Standards, but does that make it right? Stan Bugg and Brian Cornell, two of the most experienced Instructors helped write the original courses and exams and are willing to incorporate new things. Stan and Brian contributed to the new Cavern/Sinkhole Course proposal and Stan and others have implemented changes to keep their courses up to date and relevant.

The new Cavern/Sinkhole course proposal has been sent out to all Instructors and input requested, comment has been received and we will now present this back to the Instructors with replies to each and every suggestion. The Association will then have a base to work on, and every Instructor will be asked to submit their suggestions. Instructor meetings will be held and all input to be analysed against good teaching practices. It is easy to sit back and criticise, what we want is input that is constructive and educationally valid I therefore encourage anyone with ideas on this to present them by email or letter to George Yarra the Standards Director.

Most of our members wouldn't be aware of the claims made against 3 members and it is unfortunate, that in my opinion, it appears that a few members may have a conflict of interest. One of the disadvantages of this position is the abuse that Directors are subjected to. Recently I was attacked for going to Tank Cave as a Guide (All Guides do this voluntarily for no reward)

instead of sitting by my computer and waiting for the report from our Investigations Officer, which was due on the claims. It is easy to make claims against other members and in some cases I believe they may be scurrilous, vexatious and politically inspired, I'll let you be the judge. One only has to read the constant barrage on the web site against the Directors and myself in particular (thankfully this only relates to six or so members). The "private" emails are even worse. The Directors have written a report about the claims, the findings of the Investigations Officer and the final report from the Directors elsewhere, in this issue of Guidelines. In my attempt to be available and always answer questions it has proved to be my own undoing. Some members seem to take delight by taunting me to get a response that they can then ridicule. The approach I have taken to be open, honest and work for the good of the Association has cost me dearly. I therefore advise anyone thinking of nominating, to weigh the consequences of never having a spare moment and dedicating at least 4 hours a day to the Association to get the job done. We need new people but as we have experienced to our detriment so many times over the years, we need people who will dedicate the time and effort. And remember you will be one of five Directors, so what you want isn't necessarily what you'll get but, you'll be asked to defend the decision.

Terri Allen has really covered her position well as Records and Publications Director with Michael Kelly churning out membership and records. These two work together very well and it runs like a well oiled machine. Paul Leslie handles products for Terri and our level of sales since Terri took the job has increased along with the bottom line. Terri plays an active roll as a Director and seems to spend most of her time working for the members we all owe her our thanks. Check out the web site it has never been better and now with booking online expanded for more sites.

It is nomination time again and a call for business. Look carefully at the candidates and ask yourself and them," Will they actually do anything or just hold the position to stop someone else? Will they have the general membership at heart or are they on a mission to improve their own standing or push their own cause?" What his-

tory do they have and do they understand that the CDAA comes first over all other training agencies, factions or politics?" At the moment a member can demand to see the minutes of the Directors meetings where matters like this are discussed.

Vote but think carefully about everything and everyone put forward. Remember a majority of the members have to vote for Constitution changes to be passed, so your vote counts.

Jarrod Jablonski Discovers Mt. Gambier

Preparing for my second trip to Australia held a special intrigue; I was finally going to enjoy the local caves halfway between Melbourne and Adelaide.

Having previously enjoyed diving on the Great Barrier Reef I was ready for something a bit less colorful. My first dive in a cave in another country was in 1995 during a research trip in Turkey; despite a wide range of various projects, there remains something especially intriguing about exploring caves on a different continent.

Caves around the world have a unique combination of formations, structure, constituents; these somehow combine magically to form what can only be expressed as a personality unique to that cave. Generally speaking, caves from different countries seem to take that contrast to the next level. Taken together with their local culture, the means of accessing the cave, and the many people revolving around the diving these excursions are one of the most rewarding experiences in my life.

It would be hard to select one or even several things that I found most rewarding about my time in Mount Gambier. The people were all remarkable; the list of people to thank seems boundless. From the wonderful hospitality of Warrick McDonald and Jane Bowman McDonald to Steve Trewavas endless assistance to the generosity of spirit found with George and Tanya Yara to the great energy of Chris Ross and Terri Allen. There were so many great people in Australia that even casual reflection leaves me grateful.

Then of course one must consider the caves; these were actually more dramatic and unique than I anticipated. I most particularly enjoyed the variety found in

Tank Cave. I was also impressed that the cave was holding up so well given its extremely fragile structure. This seems a testament to the efforts of the CDAA and the general ability of the local divers.

The Shaft was truly the dive that took me most by surprise. At first I thought perhaps I was the victim of a cruel Australian joke- bring the daft American to a lonely paddock and then tell him to find the mud hole (we do something similar in the States). After locating the small entryway and beginning preparations I became more intrigued.

Finally I was lowered to the water and my anticipation had grown considerably. After sinking below the surface I was very impressed by the dramatic size and breathtaking beauty of my surroundings. In American terms it is a lot like Eagles Nest (local Florida cave) but bigger, clearer, and prettier. Having secured permission from the landowner to evaluate the Shaft for the potential of mix diving access we did a short but very enjoyable dive to 55m. I am hopeful that future trips will allow expanded exploration of this remarkable location. With a final dive in Pics I was ushered off for another trip to Barrier Reef. I could not help being a bit annoyed by all the fish and color and looking forward to my next return to the caves of Australia.

Thank you to all of you for your remarkable hospitality.
