





25th Anniversary of the Discovery of Toad Hall in Cocklebiddy Cave

The 8th of September 2007 is the 25th anniversary of the discovery of Toad Hall. This significant passing of time prompted me to dig back into my 35mm slide library, and with the help of digital technology resurrect some of the images from that trip. I published a few of these photos with a report on the dive in the September-October 1983 edition of "The Scuba Diver" magazine.

However, my inexperience with the camera setup I was using on the dive (a Nikonos II with a new, never before used, combination of a Sea & Sea 20mm lens and a single Ikelite 150 strobe), meant that many of the

slides I took were underexposed, and so were never published. I have used information from my original log book from the dive, as well as the subsequent article I wrote, to put the following pictorial recollection together.

After 5 push dives in Cocklebiddy by West Australian or South Australian teams between 1972-1979, the explored limit of the cave was 2000m beyond the first air chamber and at a depth of 15m; statistics which inhibited further attempts until 1982. In September 1982 Hugh Morrison led an expedition from Perth

which I invited myself along on as a photographer, and Ron Allum joined me as my "assistant". This was the first time that the West Australian and South Australian teams combined forces. The pace of the trip was frantic, with Ron and myself arriving at 8am on Monday 6th September after an overnight drive from Adelaide. We got all our gear down to the entrance lake and dived the kilometer to the first air chamber on the Monday, with a repeat dive on Tuesday to take in scuba tanks for the push dive. The push dive commenced on Wednesday with an exit from the cave around dawn on Thursday, and all the gear was pulled out of the cave by Thursday after-

Tanks were over-filled, leading to issues with burst disks and regulator hoses. One high pressure hose and one scuba feed hose blew on the push dive. In anticipation of such problems, spanners and plugs were taken and these problems fixed on the run during the dive.






Taking the sled through to the first rock pile. The sled was composed of 15 tanks put together as 3 sets of 5 using triple bands. Each set of 5 tanks was lashed to a sealed piece of sewer pipe, and 3 horse collar buoyancy vests attached to provide lift.



The sled and each push diver's triple set were re-assembled in the lake on the far side of the first rock pile.



A broom handle was put through the front of the sled and 3 divers worked together to push the whole arrangement along. Controlling buoyancy was a major problem, and progress was often slow.

Regulators have been put on all the tanks on the sled, so the each diver had access to 5 sled tanks and 3 on their backs, a total of 8 independent air supplies per diver. The yellow reel contains line to put in to any new cave we discovered.

When one third of the air had been consumed from the sled, it was parked against the roof about 1800m into the dive. From this point we pushed on using the air on our backs.







Hugh putting new line into Cocklebiddy. As we pushed on from the 2000m mark, the cave started to get shallower, and by 2400m we passed under a small air chamber. At 2500m we could see a large chamber above us, and at 2550m further progress underwater was blocked by a large rockpile.



The first photo taken in Toad Hall. Even though my 20mm underwater lens could not focus in air, I wanted evidence that we had found an air chamber. This is the back of Hugh's head shortly after we surfaced.

All the gear was dis-assembled and transported over the first rockpile.

Another out-of-focus shot showing Hugh un-kitting. We explored and named Toad Hall, which we estimated at that time to be 500m long. I did a snorkel dive in the lake at the far end of Toad Hall and we realized that the cave kept going. We had started to discuss a return trip with an overnight camp in Toad Hall even before we left. We only spent 1 hour exploring so as not to unduly worry the support divers waiting at the first rockpile. We had started the dive with enough air for about 9 hours underwater, and had not really expected to find an air chamber, so using the thirds rule, we were expected back after 6 hours. The outward dive took 3 hours, and so we commenced the return journey 4 hours after starting the dive. The return trip was a bit faster, and we got back to the support team at the first rock pile 7 hours after leaving.

Glen thank you for you letter dated 6th August 2007. Your letter raises a number of points I would like to discuss.

In 1998 the new Constitution set members fees in concrete and the only way to change those fees was by a vote from the members following the procedures as set down in the Constitution. This means simply that it takes 20% of the membership to vote to make it "legal" and then the majority need to be in favour of any change. The CDAA history shows that members don't vote very often and in the past many suggested changes have not occurred because we have not reached the proper quorum. There has only been one membership fee change in this period. What the Constitution does allow though is for the Directors to post a "levy" for certain activities and this has been done with Nitrox endorsements etc. Personally I am not in favour of members deciding what the fee should be and would keep to see the Constitution changed. It seems ludicrous to me that we ask members if they want to pay more money. The answer will most probably be "no". A fairer system, I believe would be to abolish this clause in the Constitution and move it to Regulations where the elected representatives of the Association could decide on a business basis whether a fee is needed or not. Members would soon make their feelings felt in a ballot box should Directors not use this power wisely. One of the more laughable clauses is the staggered fee situation; does anyone really believe that they are charged a different fee at different times of the year by their Instructors? This needs to be abolished as well:

The CDAA is a an Association that stands on its own feet, is financially secure now, unlike the first 20 + years of it's life and is able to achieve what is has through careful investment of it's funds. If that makes the CDAA a profit making organisation so be it.

When I first became a Director of this Association I found that our "books" showed that we had about \$20,000.00. But, when I went to pay bills that were outstanding it was discovered that the \$20,000.00 was in assets such as fences and office equipment. The first thing I did was change the accounting system and proceeded to stash our overheads, refusing to pay telephone calls on mobiles that lasted more than 4 minutes for example. Completely disbanded the Mapping and Research Committee and made a number of enemies by doing so. Tough measures had to be taken to get the CDAA out of the mass it had sunk into. I used my own money to finance the Association for the first year and in that time paid back all of our debt (some were not shown in our books at the time) and still managed to get a firm footing back. Then I started investing the money because anyone knows that "money makes money" and if you spend it its gone! A new Directorate came on board and the careful control of our spending was confinued by Carlo Virgil so when I came back as National Director eight years ago the foundations for our financial security were solid. Andrew Seifried continued the process and then Richard Price then took over and aggressively invested portions of our savings and now we have Heike Apps holding the baton. If you look at our financial report in the September issue of Guidelines you will see that our Interest Income has steadily risen each eyear. This is what we survive on, not members fees, not Instructor fees or profit from other areas as most are cancelled out with expenses. Although the little each area makes helps our bottom line. If it wasn't for the very close control we have on each area the Association could easily go into the "red". The area that stands out the most to me is Guidelines costs which have gone down, although we are producing a much better magazine, on time, with colour and it's reaching more members and associates. This is due to the hard work of Terri Allen and David Bryart and soon I hope to see an ev

Now let's cut to the chase... if we didn't have the money we couldn't pay Tank Cave fees, these nearly doubled this year. We get our fees when members reach the level of Penetration Diver and have shown experience in caves to reach a point where they can apply to be a Tank Cave Diver. The fee (user pays) is applied once they apply. If we didn't have funds in the bank that we can draw on how would we pay the Landowner? After we had used it for 12 months? As people pay in dribs and drabs? Don't think so!

Another factor is our insurance expenses, normally around the \$22,000.00 mark. It everyone joined at the same time we could probably pay this fee but that's not the nature of the beast, history shows that cave divers spread their fees out, what I mean is that by the end of August, although fees are due in July we have about 50% of our members paid up. Some through forward payments, by paying years in advance but the other 50% are either new members, we lose about 12% a year or just renew when they think they may want to dive in caves again. Insurance companies don't quiet understand us not paying them at the start of the financial year because we haven't got the money yet. Hence our bank balance comes into play again. The recent lease I did with the Kilsbys family to get this site for us is another point. In your letter Glen you are objecting to the \$10.00 levy and asking why the Association doesn't pay out of its funds. Well Glen that's exactly what the Association did, we paid it out of our funds! The money was to be paid at the start of the financial year; we had the money in our account and used it. But if we use this money continually and don't replace it soon we will be going backwards and end up in real trouble again. "User Pays" is the system we operate by and we were trying to come up with a fair and equitable way that would get us the money and keep things in balance. Doesn't everyone have access to Kilsbys? Therefore Garry Barclay suggested that the fairest way was to levy all members, and the Directors agreed. But, let's look at how the Association paid for Kilsbys, for the members. As I said about 50% of members are financial at the end of the year therefore is it fair or good business sense (postage, holding back membership, paperwork nightmares) to ask these members who have done the right thing by the Association to suddenly come up with another \$10.00? No I don't think so; therefore the Association has paid their \$10.00 for them. As members get around to paying their fees we will finally see so

The Association is working for the benefit of its members by using the funds at its disposal to invest wisely for the good of the majority. Without an investment, interest bearing account and without a bank balance to fall back on we would not be able to continue, site improvements, access agreements, Guidelines production, Trade show representation, production of materials for training, workshops, web site, insurance, lease fees, the new courses, new manuals, exams, printing and the many other day to day expenses that consume our funds.

Glen you asked if the CDAA was a profit Association as if "profit" was a dirty word. The money that the Association has enables us to survive and five on our investments. Eventually with clever management I have a dream that we could see the day, when because of the returns we get on our investments, we could be a fiee free" Association. Spending our hard earned money will not be beneficial in the future but building our balance will is \$10.00 really too much to pay for double the access and the ability to use the site as we wish for example trimix, rebreathers, training courses, workshops etc??



NATIONAL DIRECTORS REPORT

September 2007

It is with great pleasure that I can report that all is well in the CDAA.

Your vote is required for the election of Directors. A simple majority can vote in directors and over the many years that I have been involved in the Association I have seen good and bad elections. The bad are when people don't vote for a candidate and then complain bitterly for the next two years when someone they didn't want is elected to office. It's up to you, you're vote is important! The good is when there is a clean fought election between members not promises of "..being honest" and the rest of the tripe that's dished out. This rubbish and innuendo that is used is an insult to all of us who serve the Association or wish to.

It is not my place to tell you who to vote for but it is my duty to advise you to vote wisely. Change is good if it means improvement but change for the sake of change is not constructive. I believe that Directors should be judged on the work they do and if you don't know what that is (impossible to tell what's true or false in a 100 word précis) ask them and then check out the answers. In a time where communication is more available than any time in history we (Directors) still have our hands tied as far as public comment goes. I can't tell you that Joe Blow does stuff all, I can't tell you that Mary is lazy I can't tell you that Jack Flash is the best person the CDAA has ever had. Accusations of bias and taking advantage of my position I don't need. But, if you don't know who does what, ask!

In this issue there should be reports from all Directors advising you of their current position. Read them and if you think a Director needs to be looking after something better or something else let them know. Feedback is one of the only ways we can work on projects that help you, the member.

STANDARDS

George Yarra resigned as a Director and we appointed Steve Trewavas in his place. Steve has been very active helping with many decisions in the day to day workings of the CDAA. His advice and input was sought on the final draft and introduction of the new Deep Cavern Course. A new QA form, for Deep Cavern and Cave courses, on line was introduced. The form must be completed before certification cards are issued, although a temporary card is given at the successful completion of the course, A new Instructor Guide is being written to be followed by a new student manual. Work has begun on a new Standards and Procedures Manual to be used by Instructors in conjunction with all of our courses. The Penetration Program has gone through some "tidy up" and a new exam and course outline is being prepared. Cave divers doing courses will see some of the Penetration program being introduced to make the certification more acceptable worldwide.

ACCESS

Kilsbys is now a CDAA leased site with more access and less restrictions as to equipment allowed to be used. Tank Cave has been leased again with more access. The Tank Cave shed was extended and the cave, thanks to Dave Warnes enlarged to make access easier. Dave also fixed the leak in the roof and moved about 4 tonne of rock from the entrance. Gary Barclay with some volunteers had a clean up day and improved access to Allendale and fossils plus cleaned up the rubbish at Gouldens and Hells Hole. Gary managed to get bakers Cave opened and that is now diveable. 1080 was opened again by Grant Summer and he's now working on improving access to Blacks which should be open soon.

RECORDS and PUBLICATIONS

Terri Allen is a workaholic and spends a ridiculous amount of time working for the Association with her team - Michael Kelly, Helen Higgins, Tony Richardson and David Bryant have overextended themselves getting things out to you. Guidelines is a publication we can all be proud of and although we can always use new advertisers it's production is on time and of high quality. A new system Terri has just put in place should see the marketing of Guidelines benefit the Association and return a profit. Certification cards, provided that members send the correct payment, stamped self addressed envelope, indemnity form etc. are returned almost immediately, a far cry from the "old" days. The smooth transition of the Deep Cavern rating by Michael has helped keep this part of the Directorate operating efficiently. CDAA products are now available on line and payment has been set up so that direct transfers can be made. Helen has aggressively marketed our products at every opportunity including OZ Tek where she worked on the stand longer and harder than all of us who volunteered to help. The web site has become one of our most important tools with bookings available for a lot of sites and forms being downloadable. Although voting on line has been looked at, the Directors are still to be convinced of its security. QA forms are now available on line and full Instructor materials are downloadable. Maps and site information are also available and judging by the "hits" the site receives it is working well for our members and visitors.

BUSINESS

Heike Apps has continued in the job now for two terms and has continued the good work set up by her predecessors. Heike is a strong contributor to the Directorate and when asked to make a decision on any matter is quick to vote or make suggestions. As I have not seen the balance of accounts at the time of writing this I can only presume that although costs have risen in some areas we will still show a healthy bank balance.

NATIONAL DIRECTOR

As I oversee nearly everything I get involved in most decisions and projects so I won't mention them all here as they are in the above reports. I look after

Investigations and although things have been quiet with only a few suspensions this year I am working on a matter now of great concern and that's the behaviour of a member and whether it directly effects the Association or if it is really a private matter. Insurance has finally become competitive and although this side of it is one of the worst jobs I do at least this year I was able to save the Association many thousands by shopping our policies around amongst some new players. My involvement in getting a lease for the CDAA for Kilsbys was very rewarding and the dealings I had with the Kilsbys owners worked to our advantage because the outcome saw us with complete control and double the access. The tank cave lease which I advised would double surprised even me, after a lengthy negotiation with the Landowner, the Association managed to get out a bit cheaper but did manage more access and

allowed the site to be further improved. See Access report. The new Deep Cavern Course has been written mainly by Terri Allen and myself with input from other Instructors.





Then it was on to Allendale where we had about 12 divers helping to cart and lay some limestone blocks down the slope. Standards Director Report - Sept. 2007

I have had a whirlwind introduction to the internal workings within directorate of the CDAA and I have a new appreciation of how much work the directors put in behind the scenes unbeknown to the general membership. In particular I would like to acknowledge Terri Allen's phenomenal workload on our behalf as it makes the rest of us look mediocre. I would also like to bring attention to the effort put in by volunteers who assist the standards director - Andy Higgins, Ian Taylor, Stan Bugg and Michael Kelly. Their input is appreciated.

In the past 12 months we have had a total of 2 suspensions for a period of 6 and 3 months respectively. Both were for violation of permit conditions. In general my contact with members of the association has been on a positive note but recently an incident arose which has had some negative effect on how the association is perceived. Please remember that whilst on cave diving trips you are representatives of the CDAA in some way or another, whether you think so or not. Locals associate us all as "divers" so the way I personally act and represent myself at and away from the dive site is associated with everyone within the association, for better or worse.

OA FORMS

Our new Quality Assurance forms are starting to roll in for both deep cavern and cave courses, keeping Stan Bugg on his toes. It is important to note that these forms are totally independent of the instructor base and can not be viewed by any CDAA instructors. I am the only other person who has access, in the event an issue arises that I may need to address. When filling out these assessments I encourage you all to take a little time and think about what you liked and disliked within each course and add any additional material you may wish to see covered. It is pleasing to hear so far that students are having a positive experience and our new deep cavern course is meeting their experience.

ONLINE STUDENT PACKAGES

In an effort to come in line with other sporting organisations in the 21st century we are attempting to further upgrade our electronic service. In the near future we intend to have students registering for courses online, paying their association course fees and receiving electronic versions of course materials all via the CDAA website.

AGM PRESENTATIONS

I want to encourage as many of you as possible to attend the AGM in person on Saturday 13 October. We are offering a number of quality presentations from members who have been off exploring caves within the last 12 months or so. Several of the presenters spoke at this years Oztec and I hope to capture the infectious attitude of exploration expressed there and inject it into the CDAA.

REBREATHERS

It is great to see more and more units being regularly safely utilised in the caves. I want to bring to the attention of all members that Rebreathers must meet each individual manufacturer's specifications to be accepted within our dive sites. I do not want the majority of our members to suffer access and insurance issues compounded by any one selfish individual. Please ensure you comply with your manufacturers standards as per CDAA policy.

DRYCAVING ACCESS

It is interesting to note that there are over 200 recorded water filled caves within Australia. The CDAA has just 37 recorded on our access page. The majority of these sites are remote and require considerable dry caving experience including vertical and horizontal caving access in order to reach the phreatic passage. There is a small working party looking at ways and means to gain access to these additional sites and what if any training our members require to achieve competence in the required drycaving skillsets. This may take the form of workshops, assessments or training courses. For those members who crave the more remote caving experience we hope to ultimately gain access to a large number of sites which we do not have access to at present.

I trust the next 12 months will bring safe and rewarding diving to all.

- 2. The breakdown for joining and rating upgrades are: joining: \$1680; sinkhole: \$1680; cave: \$660
- 3. Increase is due to access fee to Kilsby's of \$4950
- 4. Web site expenses are those incurred in maintaining the official CDAA web site.
- Guidelines production costs are for three issues in 2006 rather than four issues as is usually the case.
- 6. Surplus cash is transferred to an At Call common fund where a higher interest rate applies.
- 7. Guidelines issued in July 2007 was paid in June. Tank Cave fees for 2005-2006 were paid in June.

As you can see, insurance is still the biggest expense, with Guidelines production and site licence fees coming in second and third. 

THE BLUE HOLE OF THE ABROLHOS ISLANDS

The rotors overhead beat the air in a deafening cacophony and, through the open door, the Abrolhos Islands appeared amidst a sea of topaz blue. We were aboard a Russian chopper, below us our welcome party awaited, ready to whisk us out to the mother-ship, and on to the fabled "Blue Hole of the Abrolhos".

The Odyssey Explorer is a luxury liveaboard dive boat servicing the Western Australian coast, from Cape Naturaliste in the south to the Kimberly in the far north. In March each year, as our mid-west's strong winds abate, the Odyssey heads to the Abrolhos Islands, in the Indian Ocean 60 kms west of Geraldton.



This year, in addition to the spectacular diving these islands are renowned for worldwide, we were hoping to explore the blue hole rumoured to exist at the southern extreme of the island chain. I knew of five people who'd dived it at different times, but details were sketchy. Two divers claimed it was a freshwater dive, fed by a spring

linked to the mainland, another warned us to wear old dive gear because it was sulfuric from rotting vegetation, reminding me of Cousteau's dives at Clipperton Island.

We dived the islands for three days, getting used to each other, sorting out our weighting and trim with the hire tanks, and generally having a great time. During the fourth night the winds changed direction and we awoke to perfect conditions for the open ocean crossing to the Pelsart Group of islands. This was it. We busied ourselves on the dive deck as the boat steamed south, checking our air-fills, slinging tanks, loading freshly charged batteries into our torches and cameras, and so on.

An hour later the skipper, a diversater and four of us divers boarded the tender, a 24 foot purpose-built aluminium dive boat, and set off out to sea, leaving the other 15 recreational divers to visit another unspoilt and rarely-dived reef. A further half-an-hour later our destination came into view and, sure enough, there was an unmistakeable kidney-shaped blue-black hole in the centre of the reef, measuring 9m wide by 7.5m across.

We geared-up standing in the chest-deep shallows beside the hole. As far as holes go, this one

enveloped us completely. Tying a loop in the guideline at 21m, our first planned deep-stop depth, we clipped off our cam-

eras before continuing down. Floats tethered by rope hovered immobile from 24m onwards, so I clipped-off the reel to a rope against the northern side and we used that to carry-on to till we bottomed out, beside at an abandoned cray-pot at 46m. We had landed on the northern-side of the central sand-cone. I looked west and saw wall not four meters away so I tied off my tape-measure to the base of the rope and headed north, measuring just six meters before striking wall. Turning south-east I finned across the cone till the tape stretched taught and from there I headed directly east, following the cone down. The wall to my left remained in view, a wall to my right appeared after twenty metres, below me the cone kept going, depth 48m, 49m, 50m, no end in sight, just a milky halocline. The passage at this point, 30m east of the cray-pot according to my tape, was about 4m wide and the same high.

Looking at my watch I decided not to change the dive plan by going on for longer than the others expected me to, so I took out my reg and tasted the water - definitely sulphuric. Next I collected a two litre sample in a zip-lock bag, made notes on my slate and peered one last time into the blackness ahead. Even my 25w Dive-Rite torch faded into the dark before me - there is definitely more to explore here.

I reeled in my tape, my buddy ever so relieved to see my lights returning, then we ascended, joined the support divers at 30m, collected our cameras at 21m and started our deco, taking photos, and measuring the diameter of the sinkhole (11m wide at 15m depth). Soon we returned to the light and the sky and the birds above, euphoric to have succeeded in our mission.

Next March, weather-permitting, we are planning two days at the hole, and we'll have nitroxblending on board. Cost this year was just \$1750



including flights to the islands from Geraldton, five nights accommodation on board, food, air and all the diving you could want. Other highlights included snorkeling with Australian Sea-Lions and diving the historic wreck of the Batavia, famous for mutiny, treasure and the murder of 127 people. Warrick McDonald PART 2. on the

(or how to spend \$10,000.00 and smile)

If you recall my previous article in Guidelines 5 minutes later, wakey wakey, up for air, another scratch 99 I wrote about our diving in Jackson Blue with scooters in October and November last year. This story is about our (Warrick McDonald, Jane Bowman, Terri Allen and Geoff Chambers) diving down south towards Lake City.

The next port of call was Crystal River, on the coast of Florida. The place is a "Nearly Dead or Newly Wed" hangout but

has one of the best dive shops I've seen. We turned up at the shop to book our Mantee adventure and the owner took us for a tour. Parked behind McDonalds across the street were 12 "dive boats", in store was a swimming pool and fabulous shop setup with classrooms. Biggest sale item??? Fluffy Manatee toys, 4000 a year straight from China. We paid our fee to snorkel with the Manatees (no guaranteel) and the next morning turned up very early for our briefing. It was a clear sunny Florida morning and we were told to "...park anywhere, we own the shopping centre!" After a 5 minute "follow me and the boat!" drive, we launched the boat at a local ramp and headed off. Each boat holds a full compliment (about 12 passengers). Now let's think \$28.00 US a head for a snorkel that lasts three hours all up times 12 and there are 12 boats twice a day.....hmmm I'm in the wrong business! The safety briefing was different, I particularly liked the bit about "...if the boat should sink I want you to reach up grab your life jacket from the overhead locker and then walk to shore with me!" Yep, not deep and after a 20 minute putter around we found some Manatees. Competition is strong and if you are part of the "in crowd" another captain might tell you where the Manatees are resting, if not, good luck with your projects. These guys are good and if you are in luck you get a Captain who can spot a manatee from 1000 metres. Our fearless Captain dropped anchor in a metre and a half of fairly clear water and we proceeded to look for a Manatee. Within minutes we had a young one, about 1.5 metres long, lying on the bottom having a snooze. A little scratch under the fin or is that the "finpit?" and it was

content. A minute or so of scratching then back to sleep,

and back down again. We saw about 6 Manatees ranging from this young one, to a huge mother, about 3.5 metres long and it went past like a bus! Highly recommended as a break between dives.

Our next stop was Manatee Springs. A resurgence with

a reputation for strong flow and this day was no exception. We started gearing up in the park, and where we saw wandering deer, squirrels and any amount of birds. A party of divers in a bus were nearby about to go for a scuba dive in the spring. The Rangers gave us a bit of a scare by stating that the Park had reached its guota of divers, some smooth Aussie talking was needed to get us in, but all turned out for the best...or did it? All assembled and ready to go for a dive in Catfish Hotel until we checked our gauges, yep we got our tanks filled at Merritts Mill Pond when we dived Jackson Blue and of course the good service continued, one set full the other three still half full from a previous dive! Do we cancel: drive two hours to the nearest fill station or dive? Hmmm not a difficult decision, naturally we dived! Jane and I headed upstream from Catfish Hotel, while Geoff and Terri, whose knee was giving trouble, stayed close to the entrance. Pushing against the current we still managed to get further than on any previous trip sticking to thirds, we must be getting fitter or maybe the current wasn't as strong. Turtle skeletons and huge mounds of dark brown silt without any white walls makes this a dark place. As Geoff had plenty of gas we decided to go downstream waving goodbye to Terri at the entrance. The last time Jane and I tried this with Les Rothbart and Rob Stewart we were given a roller coaster ride and were spat out of Manatee like corks from a bottle of Dom. This time we reckoned that as we had been able to swim so far upstream the current was down and it would be easier...wrong! The exit was a Whirlpool washing machine in overdrive. Rocks not stones were being rolled across the bottom and it was impossible to hang on to anywhere but the side. I remembered from the last two dives here that the best place was on the left side coming out, as there is a small alcove, so I signalled for everyone to get close to the wall and make like a limpet. Jane went first, see...I am a gentleman....and quickly disappeared. Trying to do deco in this is a real challenge and makes for a good story later. Jane slammed into the large tree that lies across most of

the opening and made like a Koala! Next Geoff moved into the alcove and started to manneuvre around a rock. Nothing happened so I took a peak around the corner, immediately filling my mask with water and nearly losing my grip. Geoff was caught with his fin and leg doubled over behind him, the fin on the back of his head, Interesting photo, but now was not the time! I grabbed his fin pulling it down to the bottom, this meant I slammed into him having lost my grip on the wall and he took off like a rocket towards the tree. Slam, wham, he was safe! It was now or never and knowing the place sure helped, if I could miss the tree and stay flat, the last

thing I needed was to be pushed above my ceiling. As fate would have it I missed the tree and landed in still water surrounded by kids all pretending to be scuba divers. vo vo ing up and down in the crystal clear spring water. A 15 minute deco and down the river we went swimming with sturgeon, bass and eels, no snakes this time. Last time here. Jane found a snake (ves deadly) and started nursing it as she does with all animals that just seem to accept her as friend and of no danger to them, A great adventure, once again no disappointment.

Next stop High Springs, home of Haloyon, GUE, Extreme Exposure and Salvo. Rule number one. If you don't strip your gear down don't go to Extreme Exposure for fills because Doug the manager will give you a bollicking. Yeah, yeah I said we have been filling in the back of the van and stripping everything on a boat so this time we weren't prepared, but I promise I will NEVER do that again. The shop was closed at the time but Doug had a GUE Tech Instructor course running, so after hearing us sniffing around the building outside he let us in and filled our tanks. Another good bloke found and a friend made. Extreme Exposure is one of those drool shops, or so Jane reckons. I'm sure she meant the gear and toys not Jarrod Jablonski who was there teaching and extended that warm hospitality that you only experience in this part of the world. Two days later my cable was stripped from it's head. Something to do with leaving everything attached and things getting dragged about...alright, alright I have learned, I will be a good boy, I promise. How embarrassing to go cap in hand to Doug and have to say "Mate, you'll never believe what happened...!" Luckily for me we stopped into Salvo for a squiz and there was the fixit man soldering cables on to plugs ... "Mate....can you help a poor Aussie tourist I said!" "Shucks no problem, just bring it in". "Oh...it is another brand". I said "Don't worry about that we see all kinds" he said. Salvo fixed it no charge, and

did not give me a bad time about it...good guys!

Ginnie Springs had low flow so it made diving easy, the carpeted steps, the clear water, change tables, hot showers and beautiful countryside made our stay and dives unforgettable. Hill 400 the Roller Coaster and the Grand Traverse waited. This place has so much to offer and you can see why divers are willing to part with lots of dollars each day to dive here. When I hear divers complaining in Australia about the cost of cave dives I just laugh. This was the only place where our qualifications were questioned and it was because they didn't understand what

"Penetration Diver" meant. Terri and I discussed that Penetration Diver with advanced Cave in brackets, might be the way to go in future on our cards.

> Bill Rennacker was waiting for us at Luraville where there was a Dive Rite sale on. Only in the USA could you do this...a huge tent, free B-B-Q, soft drinks, beer and "specials" to tempt you to part with your hard earned dollars. Lamar Hires said hello and we chin wagged for a few hours. There must have been 500 people out in the middle of nowhere, a great example of the camaraderie between divers.

We dived Cow, Telford, Little River, Orange Grove and the Peacocks, but that might have to wait for another time
