

DIVE REPORTS

Drift dive with a difference

Craig's call came on Saturday morning, mid way through a weeks worth of washing (yes even high-powered marketing executives have to occasionally stoop to the mundane). What did I think about the conditions? We had been talking during the week about a dive on Sunday morning if the southerly had eased sufficiently.

I had spoken to the guy at the dive shop that morning, while having my tanks topped up, and the report had been very encouraging. We agreed to give the Tuggerah a go if the seas were flat enough for a comfortable decompression (nothing more uncomfortable than hanging around under a small boat in choppy seas). I put the twin bands on my tanks and checked the camera with a sense of anticipation. Events would make tomorrow's dive even more memorable than hoped for.

Sunday morning at 7:00 am and I'm at Yowie Bay wharf with another mate heaving all our gear into Craig's boat. The skies are clear and the breeze almost dead calm. The run out is fast and as we turn the corner from Jibbon point the seas are only slight so we confirm our decision to head south to the wreck of the Tuggerah.

Hazy conditions obscure the northern marks but we locate the wreck without much difficulty and get a firm hook-up on the second attempt. This is when things start to get a little interesting. Despite the lack of wind, the boat is tugging at the anchor line indicating that the

southerly current is running. We take a look at the speedo on the boat, which is registering less than a knot, and decide that the conditions are not beyond us or likely to make a short deco too arduous.

Craig's boat is a bit short on space with twin tanks and cameras on board so it is agreed that I should get geared up and in the water first. I have the camera and am therefore likely to be slower down the anchor line, with the others following as soon as they can chuck their gear on and get over the side Second fateful decision.

As I roll into the water the current sweeps me backward but I am expecting this and waste no time in locating the anchor line and heading for it. Latching onto the line I head down, dragging my housed camera and four foot strobe arm after me, hoping to get out of the current as soon as possible. It is immediately apparent that the viz. is not as good as I had hoped however the disappointment is replaced by elation as I head deeper and the murk clears away to reveal the shadow of the wreck on the bottom.

I touch down to the eerie calmness of the wreck site. Savouring what I expect to be a few moments of solitude I look around me. The current is almost non existent at this depth. Visibility is good, over 20 metres, but the dirty water on the surface is blocking out a lot of the light giving the scene a spooky twilight feel.

The thing I like most about this dive site, is the huge school of red nannygai, hovering in a vast cloud above the wreck. Much more of the structure is visible than usual. No sense in wasting bottom time I think, I check the anchor, it is hooked over a piece of iron (must remember to check it is clear on the way up), check my gauges, both regs working, check the camera, oh shit! The locking ring on the front of my strobe is missing along with the diffuser. I survey the damage. The diffuser must have caught on the anchor line on the way down and caused the locking ring to undo.

No serious damage yet!!!!!

The water pressure is holding everything together. I know that that is unlikely to remain the case when I get back to the surface However, nothing I can do about it now. At least the strobe is working at the moment. I am going to need a bit of artificial light due to that dirty layer of surface water. I head over to the propeller, a few metres away and set up for my first shot. Conditions aren't too bad for photography. The clear bottom water should keep back scatter away and there is still enough natural light to give a gentle silhouette to the fish schooling above the wreck. I take some shots of the propeller, a large windlass, some nannygai schooled around a mass of netting under the stern.

There is a galvanized anchor chain coming out from under the stern terminating with a shiny stainless shackle and a piece of anchor rope freshly snapped off at the thimble (I subsequently discover that Max Western has left this behind the day before). Where are my buddies?

Probably don't want to dive with a cameraman. I had expected to see their bubbles through the schooling fish though. The nannygai usually leave a bit of distance around the column of bubbles. I take a few more photos and check my gauges again. Coming up for 15 minutes deco. I don't really want to commit myself to any more time on the shot line in the surface current so I head for the anchor. During the whole dive I haven't moved more than 8 metres from the anchor so I'm sure you can imagine my surprise when I discover it isn't where I left it.

I check my bearings, no mistake, this is where I landed. I rise up in the water column, over the schooled nannygai, to see if the line is visible (it might have re-hooked on another part of the wreckage). No sign of it and I can see a fair bit of the wreck now. I briefly consider checking to see if my buddies have re-anchored on another part of the wreck but I discard this idea almost immediately. It would only entail more deco. So it's cut my losses and run. I continue ascending slowly towards my first stop. The water is dirty, at 9 metres, limiting my view of the surrounds. I wonder if I am sharing the vicinity with any large wildlife. I remember the speedo on the boat; I will be

heading inexorably south. I swim gently towards the sun since the current will be taking me the other way. I wonder if Craig is back on the boat. I assume he is since I didn't see him on the bottom. If not we'll all be having a swim around the Pacific Ocean. Just as well we checked in with the coast guard before heading out. At least the others will have some company during the long swim to shore, I muse, and I only have the camera for company. I rise up to my next stop.

There is a popping sound, as the port of the strobe is forced open by the internal pressure. I clamp my hand over the port, desperately trying to minimise the amount of water entering the innards of the strobe. If you haven't done an open water deco in poor viz. I can't describe to you how boring it is. There is just NOTHING to look at! Mind you I don't know how glad I would be to have something big and interesting to look at. Might be the wrong sort of company.

If the other guys are back on the boat now I'll bet they're shitting themselves. Probably wondering how they're going to explain to Sarah that they managed to lose me. I keep checking the computer but it seems to take ages for the time to count down. Finally the computer is clear! I wait an extra few minutes for safety and head for the surface.

Back in the sunlight again I can see the boat about half a kilometre away. It is moving but not towards me. Thank goodness for safety sausages! I fumble mine out of my BC pocket and inflate it while trying not to drop my camera or the loose strobe port. Once the safety sausage is up they only take a couple of minutes to spot me and head over. They are pleased to see me though I suspect more out of relief at not having to confront Sarah than out of concern for my life. Back on board and I hear their side of events.

They were in fact only a few minutes behind me when entering the water. The anchor must have let go under the load of two divers pulling themselves down against the current. This was probably just after I turned around to start taking photos. When they reached the anchor it was dragging across a featureless sand bottom.

With no hope of dragging the boat back against the current, to where they suspected the wreck was, they were left with no option but to ascend. After a short safety stop they hopped back in the boat and weighed up their options. Should they relocate the wreck and attempt to re-anchor? After checking their watches they decided that I would almost certainly have left the bottom by the time they had hauled up the anchor, relocated the wreck and re-anchored and besides there was no guarantee they would anchor on the same spot. They therefore decided to drift down current for the expected remaining duration of my dive and then actively search for me. They left the anchor out to slow the drift a little. When I surfaced they had just pulled up the anchor preparatory to searching for me and were discussing how long to search for before calling the coast guard and requesting assistance. Unfortunately for them, they had blown their bottom time for a return attempt on the Tuggerah so they had to settle for a dive a Osborne Shoals.

This dive certainly showed the advantages of having someone sitting the boat, especially in any wind or current. Although it is less likely that the anchor would have released once the divers were off the anchor line it could still have occurred. A reel wouldn't have been any help, as the load would only snap such a thin line, especially with all the twisted steel about on a wreck. In future we will probably dive in shifts with the second group not leaving the boat until the first group is back at the deco line. Perhaps other members might like to relate any similar experiences in the wet rag. I know another club member had a similarly lonely open water deco only the day before at the same dive site.

So there you have it. The story of my drift dive on the Tuggerah.

COMMON NAME: Bennetts Nudibranch
SCIENTIFIC NAME <u>Hypseldoris bennetti</u>
DISTRIBUTION: Common along NSW Coast
HABITAT Rocky reef and sponges (all types)

DEPTH RANGE: 0 to 30 m ADULT SIZE: 60 mm

NOTES:

Can be found by itself or in groups.

Their colour is pale blue fringed with yellow. The dots on the upper body are red, while the gills and rhinophores (horns) are white with red edging. Sometimes you can find some small

transparent sea spiders / crustaceans or copepods on them. The relationship with these creatures is unknown.

PROPOSAL FOR THE CLUB MEMBERS

The Proton Magnetometer has been a source of many heated discussions and problems for the club over the years. This being so at the last club meeting on February 15th 1999 I put a proposal to the floor that the South Pacific Divers Club should sell its Proton Magnetometer and buy for the club members a Slide/Print Scanner and an External CD-ROM writer.

Approximately 4.5 years ago the club purchased the Proton Magnetometer for the sole purpose of trying to locate new wrecks. To properly locate a wreck you need not only the Proton Magnetometer but also Side Scan Sonar. As a very avid wreck diver myself I have no problem with the idea of trying to find new wreck sites. What I do have a problem with is that \$4,000.00 of the clubs money was used to purchase the Proton Magnetometer which of the club only a select few are able to use this expensive piece of equipment.

Note: 1. You have to have access to a boat.

2. You have to be trained in the usage of the equipment.

3. You need years of experience to be able to differentiate between the readings.

4. In 4.5 years the equipment has been used but a handful of times.

I believe we put a sale price of \$2,500.00 on the Magnetometer and do not go below \$2,000.00. This will cover the cost of the new pieces of equipment being proposed.

A Slide/Print Scanner and an External CD-ROM writer will have much more benefits to the club and the club members at a cost of approximately \$1800.00. More club members will have useable access to these two pieces of equipment than the Proton Magnetometer.

Benefits to the Club and Club Members:

1. Will be able to scan slides or photos onto a CD-ROM or Computer.

2. The Club can make up its own PowerPoint presentations and burn them onto CD's for promotions within dive stores and at trade shows.

3. The Club can scan all the photo competition slides onto CD-ROM for record keeping instead of duplicate slides being kept. (Cheaper)

4. Club Members can have access to both or either piece of equipment.

5. Will help dress up the WETRAG with more photos from club members.

6. Will be helpful in promoting Photography back into the club.

I would like to see a <u>ONE-WEEK</u> booking program applied to the usage of the Slide/Print Scanner and External CD-ROM writer. This would mean that you could book in advance for the items if they are already out on loan. If when you return the items and no one has booked them for the next week you can then book them out again. But the items have to be returned to the equipment officer at the end of each weekly booking before they can be booked out again.

Standard Voting procedure apply

With this edition of the WETRAG, Noel Taylor has put a proposal for the club members to sell our Magnetometer and purchase a slide scanner and CD ROM. Now I can appreciate that Noel and or any other <u>financial member</u> of our club has a right to propose anything they like, but they too must appreciate that other members have a point of view aswell. Unfortunately this proposal, as others, from time to time have been padded with many red herrings. If the proposal carries any weight, you members will except it. This proposal, in my view is shrouded in mystery and has a foul odour about it and needs to be looked at thoroughly.

In 1995 a proposal was put to the club to buy a mag. It was published through the WETRAG and a vote was taken. The vote was an extreme majority in favour of purchasing the mag. "Noel had nothing to do with the club at this time." Sadly the members who raised the issue, also had submitted a set of guidelines by which the mag would be used. The minute the mag arrived they continually refused to accept their own rules and this is why there were many heated discussions, both privately and publicly over the mag. These members in the main are no longer with the club. There is still a small group of members wanting to use the mag but will not do so at the moment until all this political garbage ceases. In reality what is being proposed here is that we throw away \$2,000.00 worth of equipment and with the remaining \$2,000.00 we purchase another piece of equipment that "only a select few will have access to". If indeed we need a scanner/ROM which costs approximately \$2,000.00 we have \$8,000.00 invested, there is ample funds to purchase it anyway.

Now lets dissect the pros for selling the mag in Noels order:

"We need access to a boat"

Bloody hell! How else would you tow a mag around? Behind a tow truck! This was a known quantity when the mag was purchased.

"You have to be trained"

What you're telling me is we need certification from P.A.M.I. to use this equipment. What garbage. "Training", the word of the late nineties, the word associated with people running around the countryside conning other people out of money. Well I for one attended the lecture Bob Ramsey gave us when he originally delivered the mag, many others were in attendance Noel was not.

"You need years of experience to differentiate between the readings"

Can't quite understand what Noel is talking about here. The side scan sonar or the mag. I agree that the more one uses the mag and plots its path the better one will get, but without the mag no-one will get this experience.

"In 4.5 years it has only been used a handful of times"

Legitimately yes. Scott Willin admitted at the last meeting that he has used it a "dozen times". I was president from the time we first purchased the mag up until 20 months ago and Russell"Baseball bat" Stoker was property officer until 12 months ago, we have no recollection of Scott Willin ever hiring the mag. Am I to assume he has used it 12 times in the last year. Obviously one way or the other it has been used more than a handful of times.

"Finally, the side scan sonar"

To find a wreck you need a boat "yes", a lot of research "yes" that's it. A depth sounder helps, a mag helps even more, a GPS is another helper, a side scan sonar is also another instrument, not necessary, but sure does make the job easier. May be the club should consider buying a side scan sonar.

Now for the slide/print scanner and external CD-Rom writer (scanner/Rom). Not necessarily in Noel's order. How many members will use this equipment? I ask these questions: How many financial members are photographers in our club? How many members entered our own internal George Roberts competition last year? How many members entered the main competition and regularly attend club functions?

At the club over many years we have hosted the A.U.P.Y. with many members devoting their time to the efficient running of this competition. photographers have given their time back to the club? How many entrants have joined our club, even though entry into the competition is cheaper for Non photographers volunteer their time to host the comp and members? presentation night (the largest in this part of the world). Yet photographers still don't join our club, do you really believe this equipment will entice photographers into our club. I doubt. I'll bet most photographers have access to this gear anyway. Other benefits to club members allegedly are club members will have access to this equipment and we will be able to scap slides, both of these statements are stating the obviously surely. The cl can utilise CD writing facilities, now available in most photographic shops, relatively inexpensively and even if the next competition does go ahead it may well be the last anyway.

Over the last couple of years we have produced 3 full colour editions of the WETRAG without the club owning this equipment. This facility is still available to the club if the occasion arises. The final benefit in purchasing this equipment is showing off our club in dive stores! "Yeah" Noel what shower did you come down in. As to trade shows, we are not welcomed there nor should we be there. We do not manufacture or retail, we are a non-profit organisation.

"THE BOOKING PROGRAM". Mag rules revisited, heard it all before. These questions need to be answered before considering this proposal. Who supplies the computer? (same situation as a boat) to use powerpoint commercially who pays the licence fee, who will pay the repair bills (this equipment is a little sensitive to be transported around, and is ideally suited to be in a stable environment.)

The magnetometer is a robust piece of equipment that we own and very few are available. We should use this as a asset for our club. It is time various members stop using it as a tool to cause problems in the club. Selling it will make S.P.D. look stupid in the eyes of other clubs. It is time as members we say enough is enough, leave the mag alone, as I said earlier if we need the scan/CD-Rom well then we can buy it anyway. If the main reason to sell it as lack of use then the oxygen gear should go, as should the projectors, etc, etc. A precedent will be set. Proposals to purchase any equipment in the future will be unattainable.

The whole idea of a club is to join forces and work together on projects that is otherwise impossible outside this proposal is not about buying a slide/print scanner and external CD-Rom. It is about selling a magnetometer. I WONDER WHY.

VOTE NO, and keep our mag.
