Sue Armstrong had been invited along to the meeting to shed some light on the question of diver related accidents from boats and whether or not the club can be held liable.

Sue stated that as we are a un-incorporated club, the club as a whole could not be held liable for any boating accidents occuring whilst on a club outing, but the boat owner or any individuals found to have caused the accident through negligence on their part could be held liable. It is always a good idea to make sure that the person diving is a certified diver.

The injured party would have to prove that there was a breach of duty, that no reasonable person would have done it and that it was out of line with normal diving practise.

You can only sue the person who was actually negligent. The action in this case would be against boat captain.

There was a suggestion that members should sign a decleration that they are responsible for themselves as certified divers. Another suggestion was to put C Card No. of member on membership form and incorporate this signed decleration. Sue offered to draft something up for us along these lines.

Boat owners should carry comprehensive insurance (3rd party).

The question was raised: "Are boat owners liable if they accept money for dives?"

Sue answered: "Accepting money to cover costs is not a problem."

B.J. thanked Sue Armstrong for attending and giving us her time and advice.

As the next club meeting would fall on Easter Monday, a suggestion to change to the following Monday 27th April, was made by the president. Passed by majority B.J. requested permission from club members to spend money to entertain the judges on the judging day as is the normal procedure. Passed by the majority.

A donation of \$50.00 to the Hunter Valley Bottom Time dive club was suggested as we could not attend its fund raising activity. Passed by majority.

The meeting was closed and the George Roberts Comp. entries were shown.

Larry King was awarded 1st. prize and the trophy.
