### PRESIDENT'S REPORT

What does the Group have to show for another year's activity? I believe the highlights were two courses run by CEGSA for other people.

The first ran for four evenings at the Workers' Education Association. It was proposed, planned and run by CEGSA Members, Dot Paisley being the guiding light, but most advertising was left for W.E.A. which was a mistake. Attendance was low due to many factors (including the weather) but a lack of time between conception and execution, and the relatively high fee of \$12.00 were influential

The second course was an introductory Search and Rescue Seminar and practical for two State Emergency Squads which was well attended. With further training these squads will be ideal man power in the event of a real call-out.

Repeats of these courses are planned in 1981. The Police Special Tasks and Rescue Force have requested the S. & R. course for February, 1981 which should be completed before presentation of this report.

The 14th Australian Speleological Federation Conference (January, 1983) is to be held in Adelaide. Planning for this event has already commenced with Flinders University as venue for accommodation, meals and papers.

Cave locating to absolute references instead of by feature maps which keep changing, has kept many busy cavers busy and consequently reduced the number of cave maps produced this year to its lowest for many years. Nearly all caves and karst features on State Forestry land have been accurately located, mainly by Kevin Mott, and together with our descriptions and conservation ideas, will be presented to Woods & Forestry at their request for forest management planning.

A grant from the Department of Recreation & Sport has enabled us to purchase a set of Single Rope Technique Equipment for training purposes.

All the aforementioned is a good report for any small, voluntary speleological society, something to be proud of. But wait. Aren't we a cave exploration group? Over the last few years there has been a steady drift away from, and scorn of, "tourist" trips. This is wrong. What is happening in S.A. is that more people are going caving but think of CEGSA as a society beyond their aspirations and needs.

When asked to talk to organisations, we invariably try to **TEACH** about caves and give the impression of a learned body. What we should do instead is transmit enthusiasm for caves and caving, the thrill of just being in Nature's Wonderland. The present result is a steady decline in recruitment with a rise in requests for our "expert" services.

I've been responsible for a good part of this situation by encouraging, doing and implying "scientific" caving. What is now needed is to emphasise what CEGSA has to offer - the joy of caving. My present term as President is now finished and I stand down to enable another to impart fresh attitudes and hopefully, a more balanced caving scene next year.

### SECRETARY'S REPORT

Activity of the Group has been more diversified this year. Because other commitments and illness, physical caving activity has been lower than normal. Educational activities with other bodies hopefully will ensure proper foundations have been laid for safer caving.

An introductory course on caving was conducted through W.E.A. in the middle of the year. Negotiations for a training course in cave rescue with the STAR force are being conducted. Lessons learned from a similar course conducted for Noarlunga S.E.S. will help to make this course more relevant. Members of the group have been involved with teaching scouting groups the fundamentals of caving.

On the conservation side, the group has been liaising with the Woods and Forests Department to relocate caves on forest land. Once this has been done the caves described and management proposals will be included in Woods & Forests Department management plans. Tantanoola Caves Conservation Park was visited by members of the A.S.F. as part of a study to draw up proposals for a plan of management.

Numbers were down for the VSA - CEGSA Annual Dinner at Naracoorte in June. Those who attended found the event managed to satisfy their instincts. The Annual Dinner was well attended despite the change in venue. This year we had the use of a private dining facility. Noel Mollet and Vic Linke cut the 25th year cake and reminded us of some of past antics of members. We haven't really changed.

### TREASURER'S REPORT

### RECORDS REPORT

The key word with the S.A. Speleological Records this year has been "status quo". Due to pressure of other work, the Records Officer has been unable to devote very little time to further sorting and cataloguing of material on hand. However, the Records remain in a reasonably orderly form.

This "non-activity" has been substantially matched by other members of the Group, in that a smaller amount of material has been submitted to Records for archiving than in any year in recent memory.

The most significant project seems to have been the consolidation of our knowledge of cave occurrences within Woods & Forests Department land in the lower South-East region. This work, in cooperation with the Department, aims at including the caves in an overall plan for management of the forest reserves.

Survey work was done (and maps produced) in Mullamullang Cave N37 (see Nullarbor report) and in the most-recently-found significant cave in the Flinders Ranges (F33). Additional work has removed some discrepancies and added to the detailed maps of Corra-Lynn Cave (Y1).

A new filing system has been instituted for the Group's photographic records. In addition, we now have about 70% of the microfilmed map copies installed in slide mounts for projection purposes at meetings and conferences.

Total numbers of numbered karst features within South Australia and the Nullarbor Plains (excluding Glenelg River) are listed below, region by region as at the 5th December, 1980. Numbers of new allocations since "Checklist of Australian Caves and Karst 1979" are shown in brackets. (These numbers are not necessarily the highest numbers allocated because some numbers have not been used.)

## SAFETY AND TRAINING

Most effort this year was spent on consolidating the call-out and Search and Rescue system. The group met with Superintendent Sampson of the Special Tasks and Rescue Force (Police) to discuss a joint exercise; the exercise will be held at Curramulka in February, 1981, prior to which CEGSA will give STAR Force a days lecture on caving and cave S. & R. procedures.

The Group's S. & R. Guidelines and Call-out List were updated and expounded. There is now a Main Call-out List consisting of 9 experienced cavers, an Area Expert List, with name of people who have a good knowledge of caves and cave location in a particular region and a Back-up Call-out List. The Main List is held by Police Headquarters.

CEGSA ran a Cave Search & Rescue Course for the Noarlunga and Mitcham State Emergency Squads in November. This was a two day course for 30 SES members. The first day consisted of lectures on caves, caving techniques, typical accident situations, Search and Rescue techniques and Logistics, and a practical session on vertical work and stretcher handling. The following day. a S. & R. exercise was carried out in Carrickalinga Cave.

The course proved very successful with all learning a great deal, particularly with the difficulties of extracting a patient from awkward passages.

Having a group such as the SES trained in cave S. & R. would certainly be of great benefit to us in an emergency situation. To have worked with these people in itself is of utmost importance. It means in the real situation that faces will be familiar and capabilities known and hence cut out any time wasted in establishing hierarchies and competencies.

Hopefully CEGSA, SES and STAR Force can combine on a practical exercise, to establish the best ways to integrate all the skills.

If anything brought sobering thoughts to members about cave rescues, the film Rescue at Sunset Pot shown at the July General Meeting certainly did. The film of an actual cave rescue in England, highlighted the great difficulty in removal of a 'stretchered' patient, in a seemingly simple horizontal passage, and the need for manpower, equipment and competent rescue co-ordinator.

CEGSA did not have an internal S. & R. exercise as in previous years, however we may look at Carrickalinga Cave as a most suitable cave for future exercises. My observations on Group Trips this year were that members are caving safely and are well equipped.

Training of members is by and large carried out on trips and occasional sessions on the cliff at Morialta - there were no Field Days at Reynella nor Training Evenings.

CEGSA has procured a grant from the Department of Recreation and Sport for S.R.T. gear and rope. This will take the strain off those members who have been generous enough to allow trainees use their personal S.R.T. equipment. The gear will only be used for training purposes and not for trip use - it will be kept under the care of the Safety and Training Officer.

Several scouting groups were led on caving trips by CEGSA members throughout the year and a ladder training session was run for the Underwater Explorers' Club who required the skills for cave diving trips at Mount Gambier.

I would like to thank Graham and Kevin for their time spent in Safety and Training aspects.

## **MEMBERSHIP REPORT**

Nineteen-eighty saw a reduction in CEGSA's membership from a total of 82 in the previous year to 69. These were comprised as follows:

- 10 HONORARY LIFE MEMBERS
- 29 FULL MEMBERS
- 30 ASSOCIATE MEMBERS

Although the net change is only 13, in fact 30 of the 1979 members did not renew their membership. As I mentioned in my earlier report, a number of people were known to have left South Australia, and it is reasonable to expect non-renewal in these cases. However, this still leaves approximately 20 who progressed to different interests.

CEGSA has always had a membership with a core of long-standing members, and a balance of numbers remaining for perhaps one or two years, or often shorter terms. A number of us have put many hours of thought over the months into group membership - its attractions and detractions, member needs, meetings, trips and other facets of the problems of small group membership. Nevertheless, there does not appear to be any simple means to increase or even to stabilize the groups' numbers. This has always varied, and there is no doubt that we are at present in one of the downward swings.

I believe that the membership of any group is dependent on the population of the locality in which it operates, and having regard for the type of activity in which it indulges. Caving, as a sport and science has evidently managed to maintain a group of about 100 in Adelaide over past years. I wonder though, whether the activities of the group have changed its nature from earlier days, to one where different requirements are demanded by members.

In my own eight or nine years there has been less and less "exploration" for the simple reason that our own activity leads the caver to travel further afield for new experience. We have seen an increase in travel to distant caving regions in S.A. and to greater speleological wonders interstate and overseas. We have also seen a tendency of our members to diversify their interests into broader fields. There has been a big increase in the outdoor movement at national level, and there is ample evidence of our own members gathering into bushwalking, diving, cave diving, rafting, climbing and other activities. This diversification can only increase. With heightened awareness of other sports, and a low level of group projects, I suggest that we may not see the days again where caving is the whole activity of our members. The group will, of course, always provide a vehicle for the pursuit of specialist disciplines associated with caves.

Caving has seen the increase of advanced techniques to pursue exploration (e.g. diving, S.R.T.) and the growth with these of individualism. At the same time the group has experienced cliques growing around different interests and backgrounds, age, length of time in the group, and social activities. Fortunately these have not been derisive, but are perhaps daunting to new members. I fear that the small membership of the group, and the very slow turnover of new members will lead to a lack of membership resilience, and therefore slow recovery.

I will not be standing for Committee next year, since my studies and job will not permit me to do the task justice. I certainly wish the new holders of the job success and will help wherever I can. Membership is going to be a challenge over the next few years.

## CAVING ACTIVTIES

# ANNUAL REPORT 1980 - 1981



### Henschkes Fossil Cave

Neville Pledge organized 5 trips during 1980 (January 4-6; February 9-10; March 8-9, 29-30 and November 15-16) to continue the excavation of this fossil deposit. Some 70 volunteers, including 7 CEGSA members participated in some way.

About 16 square metres of cave floor, up to 1.5m deep, were excavated, and some excellent specimens were obtained. Notable amongst them were a skull of the giant Echidna. <u>Zaglossus cf.</u> <u>rawsayi</u>, jaws of the short-faced Kangaroos, <u>Sthenurus spp.</u>, teeth of <u>Zygamaturus</u> and bones of the giant Mallee Fowl, <u>Progura naracoortensis</u>.

Analysis of the bird bones by Dr. G. Vantets (CSIRO, Wildlife) indicates the presence also of a large Water-fowl about **Progura** size (i.e. turkey size). A popular account of the discovery of the **Zaglossus** skull was published in the Friends Newsletter, "FOSAM" (September 1980).

Kevin Mott visited the cave on several occasions to complete its survey and keep up with our additions-by-excavation. A reasonably accurate map is now available to assist in the analysis of the fossil collection and the distribution of specimens.

Excavation was, as before, hampered by the appearance of large rocks and boulders within the cave fill. One large boulder, resting on the silt floor, had to be reduced in size and stabilized in a new position before digging could proceed. One hardly anticipates using a sledgehammer and crowbar in excavating such fragile fossils, but that is what it took! Further work now appears limited: we can in fact, see an end to this project, with only 2 or 3 square metres of accessible cave floor still to be excavated.

## Yorke Peninsula

Activity was confined to Corra-Lynn. Very few CEGSA members visited the cave, but some made many trips. Max Meth and George Parker topped the list, planting and looking after trees as well as removing debris and preventing further accumulations in the entrance passages.

Introductory trips were led for Banksia Park Adventurers, Scotch College students and several for CEGSA, but the most important introduction will be for the Police Special Tasks and Rescue Force in February, 1981 which will be using Corra-Lynn for cave search and rescue practice with help from CEGSA. Maybe the Police will remove the minimum height requirement!

Surveying of bits and pieces found mainly by Max and George took more effort than expected but we now have the Mott Spott Maze/East Bushwalker's Chamber/Gunbarrel connection areas surveyed together with a re-survey of the Limestone Bridge/Great Collapse area. Three areas are now left to survey totalling about 500m of passage.

Extensive finds in Corra-Lynn have been elusive this year despite the intensive efforts and the use of a new dirt-blockage probe.

## **Eyre Peninsula**

The only trip to the region resulted in exploration of the underwater sections of Death Trap Cave and Homestead Cave (Lake Hamilton).

Homestead Cave was penetrated a further 100ft. underwater, with more passage yet to explore. Death Trap closed off at a depth of 4 metres with no horizontal development.

## **Nullarbor Plains**

This exciting area was the scene of two CEGSA trips in 1980 - trips with very different objectives but both proving highly successful.

In May a group of 4 members and 2 visitors (cavers from the U.K.) rendezvoused with 3 from Perth (WASG) for a survey trip to Mullamullang Cave. N37. The aim was to establish reliable control (both horizontal and vertical) for future detailed survey work in the very complicated Easter Extension area. The horizontal work was extremely successful, 8 electromagnetic (RDF) control stations being established in the Extension, and the inter-connecting surface survey (by triangulation) also completed. Incidentally, a further RDF fix at White Lake (2km. in a straight line from the cave entrance) confirmed the accuracy of the original underground survey of 1964, showing a discrepancy of only 2m.

Vertical control work (by means of water-filled tube levelling) has second priority and only 20% of the program was completed. A follow-up trip is planned for 1981. Once the party had become familiar with the operating peculiarities of the levelling equipment, this work proved to be a surprisingly pleasant caving activity, it is apparently the first use of water-tube equipment for levelling by CEGSA.

The May trip was a social as well as scientific success, the participants experiencing that particular sort of comradeship which comes only with "expedition" caving. Quick side trips were made to the Kestrel Caverns, Abrakurrie and Weebubbie Caves.

August 1980 saw a five-person cave diving trip, taking in Warble, Weebubbie, Tommy Grahams and Pannikin Plain Caves. The first three have become established as "recreational" diving caves (par excellence) and this trip furthered that tradition.

Pannikin Plain Cave has had little previous underwater exploration but this situation is now guaranteed to change, as a major find of 500m of passage was made (the logistic limit) with no end in sight. Further pushes will extend the cave diver's art to the limit because the depth is such that long decompression times will be necessary.

The August trip also took in Mullamullang Cave, a "dry" day, but snorkel exploration was made in White Lake, revealing no leads.

## **Flinders Ranges**

There were eight trips to the Flinders Ranges this year, resulting in several caves being tagged and entrances being photographed.

Half of these trips were primarily run to begin studies of the cave dwelling bats of the region. This involved mist netting cave entrances and nearby waterholes together with general observations inside the caves. Many of the caves have rich deposits of bat guano, but despite this evidence, little is known of the species and their habits.

Narrina Lake Cave was visited on three occasions - the extensive under-water section was surveyed and mapped early on in the year by cave divers.

Reports of Mt. Sims Cave "falling in" were found to be untrue, while it was discovered that the bottom passage of Mt. Remarkable Blowhole had collapsed, making the small lake at the bottom even smaller and less accessible.

## Kangaroo Island

There were no caving trips to Kangaroo Island.

## **Adelaide Region**

The most notable event occurring within this region was the rediscovery of Burleeyung Cave near Burra. This cave has been largely unknown for 120 years except for the occasional reappearance of an old newspaper article. The cave just makes it into the Adelaide region so eat your heart out Flinders Ranges.

Carrickalinga Cave received a good deal of attention through a rescue exercise conducted jointly with the Noarlunga SES. During a visit to the cave prior to the exercise, several sea caves were found nearby. These have not yet been numbered or located. There has also been a report of a cave in the property adjacent to Carrickalinga Cave.

## **River Murray**

## **Upper South East**

This was probably the most visited area after York peninsula during the year. Survey work continued in the Victoria Fossil Cave. The steepness of the exit path has made surveying relatively more difficult. Terry's new Blackberry gate is almost completed. The framework only needs to be treated with a rust inhibitor to complete the work of art.

By the time the Annual Report is completed an era of caving will sadly come to an end with the demolition of the Naracoorte Hut. It appears that the majority of membership is not prepared to pay the high price required by National Parks for a replacement hut. They would prefer to cave and work voluntarily and for pleasure.

Bruce Allen resigned from National Parks and is now managing the Kangorong general store. We wish him well in his new venture and thank him for the assistance he gave the group both at Naracoorte and Kelly Hill.

Henschkes Quarry continues to linger on and yield more bone material. When it finally is completed a new cave deposit near Camaum should keep Neville more than busy.

## **Lower South East**

Although there has been reports of several new caves in the area nothing has been done to investigate them. The relocation programme was continued with tagging and photographing done in connection with the Woods & Forests project. This involves locating, describing and suggesting priorities for preservation as part of Woods & Forests management proposals for forestry areas.

Tantanoola tourist cave received attention from the ASF through its management study on behalf of the National Parks & Wildlife. The new ranger, John Callaghan has already done a commendable job in trying to clean up the cave. We can only hope he does not have to tackle bureaucratic red tape from the management authorities and the clean-up can continue and the redevelopment proposals will be implemented.
