### SECRETARY REPORT

### MUSEUM REPRESENTATIVE REPORT

I am pleased to report that the skull fragments of the Wonambi skeleton stolen from the Museum last year have been recovered from an anonymous person through a third party. It is anticipated that they will go back on display when the Museum reopens next March, after major renovations to the Aboriginal gallery and elsewhere.

Terry Reardon and Neville Pledge led a group from the Friends of the South Australian Museum (FOSAM) to Naracoorte in November, staying at the new Caves Reserve dormitory accommodation on Carters old place. The program was to visit the new Wonambi Fossil Centre and the Victoria Fossil Cave, help Terry with his bat survey project, and visit a number of features in the lower Southeast, notably Piccaninnie and Ewans Ponds, and a detour to the spectacular Hell's Hole (L40). The Wonambi Fossil Centre gets better and better, with new exhibits appearing all the time. Despite a few

hiccups, the weekend trip was enjoyed by all, and the new bunkhouse facilities proved quite comfortable.

As a postscript, Terry reports that more recent testing from the Bat Cave has revealed some disturbing results, which he will release when final analyses have been done.

A new cave found in the northern Flinders last Christmas had several partial skeletons, some still with desiccated skin. Photographs taken by Jules Gheude, however, showed them to be dingos and not the thylacines that early descriptions suggested.

"Vineyard Cave", discovered during the year near Naracoorte, has yielded a quantity of fossils, including a jaw fragment of the rare 'marsupial tapir' Palorchestes. These fossils are being studied by Liz Reed as part of her PhD work.

### SOUTH AUSTRALIAN SPELEOLOGICAL COUNCIL REPRESENTATIVE REPORT

The major events for 1999 were:

The Australian Speleological Federation, of which the SASC is the recognised State body, has acknowledged that the SASC is independently financed for both revenue and expenditure. This means that the SASC does not form part of any ASF audit.

The Outdoor Recreation Council of South Australia (ORCSA), of which the SASC is a member, is amalgamating with the Recreation Council of South Australia (RCSA).

Town Well Cave, 5Y2, is still closed because the entrance is still unstable.

The SASC has held joint club training for the "ASF Caving Leadership Scheme" and plans to present a common certificate. The training of the assessors has started.

The GPS units now have computer connection cables and software.

Warraweena Cave, 5F10, owned by "Wetlands & Wildlife", is being proposed as a site to be managed in conjunction with the SASC.

The Quorn ASF Conference finances have finally been closed and about \$1300 distributed to the ASF. The large "profit" was because a large number of unexpected late registrations occurred after cost recovery had been budgeted for and then cavers using their own vehicles supplied the extra transport needed. We also received some significant donations.

### **CAVING ACTIVITIES**



### ADELAIDE HILLS & FLEURIEU PENINSULA

The work in the Adelaide Hills and Fleurieu Peninsula region has once again focussed mainly on the Sellicks area. With the exception of Sellicks Hill Quarry Cave, 5A20, the predicted major cave systems still elude us, but small breakthroughs in 5A25 and 5A30 help to keep the optimism alive. A micrometeorological study of the airflows in 5A25 and 5A5 is planned for the coming year. It is hoped that this study will enable us to determine whether the two caves are linked underground, and to upgrade current crude air-flow based estimates of predicted cave volume with more precise measurements.

It is pleasing to report for a change that no further attempts have been made to break in to 5A25. It is possible that the extra layer of reinforced concrete added after last year's attempted break in looks like too much hard work. We hope so.

One visit has been made to an interesting area on the lower Fleurieu, where winter rains caused further collapse in a small sinkhole. Any progress in this area is dependent on plenty of manpower for a well planned and committed digging exercise, and may therefore be a few years off, because it is hard finding enough dedicated diggers at present even for 5A25 and 5A30. Volunteers are always welcome.

There is still scope in the region for some surface exploration, and because of its proximity to Adelaide and the effects of population pressure, it is important to catalogue and investigate significant karst features while we still have the opportunity. Housing is being established on limestone strata on the hills overlooking Carrickalinga. One house at the base of those hills several years ago suffered a sudden and significant subsidence of their garden that appeared to be a consequence of collapse into a cavity generated by, or forming part of, natural underground drainage, and resulted in a claim being made against an insurance company. Large cracks observed to be at least several metres deep opened up overnight around a subsidence about eight metres across luckily right next to rather than underneath the footings of a two storey house. A conical doline in a farm paddock in the same band of limestone a kilometre or so to the north is a visible manifestation of karst processes which could indicate future problems for other housing and any as yet undiscovered significant karst features which may lie below. The safe treatment and disposal of effluent from septic tanks is another area of potential conflict that comes to mind.

Correspondence has continued to be exchanged between the State Government and members who were involved with Sellicks Hill Quarry Cave who have been concerned over the Government's lack of progress in implementing the recommendations of the Environment, Resources and Development Committee's report on the matter. Regrettably, the Government seems to be accepting at face value, and with relief that the problem may have been gotten rid of, advice from "a qualified surveyor" that the cave has now been substantially removed by mining. Throughout this matter the Government has demonstrated a preference for clutching at bad advice rather than ferreting out the truth. It only takes a cursory inspection of the site and a proper understanding of the cave survey to establish that significant portions of the known cave could still be intact. Additionally the Government has been repeatedly advised that survey and exploration of the cave system was incomplete at the time further access was denied, so the factual information which would be needed to support the claim attributed to the "qualified surveyor" just does not exist. Cavers look forward to the day when the fact that such caves are out of sight no longer results in shabby, half-baked misrepresentation, and the resource we are attempting to conserve is at least judged in the light of proper, well-informed assessment processes. In the present circumstances it is difficult to form a conclusion other than that those who do not want caves to interfere with mining are afraid of the possible outcome of a proper assessment process, and have at least the tacit support of the Government.

Even so, the Government wants to avoid a repetition of the Quarry Cave debacle and some good may yet come from this episode. One of the problems that the Government found that it was faced with in dealing with this matter was that the Sellicks Hill Quarry has the status of a private mine. The Government has finally legislated to amend an anomaly created when the current Mining Act was passed in 1971. To avoid massive compensation payouts when the new Mining Act reserved minerals under private land to the Crown, the Government largely exempted Private Mines from the provisions

of the Act. This meant that there was little the Government could do about the Sellicks Hill Quarry Cave matter under the Mining Act (as distinct from the actions of Minister Wotton in actively preventing any proper assessment of the cave under the provisions of the Heritage Act). The Government has now, with the support of Labor and the Democrats, as well as the Chamber of Mines and Energy, and the Extractive Industries Association, passed the Mining (Private Mines) Amendment Bill, which among other things has the function of requiring proper environmental considerations to be made in the preparation and implementation of mine operations plans for private mines, and gives to the Government the power to enforce compliance should this be necessary. The regulations to accompany this Bill should be in place early in the coming year, and are expected to require operators to consider caves and other items of environmental significance in the preparation of any mine operations plan. It remains to be seen whether operators observe the spirit of this legislation, or alternately are so scared by it that they make sure all future caves are destroyed before they are "discovered". We urge the Government to encourage the former approach by ensuring fair compensation is payable in the rare event that unexpected discoveries of significance necessitate the modification of a mine operations plan.

### **FLINDERS RANGES**

Activity in the Flinders region during 1999 was again dominated by exploratory trips in the Wirrealpa–Narrina area. Further work mapping and relocating features was carried out, but new discoveries were scarcer than in previous years. Features found in 1999 were F175, F176, F177, F178 and F180.

In February a trip to the Point Well area began the survey of F172, Sweet J Cave and also visited F170, F171 and F173. The location of Steam Pot (F74) was confirmed by GPS, and the small cave was further explored with assistance from new Flinders recruit Jock Hummer.

An Easter trip from April 1-8 visited the areas of Point Well (finished surveying F172), Narrina Hut (confirmed locations for F18 and F67), Moro Gorge and Gum Creek (Trezona Range). F175, McKinlay's Daughters Cave was found near Moro Gorge and F176 and F177 were found in the hills around Arrowie Gorge. The location of F69, Gum Creek Cave was confirmed with GPS.

In May, further exploration of F171 began, with over 100 buckets of dirt and rubble removed to the surface. F178, a small craggy hole near Eregunda Spring was discovered on the trip.

Another trip over the May long weekend was run by Frank Hankinson and Gary Woodcock, to the Bagalowie area, visiting Mairs (F3) and Clara St Dora (F4) Caves.

Warraweena station, on the western fringe of the Flinders was visited over the June long weekend, with the objective of locating F10, Warraweena Cave - the location of which has continued to elude CEGSA records and the property owners. The cave was eventually found and its location accurately recorded. Since the trip, the property owners have consulted with CEGSA members involved in this trip, in developing a management plan for this sensitive cave.

Point Well homestead was visited again over the October long weekend. Digging in F171 continued and an area of promising limestone in the hills north-west of Narrina homestead was walked in search of new caves. No new features were located, but the area shows good potential and appears to be largely unexplored. The stunning scenery of Blinman Pools was appreciated later in this trip. These permanent pools are well worth the several kilometre walk.

A trip in early December returned to F171, where the technique for bucket removal reached a greater level of sophistication. Later in the trip a new feature near Narrina Hut, F180 was discovered and appropriately named Kangaroo Rodeo Cave. The location of F67 was also confirmed by GPS.

Flinders Ranges karst features now total 179 (F179 is not allocated yet). Activity is sure to continue with enthusiasm in the new Millennium.



### **KANGAROO ISLAND**

Despite improved access to the Island with the new Sealink ferry, "Sealion 2000", and the bitumen now close to Kelly Hill, the Island's caves warrant more attention than we have been able to give them again this year. When we do manage to get there, we keep promising ourselves that we won't leave it so long before we return, but despite all the new labour saving devices around us, life just keeps on getting busier. At least we did manage one very productive trip to the Island in June last year in conjunction with members of CAVEX.

Several so far small but interesting holes near 6 Mile Lagoon were briefly examined. Further exploration and survey is planned for a return visit in May. At Kelly Hill, the timely approach of an intense low pressure system caused strong cave breathing which helped us to locate a very promising area for concentrating further exploration effort in the main Kelly Hill system. Current indications are that the known cave still only represents a small fraction of what remains to be found. Much the same comment applies to minor caves southwest of the influx. The scale of development in some of these caves, when coupled with the strength of breezes observed, suggests that the main cave system in this part of the ridge is yet to be located. Considerable effort should be invested in systematic searching for leads if we wish to improve our understanding of this complex system.

### **LOWER SOUTH EAST**

Caves numbered 13 Features recorded 12 Latest number L429

Caving activity continues in the South East, albeit quietly with a couple of CEGSA trips to the area early in the year. Further work continued in L412 but more work is required to resolve anomalies in the surveys. A known cave with a tight entrance was entered for the first time and preliminary exploration revealed at least 500m of passage. This cave still needs to be documented. Several trips were run through the area by Peter Horne to show overseas visitors a sample of our karst.

The 13<sup>th</sup> biennial conference of ACKMA was held in Mount Gambier in April with delegates from across Australia and overseas. Field trips were conducted through both the Upper and Lower South East. Delegates were impressed with what the area has to offer in karst; if not the weather.

Neville has been busy extracting fossil whale material out of the limestone. The find is quite exciting and together with material from L412 should help to provide a better understanding of our past.

A census of bat sites was undertaken in the winter as part of a Wildlife grant. This grant was obtained to determine the status of bat habitat in the region and to get an up to date idea of population numbers. The numbers appear to be declining but the study shows that more detailed research is required to better understand what is happening to the bat population. Part of the problem appears to be that no one is willing to accept responsibility for research or management of the species.

Several training sessions in cave searching with the Mount Gambier SES were conducted during the year. It is anticipated that the sessions may flow on to the Naracoorte CFS in 2000.

Forestry SA have developed a GIS system to manage caves on forestry land. This was triggered by the need to ensure a duty of care to employees under the Occupational Health Safety and Welfare Act. It far surpasses anything caving societies have and provides up to date information on the cave or feature.

A listing of cave nomenclature for the Lower South East was published in Volume 44 No 4 of CEGSA News. Members are encouraged to look at the document and provide feedback on names as it is intended to have the names listed adopted as recognised nomenclature.

### **MURRAY PLAINS**

The usual caving took place this year to Punyelroo Cave and Gloop Cave.

A trip to three previously noted but undocumented caves/rock shelters containing Aboriginal art was made at the end of 1998. Two trips were made to an area between Swan Reach and Loxton. Six interesting features were noted bringing the M list up to 40. One depression near Swan Reach was excavated from the initial 3.5m to 7m depth down a 1.5m diameter solution pipe.

### **NULLARBOR PLAIN**

This year the numbering of karst features on the Nullarbor reached 1654 with some significant caves being found.

Many known caves remain unsurveyed so accurate figures are not available. But there are now at least 120 caves over 50m in length with 39 exceeding 200m.

Much work is being done in the field by Paul Devine. He has to date added 122 karst features to our database most with complete descriptions, and most are tagged. Most of the new additions are in Balgair Station and nearby. With many significant caves now being found in this area, the old idea that caves are mainly found in the coastal strip needs at least to be revised. Particularly since the Nullarbor's longest cave N83 is also located in this northern area.

Old Homestead Cave 6N83 surveyed length is currently 26.7km as per Graham Pilkington in CEGSA NEWS vol 44 #4. I recall making the remark to Graham, "We will be old men before this cave is completely surveyed". The occasion was in Sept 1985 when Graham and I were walking along the main passage in the North Cave that we had just entered for the first time. We were walking past many side passages on at least three levels. It was VERY obvious on that first trip that the cave was immensely complex. Events have proved that this is so. Realistically, the cave may never be completely explored because the limits tend to be awkward and difficult to traverse.

In some of new caves being found there is a great diversity of troglobitic fauna. Both in the "traditional" areas of cave fauna on Mundrabilla and Madura stations as well as on Balgair Station. Finds have been made by N Poulter, S M Eberhard and P Devine among others. The report by Stefan Eberhard THE BIOLOGICAL SIGNIFICANCE OF CAVES N46, N327, AND N1327 ON THE NULLARBOR PLAIN commissioned by Norman Poulter of SRGWA contains a detailed account of troglobitic fauna occurring in those three caves.

The TROGLOBITIC species in these caves include:

Amphipods, Isopods, Spiders, Cockroaches, Beetles, Centipedes and a Planthopper.

On Balgair the cave fauna species found include: (per Paul Devine)

Troglobitic Isopods, Spiders, (Janusia ?murri) (Tartarus ?sp), House centipede, Harvestman spiders and Cave crickets.

It hardly needs to be stated that much further work remains to be done on the Nullarbor. Both in finding new caves, and in exploring existing ones, and in detailing the fauna they contain.

#### TREASURERS' STATEMENT

The above Income and Expenditure Statement Balance Sheet and other statements are a record of the activities of CEGSA for the year ending 31<sup>st</sup> December 1999.

By the end of December 1998 eleven members had paid their membership in advance for 1999, boosting the coffers nicely. But at the end of December 1999 only one had paid for the year 2000. I trust this does not mean we will have a lean year. Unfortunately in the last 12 months we seem to be down a few long standing Full Members and for a while we had only one Associate Member. Fortunately, we managed to pick up a few late Associates and to save costs, some Full Members joined together as Family Members. We also had an increase in Country Members that include new members from Mt Gambier, S.A. Moe, Victoria and Kalgoorlie, Western Australia.

In spite of a great effort made by some members to help raise a little extra towards our overhead, we are still not fully self supporting. If it were not for these members, that include Marie Choi and her Teddy Bear Raffle (to be set aside for restoration purposes,) and her sale of batteries (towards costs of the interesting Reptile lecture) plus CEGSA sale of excess library books and donations by several venture groups, we would be in a pickle. At the moment our saving grace is our largest income after Membership, Advertising in CEGSA NEWS (which is our largest expense.) Without advertising we are far from being self supportive. So to make sure that these advertisements continue, please visit these "outlets", shop for your caving and camera gear at these Stores and make it work for you, them and CEGSA.

To help cover some of these running costs, at a Committee Meeting held on the 11<sup>th</sup>November 1998 it was suggested that all Membership fees increased by \$5 per member. It was then suggested that the fees be automatically increased by \$1 per year to accommodate potentially looming running expenses. It was then brought forward at a General Meeting dated 27<sup>th</sup> January 1999 and voted "in" by members. Therefore the extra \$1 has been added to each membership category for 2000.

According to the Financial Statement for 1999 and the proposed budget for year 2000 this will hardly be substantial towards being self supporting and I suggest that we all get together in the near future regarding this matter and come up with something more substantial.

Since the proposed budget for 2000 was handed in, the costs of overseas postage has increased significantly. There is no longer the cheaper mail service of "sea mail" for letters, only for parcels. All mail will go via Airmail and of course at an extra costs. This means that the overseas CEGSA NEWS and the ANNUAL REPORT will cost from \$4.50 for 250g up to \$9 for 500g each. We exchange magazines with 12 overseas clubs.

A transfer of \$8,000 was made from CEGSA General Account to Savings & Loans Credit Union (SA) Ltd., as an investment put into a 12 months "High Riser" Account. We receive an overall 5.28% per year.

Congratulations must go to Kevin Mott and Fred Aslin who shared a Grant for \$1,000 deposited in CEGSA account by National Parks Foundation of South Australia Inc to go towards their bat research in the Lower South East.

Earlier in the year an investigation into printed Membership Cards proved to be far too expensive and it was decided that Athol Jackson would print out the cards and they could then be sealed in plastic sleeves and run through a laminator. This proved to be effective, simple and almost cost free and will be adopted as a regular system of maintaining an ID card for CEGSA Full Members.

FEES ARE NOW DUE. It would be appreciated if all members could pay their fees as soon as possible, remember to include ASF fees.
