#### PRESIDENT'S REPORT

Although CEGSA has one of the largest memberships of any ASF club, many of our members have effectively retired from caving or are taking a long break. The number that join in club activities is actually quite small. Nevertheless, CEGSA has again been involved in a whole range of events during the year, some of which are outlined in the various reports herein.

Some of our caving activities are purely recreational and others have supported a range of community groups (schools, university groups, cave managers, archaeologists, cave scientists etc.). But the excitement of finding, exploring and documenting hitherto undiscovered caves or cave passages is one of the things that keeps many cavers going year after year. CEGSA and many other Australian clubs have been in existence for well over half a century but the opportunity to keep making such discoveries continues, as evidenced by new finds in the Nullarbor cliffs and on the Nullarbor Plain, not to mention the vast amount of new cave that is discovered up in the Northern Territory each year and by our divers interstate and overseas. The rewards of such discoveries are still there for those who are prepared to put the work in.

My tenure as CEGSA President will come to an end at the 2014 AGM and another will take on that role thereafter. During the last few years, I have written and spoken several times about the need for cavers of all caving groups in South Australia to start working more closely together and to share in each other's activities. I am pleased to say that there has been a willingness among many cavers to do exactly that and I will be endeavouring to see such collaboration continue in the future. To do so provides a means for newer members in particular to enjoy a greater range of caving opportunities and experiences.

Finally, I would like to thank the members of the 2013 Committee and Office Bearers for all of their work during the year. In particular, I thank Chris Gibbons for her tireless efforts with our accounts and membership database, Ian Lewis for his unceasing efforts to build better relationships between CEGSA and other organisations, particularly National Parks, Athol Jackson who produces our publications year after year and Graham Pilkington who takes on an enormous amount of work on behalf of CEGSA, particularly in securing our records in digital form. Without these people, CEGSA would not be the successful organisation it is at present.

#### LIBRARY AND RECORDS REPORT

The major work for 2013 was:

#### Website

Our website has been kept up-to-date with CEGSA NEWS, Annual Reports and Occasional Papers. The availability of General Meeting minutes on the website has streamlined our meetings.

#### **OzKarst**

OzKarst has had the promised upgrade to better cater for the data that it needs to hold. First release of the new version should be made prior to the AGM. It now handles all the data fields stored in the 1985 ASF KID – CEGSA did not use many of these fields because they do not apply to South Australian caves. Caves have been split from surface features so that not only can one cave have many entrances but one "entrance" (karst code) can have many caves – for example, independent caves off a large doline. It handles water and mineral sample results as well as outcrop information. Bibliographical information has been greatly enhanced with the text being available and searchable (after entry!) by converting our "Articles" database to "OzKarst Library" and embedding it into the OzKarst system.

#### OzKarst Library – was the Articles database

Developed from the Articles database to hold all types of written material, whatever the source. "Articles" was initially developed to handle the indexing of newspaper articles and this focus has been preserved. However, OzKarst Library can also be approached "top-down" via organization —> publications —> publication edition or issue —> then articles in these. The Articles focus allows searching by text in titles, images, or comments as well as by keywords.

OzKarst Library can be used for all types of cave and karst information in both published and none-published form held in newspapers, journals, books, club records, and other sources such as postcards. The "Reference" section of the OzKarst database has been moved here.

Periodical articles initially catalogued in the Newspaper/Magazine section of the Articles database (because the original list was only for Newspapers) have been moved to a Periodical section (either of caving or none caving).

Library books have been completely re-catalogued from the "CEGSA" database into OzKarst Library. In the process, book series have been recoded so that they reside together on the shelves (eg ASF Conference Proceedings) rather than scattered by date obtained. The Periodical catalogue was also moved from "CEGSA" to OzKarst.

#### **Periodicals Binding**

The caving-journal binding project was on hold this year as effort was concentrated on the upgrade to OzKarst. Eleven covers were added including one new periodical of three covers. Total bound is 53 titles with 431 covers.

#### **Major Gifts**

CEGSA received two large donations in 2013. The first was from Cate Martin, who has ceased caving and wanted to give her caving books a useful future. It consisted of 23 books, 3 DVDs, a journal, 17 newspaper extracts and 3 cave posters. The second was from Hugh Sangster, following his death,

consisting of 19 books, some monographs on cave/caving, some geological and topological maps, 245 slide photographs, 110 photo prints, a side projector and screen, tripod, slide-racks and side-rack cases. Both gifts are described in more detail in NEWS#231.

#### Other Additions to Library

A collection of 18 mainly Jenolan books and booklets was purchased as detailed in NEWS#229. Other books purchased included "Malaysian Cave Bibliography" while members donated several items.

#### **Paid Assistance**

A student was employed during the year to help with digitising CEGSA's Records. The following items were scanned or completed as a joint effort:

300 newspaper and other articles as images.

300 monographs, most as images. Average length was about 10 pages.

Some newspaper/periodical banners (title on cover) were scanned.

Old Homestead Cave's first south cave visitor logbook typed up.

Data on the 550 Quartermaine-Wheeler Nullarbor karst features were typed into a database. The location sketches were scanned and linked in. Some of these features have not yet been visited by CEGSA, and some have vague location information.

Caving journal issues scanned/cleaned/or digitised to text for both an electronic copy and for hard-copy binding, including Kempsey SS (11 volumes) and South Africa SA (5 issues).

#### **OZKARST & OZKARST LIBRARY**

You may wonder at this new title for my report. No longer are OzKarst & Articles database two separate entities.

We have not been given a current working copy of OZKARST this year as Graham has been revamping the database to make it compatible Australia wide. This has held us up in the ability to add new data that we are currently holding ready to enter.

The database previously known as 'Articles' has now been renamed OZKARST LIBRARY.

Graham has changed its name as it is now part of OZKARST & consists of all published items. In last years report we stated we were 80% through a checking process of all records & this took till mid June to complete. Following this task we did a specific check of Border Watch Newspaper records which took another 2 months. In the past 12 months the total records have grown from 8,461 to 8,784. Scanning is ongoing, with scans being added to their related article as they become available. Several attempts have been made to sort out UK newspaper problems, but with no success thus far. Prior to a trip to WA in Sept/Oct, we listed problems that could be best tackled whilst there. Our success with this was quite high.

Field work included -

- A boat trip on the Glenelg River through the full length of the January Kentbruck major fire. This yielded some upgrades & a new feature.
- Byaduk, Vic was visited to upgrade data.
- Kentbruck fire area yielded new & updated data.

#### SEARCH AND RESCUE OFFICERS REPORT

2013 was a very constructive year in the area of Search and Rescue. Fortunately no major incidents were reported and the year appears to have been incident free.

Late October saw myself, Ken Smith, Craig Challen (CEGWA), Luke Nelson (CEGWA) and John Currie (CDAA) place a rescue cache into the second air chamber of Cocklebiddy Cave (Toad Hall). The cache contains lighting, environmental protection, first aid, food and water and a through ground cave radio kindly made by Tim Payne. The second half of the radio is now kept at the Cocklebiddy Roadhouse and any divers visiting Toad Hall are encouraged to utilise it. Although this was a fairly major undertaking, the presence of the cache will significantly improve the chances of a good outcome in the event a diver is injured or disabled in Toad Hall.

Two cave rescue training events took place. The first, with the assistance of Tim Payne, was a Sump Rescue Orientation Program (SROP) at Mt Gambier. This program is a basic introduction to the issues surrounding the rescue of an injured caver trapped on the wrong side of a sump. The program was run as a workshop alongside the Cave Divers Association of Australia's 40<sup>th</sup> Anniversary celebrations in early November. Seven CDAA divers completed the program over a day and a half of talks, practical exercises and mock rescue and body recovery in the cavern zone of Pines Cave.

Just a week later, a Cave Rescue Orientation Program (CROP) was run with the assistance of Graham Pilkington and Ian Lewis, for the Naracoorte guides at Naracoorte Caves. Also in attendance was South Australian Ambulance Service Special Operations Team (SOT) paramedic Dean George, and CFS Regional Commander SE John Probert (a caver himself). Deborah Craven-Carden who was the head guide helped organize an excellent weekend and after the usual talk-fest we finished with some valuable stretchering and first aid exercises in the caves.

So a quiet first half of the year followed by some frenetic activity, I hope to build on these activities further in 2014.

## **CAVING ACTIVITIES**



#### ADELAIDE HILLS & FLEURIEU PENINSULA

The only known visit to a cave in this region in the past year was to 5A25 at Sellicks Hill. The purpose of the visit was to re-secure the entrance gate to this cave after it had been found to have been interfered with by persons unknown sometime this Spring. Presumably a cordless power tool of some sort was used to remove the relatively inaccessible locks from the gate. There was evidence that the intruders had progressed a fair way down the cave, with a change to the way a ladder had been suspended, but fortunately little damage was observed, other than to an electric cable, although the inspection was only cursory.

The cave gate has now been re-locked as intended and has remained that way for about three months. The internal ladder has been removed. No evidence of any further unauthorised attempts to access the cave has been detected. A telephone contact number for information has been reinstated on the cave gate. It is still intended that further airflow measurements be carried out in this system in the near future as a guide for future exploration.

It is also worth noting a significant anniversary has just passed. On Tuesday 10 December, 2013 it was the 20<sup>th</sup> anniversary of the large blast carried out by Southern Quarries for the purpose of "imploding" the largest known chamber in Sellicks Hill Quarry Cave 5A20, which is now known only by its survey, photographic and video records, and a number of reports written about this sad and quite shameful event. The blast was detonated on Friday 10 December1993, the day before a South Australian State election, and it was widely considered that this timing was deliberate. It is particularly sad not only for the fate of a major South Australian cave, but because despite good intentions on the part of a number of people, and widespread community concern at the time, we have not made any significant advances towards ensuring that any lessons have been learned and that history cannot repeat itself. Regrettably for the future of cave and karst conservation in this state where potential conflict with quarrying operations may be encountered, "out of sight" is still very much "out of mind".

#### **FLINDERS RANGES**

Two trips to narrina were undertaken in 2013, one during easter and the other in october. On both occasions the western end of Narinna was visited.

Extensive surface exploration was conducted for collapses and solution holes and we were not disappointed as numerous features were found. At both times temperatures were above thirty degrees Celsius making conditions uncomfortable.

A new form of examining the viability of pursuing constrictive solution tubes was adopted by ray gibbons, involving the use of a Go-Pro camera attached to poles with a truck Luxeon light and lowering it as far as possible enabling us to assess whether to devote time for further pursuit or to abandon it. Trip participants were Ray Gibbons and Eddie Rubessa.

#### KANGAROO ISLAND

Only one short CEGSA visit to Kangaroo Island was made this year. Because of the considerable potential for new discovery, all trips, no matter their duration, are by definition too short.

A couple of visits are planned for the coming year. Ongoing projects range from continued systematic exploration and survey within the main Kelly Hill system as well as a number of associated minor caves through to continuation of the survey of K11 which is now known to be quite a complex cave.

Following my retirement I have been plotting all my survey data for cave locations around Kelly Hill against 2011 ortho photos. The surveys are those that were done on a series of trips 20 years ago. From the plots I am deriving a series of grid references as there appears to be very few of the caves GPS'd. Katrina Wills from DEWNR has supplied some co-ordinates which I assume are GPS points. These are matching the derived values reasonably well. A trip in May 2014 is planned to verify the data. There are some 50 features awaiting the allocation of numbers so these will be given temporary numbers early in 2014.

#### **LOWER SOUTH EAST (Dry)**

Caves numbered 3 Features recorded 3 Latest number L556

During the year Nature Glenelg Trust worked with CEGSA to produce a karst database of the Lower South East for Dept of Environment Water and Natural Resources (DEWNR). The functional side of this database provides a GIS tool to enable researchers to identify sites that contain biological or environmental, archaeological or palaeontological values. The South East was divided into cells. Each cell lists the cave numbers and the values of each cave. If the researcher needs information regarding the cave they can contact CEGSA. Only caves on public land or on a public register are shown with a point value. A facility exists for DEWNR or CEGSA to exchange updated information.

A new access stairway was constructed to give divers easier access to Fossil Cave at Tantanoola. A new water monitoring point was also established to record levels as the existing point is no longer accessible.

A collapse some 4m in diam and 5m deep at a house in Mount Gambier caused some concern for the owner but consultants were able to engineer a solution to preserve the house.

An interesting karst spring near Beachport was documented.

Several trips by FUSSI looked at various caves in the region.

There have been numerous diving trips this year; most going to the Roe Plains where again more kilometres of submerged tunnels were found. Some research is being conducted by others on the appearance of "hot spots" in the cave lakes. It's postulated that these are "springs" and may be the key as to why the caves are found where they are and the size that they attain.

Other dry caving trips included surveying in Old Homestead Cave and the locating and documentation of some Quartermaine-Wheeler as well as other features.

A special permit is now required to go caving on the Nullarbor Plain in South Australia. Trip Leaders can obtain the relevant details from the Committee.






