LIBRARY AND RECORDS REPORT

The major actions for 2014 were:

OzKarst and OzKarst Library

The ability to compare and amalgamate data from disparate databases has finally been achieved. This enables cavers to use their own copy of OzKarst to enter new and updated data instead of having to put these in a separate otherwise empty OzKarst for submission to a central database.

The file naming convention has been altered to differentiate between surface features, caves, and rock exposures in files specific to them. These might contain photographs, maps or other images and documentation.

A graphical image display program is now supplied with OzKarst to expand the range of file types that can be handled, increase the functionality of display, and removes the user's need to supply their own driver for each file type.

Biological photographs can now be fully documented as for other photographs. Multiple photographs of a specific specimen are now allowed.

Much time and effort has been spent on the removal of (hopefully) most of the glitches that come with new software. However, because people are always wanting more with less effort, new problems keep popping up.

The Library is now much more functional as a part of the OzKarst system. Entries can be accessed from almost any part of OzKarst so that users can lookup a specific entry pertaining to the item of interest. For example, if damage to a cave is noted in an article, then the report of the damage in OzKarst can reference this article and even open the article at the specific page.

Comparing and amalgamating Libraries is the same as for OzKarst but restricted to just the Library. Any adjustment made in Library to an article's data set or index number is automatically adjusted in OzKarst to keep the reference intact.

There are several functions that will be completed or added next year: Maps, Surveys, Geology, and Satellite imagery in OzKarst; and for Library, keyword amalgamation/automation with OzKarst enabling Library to pull up OzKarst data just as OzKarst can pull up Library articles. But for users, the best addition will be the automated installer for upgrades!

OzKarst as a Karst Archive

CEGSA is starting to receive data on interstate areas from other clubs to enter into OzKarst as an archival repository. I intend to visit these clubs in 2015 to instruct them on how to enter the data directly into OzKarst. HCG supplied information on 2CV this year. We already had some information on the Kimberley (from WASG) and Vanuatu (from our Harry Harris). CEGSA has been adding its own data about Victorian karst from field trips led from Mount Gambier by Dave and Fred.

Periodicals Binding

The caving-journal binding project was on hold again this year as effort was concentrated on the development of OzKarst. Five covers were added giving a total bound of 53 titles with 436 covers.

Additions to Library

Several books were purchased for the library.

If anyone has any journals, books, or other publications that are about caves or caving (or maybe contain a one-off article), then CEGSA will be pleased to accept your donation. Better to have them available for reference than gathering dust.

CAVING ACTIVITIES



ADELAIDE HILLS & FLEURIEU PENINSULA

Last year's report noted that someone had gained access to 5A25 at Sellicks Hill by cutting relatively inaccessible locks off. The gate has again been damaged in January 2015, clearly by using an angle grinder with cutting discs, and is in the process of being repaired and strengthened yet again. The cave has not yet been entered since this latest onslaught to assess any damage, but it is likely that at the very least broken glass will need to be removed if the remains of the beer bottles around the gate are any indication.

Perhaps a bigger but related issue is the loss of access to other known Fleurieu Peninsula caves. A number of known caves and karst features on the lower Fleurieu Peninsula occur on and under private property, and while in most instances the owners of the properties may not even be particularly aware of the actual or potential significance of these features, the increased need for security against unwanted visitors and loss of old contacts through changes of ownership are currently a cause for concern.

Access to at least four separate groups of caves and karst features for which we have had good access in the past is currently hanging in the balance. Two of these areas are as a result of changing ownership, and the other two are for personal family reasons. In each instance there may be an opportunity in the future for respectful and sensitive discussions, but we must respect the rights of owners old and new, make our case for consideration thoroughly, and be prepared to be patient while attempting to earn the trust of those on whose permission we depend.

Our recent experiences with the 5A25 gate should make it clear to us why landowners in the region, and probably right across the state, are becoming increasingly concerned about security.

On a more positive note, there has been some recent interest in the coastal caves between Second Valley and Cape Jervis. Instead of concerns about landowner relations, the emphasis is on weather and calm seas. Even something as obvious as long known sea caves has some mystery associated. References in very old newspaper articles suggest that there is at least one cave of relatively impressive dimension in the area for which we do not have a current location. Additionally, a couple of the known sea caves were allocated "A" numbers many years prior to the advent of GPS, and there is some uncertainty as to what was which, and why other similar caves were not numbered. The new interest in this area should see all these features properly recorded, and that will be a good thing.

Trips of note during the year were a surveying trip by Martin Fresacher. Several new caves, L524 & L525 were visited as a training exercise to teach Martin surveying techniques. Peter Horne and Ian Lewis visited L14 during the AGM of the CDAA to collect faunal samples from various sites in the sinkhole.

A camper in one of the caravan parks dropped the wheel of his vehicle into a cavity 7m diam x 5m deep. No leads heading off were found but there are reports of earlier collapses in the area. The collapse has since been backfilled.

The recent Tantanoola bushfire has exposed an area of significant sinkhole development and it is planned to document these during the year.






