We now need to promote caving to a wider audience, maybe by persuading parents that caving is better for their kids than playing computer games.

LIBRARY AND RECORDS REPORT

The major actions for 2015 were:

OzKarst and OzKarst Library

This year Maps, Surveys, and Geology have been added into OzKarst. Upgrading or moving OzKarst has been made more automated and self-adjusting. The OzKarst merging routines have been improved and made more robust. Checking for deleted entries as well as added or amended entries is now possible.

The folder content analyser has been re-written into OzKarst instead of as a separate software package run by OzKarst. It now handles file names containing unusual characters that were not being copied by the previous system. Duplicated files can now be detected where the file name was altered. Instead of being limited to examining one folder at a time, all subfolders with matching names can be examined in one pass. Extra functionality includes selectively deleting files or editing filenames. The analyser is especially useful in merging OzKarsts but can be used to analyse any folders such as archives to remove accumulated duplication.

All of the nearly 3000 References contained in KIDSA were dumped into the OzKarst Library after it was merged with OzKarst. Most of these References were from periodicals and books in OzKarst Library. This year these References have been moved to where they belong hence the temporary dump, and the many duplicated entries, have been eliminated.

The Books sub-database within the Articles catalogue of OzKarst Library sometimes refers to items such as Occasional Papers that have been catalogued as a Publication and given a "P" number. The system now allows for the electronic copy of the book to reside in the appropriate "P" folder instead of being given a "B" number and placed into the Books folder. This reduces the duplication of filenames using the same "B" code for different books by different OzKarst Library assemblers that then need renaming on merging.

OzKarst Library as a Publication Achieve

With the rapid expansion of digital publications, OzKarst has become an ideal way to catalogue, store, and view periodical issues. As more people catalogue the contents of their publications, these can be absorbed into the OzKarst Library for everyone's benefit, even if the digital copy is not available. Many societies have and are scanning their journals and putting them on the internet for public access. Some of these, such as *Caves Australia*, have been downloaded into OzKarst. Unfortunately, unlike CEGSA, most clubs are only creating simple images and not text versions of their publications. This means that not only is the text not word-searchable, but the required storage is an order of magnitude larger.

Periodicals Binding

Many periodicals are now being obtained as an electronic copy and are being stored in OzKarst without hard copies being made. Of our hard copies, 14 covers were added giving a total bound of 55 titles with 431 covers (plus 40 duplicated covers) as follows:

TRAINING REPORT

There were no formal CEGSA Training events run in 2015. However, CEGSA members did attend a large Search and Rescue exercise held at Fox Cave in September with FUSSI, Scouts Caving Group, SES, Naracoorte Caves staff and other emergency services.

The exercise was a 'test our resources' event which assessed the quality of communications on site between the field team of cavers and emergency professionals and to a temporary HQ set up at the Caves office. About 30 people took part and a group general debrief occurred afterwards focusing on ways of improving techniques and the flow of information to SAPOL who are the official coordinators for such rescue events after a callout.

Training should be an important part of any caver's agenda and the Training team hope to facilitate a further exercise later in 2016 based on the Fox Cave trial for cavers from all three SA caving groups to advance their skills together.

SEARCH AND RESCUE OFFICERS REPORT

2015 was another incident free year with no accidents reported. Training continued at a good pace with several courses and exercises being performed.

April. I travelled to Jenolan caves to assist with the running of a Sump Rescue Orientation Program with cavers from SUSS and the NSW Cave Rescue Squad. The challenging conditions of the Jenolan sumps (tight, low visibility and cold) made for an authentic rescue scenario and a chilly experience for the victim (yours truly!). It was an excellent opportunity to widen CEGSA's contacts with other cave rescue personnel, and an excellent learning experience for all.

May. A Sump Rescue Orientation Program (SROP) was held in Mt Gambier under the auspices of the CDAA. A dozen new divers enjoyed the 2 day course, with the practical component being held again in The Pines Cave.

September. A dry caving SAREX was held at Naracoorte, run primarily by the Naracoorte cave guides, local CFS and with the involvement of CEGSA members and SA Ambulance Service rescue paramedics.

2016 promises to have more cave rescue training both above and below the water.

I was accepted onto the ASF Executive at the ASF Board Meeting held in conjunction with the Conference in Exmouth. This enables me to keep informed of all the latest happenings around Australia and to influence the ASF to achieve the aims of CEGSA and other SA clubs. With Stan Flavel no longer on the Executive, SA needed representation.

Matters directly affecting CEGSA have been few. Of note was the decision to extend the ASF Introductory Membership from 3 months to 12 months at no extra cost. Updates to several codes of practice are in the process of being finalised.

The method of calculating how many votes a club has at a Board Meeting was adjusted to better represent the members of a club (such as family membership weighting being increased from 1 to 1.5). The net result has almost no affect on most clubs, including ours, because we get 1 vote for every 10 "members". Most NSW clubs have fewer than 10!

CAVING ACTIVITIES



ADELAIDE HILLS & FLEURIEU PENINSULA

Although the damage to the gate of 5A25 at Sellicks Hill noted in last year's report has not been fully remediated, some preliminary work has been carried out to restore security and discussions held on improvements to the gate's configuration. A ladder that was normally kept rigged in the cave was also removed to restrict access to deeper sections of the cave in the event of a further break-in.

Further south at Delamere access to one important cave and karst area has been restored, with the new land owner appreciative and supportive of our efforts. Positive discussions are also being held in respect of restoring access on another property.

In each of these cases of our desire and need to restore access, the position of the owners is quite understandable and commendable, and inasmuch as they appreciate what is on and under their properties, motivated by a desire to protect and preserve the natural values of their land.

Our discussions with them need to incorporate patience, respect and understanding and build trust. One land owner in particular has been approached by a person with a hidden agenda who turned out to be interested in quarrying his limestone, which did not sit well with his strong feelings for looking after his land. His first concern was understandably to establish whether or not we had a similar hidden agenda. This actually makes him a potential ally but trust will need to be earned to forge the relationship, and that will take consistency and time.

While there are obvious benefits from our viewpoint in establishing new relationships with landowners and re-establishing access to their karst areas, there is also a significant benefit to the landowners as well, in that they will get a much improved understanding of the significance of the karst features on their properties, including the basic hydrology of stream sinks or effluxes, and the likely extent of any known or potential cave systems.

Our recent experiences with the 5A25 gate should make it clear to us why landowners in the region, and probably right across the state, are becoming increasingly concerned about security.

KANGAROO ISLAND

It is disappointing to report yet again that there have been no CEGSA trips to Kangaroo Island recorded for the last twelve months.

It is high time that we re-visited the island to maintain familiarity with and to continue the systematic exploration and documentation of the karst resources of the area. It is an area with quite possibly the greatest likelihood of significant discoveries being made, anywhere in South Australia, perhaps with the exception of the Nullarbor, but to achieve such discoveries we have to actually go there and put in the work.

LOWER SOUTH EAST (Dry)

Numbered 93 Features recorded 27 Last No L655 Last No (Forestry) L1076

Temp LXKRM 782 Temp LXDJL 10

At the start of the year a fire burnt through the area from Tantanoola to Glencoe. There were a considerable number of large dolines known in the area but they were difficult to access. Once Forestry had finished logging operations to clear the area we moved through and were systematically able to record these features without hinderance of vegetation.

Following earlier discussions with Forestry SA work has now commenced on reconciling our databases. Forestry have been allocated a batch of numbers from L900 to enable them to document features as they are found. These are then incorporated into OzKarst on a regular basis. Work is also continuing with inputting data into OzKarst. This includes obtaining up to date GPS locations.

Tim Featonby spent some time in the area promoting the survey of caves using the Zebedee 3D mapping system to Forestry and Dept Environment. Remko Leijs published a report during the year in which several new species of Syncarids were described.

Water level recordings in L81 indicate the last couple of dry seasons are having a noticible effect on the water table which will affect some caves.

NULLARBOR PLAINS

VSA ran a Ken Boland flying trip to the NE of Nullarbor Homestead. A few caves were found but mostly blowholes.

Steve Milner was on a multi-club trip to the Bunda Cliffs that explored several caves halfway down the cliff above the Wilsons Bluff Limestone.

A joint CEGSA-SUSS trip was made that started the survey of both Webbs and Witches Caves. The Webbs Cave survey was nearly completed and the cave covers an area of about 600x400m with a maximum depth of nearly 30m. The Witches Cave survey was not completed with maybe half being surveyed. Of note was a mezzanine level running just above the northern side of the second chamber. This upper level is prevalent throughout the cave but usually shows up as wall alcoves at roof level. Ignoring the entrance chamber, the cave is very flat, typically with 3m chamber height and a base at about 15m depth and maximum depth of 18m.

The Upper South East was included in discussions with Forestry SA to reconcile the databases. Changes to the boundaries of Naracoorte Caves National Park have seen some caves change ownership. Tim Featonby also demonstrated the capabilities of 3D mapping with Zebedee to the Dept of Environment.

Some reported caves in Mount Boothby Conservation Park were relocated with the help of the Field Naturalists Society.

The ACKMA conference was held at Naracoorte during the year and delegates used the time to visit some of the caves in the region. The Department of Environment is reviewing the cave access and classification and members of the group made submissions. A workshop to explore this further will be held on February 27th at Naracoorte.

An Interagency-Community Reference Group provides advice to the Minister on matters relating to the management of the Australian Fossil Mammal Site at Naracoorte. During the year Kevin Mott was invited to participate in the group as the representative for ACKMA, CEGSA and FUSSI.

A rescue exercise involving park staff, emergency services and caving groups was held in September. It has been some time since the last one was held and all parties learnt from the exercise and there is a need to hold these regularly.

CAVE DIVING REPORT

During 2015, several sinkhole dives were undertaken in the Mount Gambier area by CEGSA cave divers for underwater research purposes. Divers investigated Ela Elap sinkhole near Mount Schank to observe and measure water column temperatures and examine closely the range of different stromatolite types on the sinkhole walls. These change in size, shape and density depending on depth and the deepest ones were found at approximately 30 metres depth. Kilsby's Hole was dived to examine the fracture patterns in the walls and some ancient tree branches wedged between boulders at 25m depth which may have come from the original stringybark vegetation that was completely cleared for farming more than a century ago. Syncarids were observed on many of the small upper ledges in the daylight zone. Some gallant sump crawling was attempted in Homestead Cave, Lake Hamilton on Eyre Peninsula on a FUSSI/CEGSA trip – the first diving attempted there and very low, short and flat passages. A CEGSA/FUSSI cave diving party visited Narrinna Lake Cave in the Flinders Ranges and set up a circular fixed survey line around the periphery of the main submerged chamber. This will allow accurate side measurements into the various alcoves, rock pits and upper air bells which will provide a fascinating map of the geology when completed on a subsequent survey trip.

Matt Smith visited caves around Mt Eccles and Byaduk with the Scout Caving Group, Neville Skinner and Aimee Leong joined a FUSSI trip to Mole Creek in Tasmania and George and June McLucas visited a cave in Wee Jasper. Graham Pilkington and Mark Sefton attended the annual Judbarra-Gregory expedition in the Northern Territory which resulted in over 10 km of newly surveyed passages and two important cave connections. As a result, the Judbarra-Gregory National Park now contains the three longest caves in Australia.






