LIBRARY AND RECORDS REPORT

The major actions for 2016 were:

OzKarst

The Outcrop section has been renamed "Terrain" and expanded to cover more fields (pun intended). Selected Karst Code entries can now be extracted, including the associated folder contents, instead of all of a Karst Area.

Date handling throughout the OzKarst system was expanded and made more reliable including dates such as "before Easter 1999" and "circa 1905-1908".

OzKarst Library

Moving Article entries from the original (and only!) database of Newspapers into one of the Periodical databases has been completed except for a few stray duplicates that are still being found.

Some of the ASF's Library, the CWCG's Library, and the libraries held by the ASF and NSW Cave and Karst Numberer have been catalogued into OzKarst.

Several people have recognised the need to create a catalogue of all caving/karst periodicals. The SUSS Librarian has begun one that is not as comprehensive as OzKarst. The IUS has begun an international procedure to define what is needed at the Country level leaving each Country to work out how to handle journals from their own clubs that do not have an international presence. CEGSA has joined this venture as one of Australia's major caving libraries.

Periodicals Binding

Many periodicals are now obtained as an electronic copy and are being stored in OzKarst without hard copies being made. Of our hard copies, 18 covers were added giving a total bound of 55 titles with 447 covers (plus 42 duplicated covers) as follows:

SEARCH AND RESCUE OFFICERS REPORT

2016 was fortunately another quiet year for incidents and accidents. However in October, a 12 year old boy was rescued from Wet Cave in Naracoorte after slipping into, and becoming wedged in a a rift on a school caving trip. It was 5 hours before he was rescued with the help of SES, CFS and SA Ambulance Rescue Paramedics who used a liberal dose of olive oil, painkillers and rope work to winkle him out. It is gratifying that CEGSA's involvement in rescue exercises over the years may have proved beneficial in this case.

The annual Sump Rescue Orientation Program was conducted in the Mt Gambier area last May by Richard Harris, Tim Payne and John Dalla-Zuanna (VSA) under the banner of the CDAA. This will continue to be an annual event as long as it is required.

CEGSA is well overdue for a cave rescue exercise and this will be planned for 2017.

The main activity at Delamere over the last 12 months has been weed spraying and fencing to prevent the landholder's cows falling down sinkholes. This has been a positive contribution towards landowner relations, and helps maintain access to what may one day prove to be a significant cave system.

The particularly wet winter has helped us to locate a couple of new sinks at the base of a limestone cliff, but there would be a lot more work before any chance of locating a dark zone.

It is pleasing to report that there have been no obvious attempts to break in to the gated Sellicks Caves 5A5 and 5A25 over the last twelve months. There has been talk of further digging activity here, but no buckets have so far been hauled. Perhaps the coming 12 months may be more productive.

Some exploration of the region's caves continued during the year though mostly it was CEGSA members accompanying groups such as FUSSI and Scout Caving Group. Tim Featonby continued his 3D mapping program with the Zebedee with the data going to CEGSA records. Caves reported to have been visited include L5, L13, L18, L21, L60, L69, L119, L158, L224, L262, L264, L265, L307. Many of the new features recorded resulted from clearing a backlog of field work.

The seasonal rainfall continued to cause collapses to occur including one on a main road at the edge of Mount Gambier. The change in water levels at L81 reflected the higher rainfall. Discussions with CDAA and DEWNR continued with regard to improving access and water monitoring.

The group made its' services available to One Forty One Plantations and the Green Triangle Forest Products to assist them with identification of hazards during forestry operations. With a couple of exemptions, forestry regulations are now charging for access permits to dry caves. The caving groups need to begin discussions with Forestry SA to find a more satisfactory outcome for this process.

Chasing old field notes and trip reports highlighted a numbers of features that had been reported but not recorded in the numbering system. As a result these caves and dolines have never been followed up to obtain good descriptions and locations. Similarly Bulletin No 35 "The Hydrology of the Murray Basin Province in South Australia', published for the Geological Survey of South Australia by the Department of Mines in 1960 described a number of features.

During the year while inputting data into OzKarst I calculated the location of each of these features. Some would be +/- 100m but they give a starting point for members to follow up on so they can be properly documented and we can live up to our name.

VSA ran a Ken Boland flying trip to the north east of Nullarbor Homestead. A few caves were found but mostly blowholes.

A joint CEGSA-SUSS trip completed the survey of Witches Cave started in 2015. It has a COMPASS length of 3800m but is better described as covering an area of 300m EW and 330m NS with the entrance in the southwest corner. Another 300m was added to the Webbs Cave survey bringing the total COMPASS length to 6100m covering an area of 580m EW and 340m NS but the survey was not completed.

Other Clubs, sometimes involving CEGSA members, conducted several trips.

Following information received from SA field Naturalists Association a search was made for U257 which was located and recorded. U32 was also relocated but U83 did not turn out as successful. In the intervening years the land has been converted to vineyard and the entrance to the cave has now been filled or covered. U240 was also located.

A report of additional caves in the Stewart Range area was received during the year by Deb Carden. This report was investigated and U264 – U268 recorded. Further visits will be required to document the caves. A new cave, U263, in the Cave Range, was surveyed. Various groups have visited the caves around Naracoorte during the year. Caves visited include U1, U3, U7, U8, U14, U15, U16, U44, U47.

In August a collapse near Kybybolite was reported in the press. The collapse was subsequently documented. The press also reported a cave rescue from The Slot in Wet Cave. A student became wedged in the slit which required the assistance of the emergency services to extricate him.

Upgrades to the Reserve have continued and the Loop Walk above the Blanche, Bat and Alexandra Caves has been completed. Only the observation platforms and interpretive material remain to be installed. This walk provides a wheel chair accessible walk around the cave entrances. CEGSA and FUSSI members provided assistance for various stages of the project. The late Ken Grimes also provided valuable input to the design of the walk and the interpretive material. His expertise in this field will be sadly missed.

Early in the year and in conjunction with the Cave Divers Association of Australia, negotiations were delicately commenced with the Western Australian Government's Department of Parks and Wildlife to reassess access capability for Pannikin Plains Cave. This cave was discovered by Dave Lowry in 1961, first dived by Ian Lewis and Keith Dekkers on a CEGSA trip in 1974, further explored by CDAA divers for several kilometres for a decade and then hit by a cyclonic storm in 1988 while a caving/diving party were inside filming a documentary. The doco went viral and the Pannikin story of how they all survived unscathed but lost tons of equipment under the rockpile has been shown many times on TV ever since. This year several cave geologists examined the rockfall zone in detail and concluded that there had been no movement in the near-30 years since, but that careful vertical rope work would be needed by skilled people for safe cave diver access to be resumed. These arrangements are being formalised and reports provided to the WA Government.

INTERSTATE AND OVERSEAS (excluding the Nullarbor plain)

In January, Ken Smith and Richard Harris returned to the Pearce Resurgence (NZ) where the team reached a depth of 229 m. Ken later joined a FUSSI trip to Yarrangobilly while Mark Corbett visited caves at WeeJasper with a NSW caving group. Mark Sefton went on several trips with MCCC at Mole Creek, including to Kubla Khan. Steve Milner joined a 'high tech' digging project in Ireland. Graham Pilkington and Mark Sefton again attended the annual Judbarra-Gregory expedition in the Northern Territory which resulted in a further 10 km of newly surveyed passages and several more cave connections. The Judbarra-Gregory National Park now contains almost 300 km of surveyed cave passages. They also spent two weeks in the Kimberly region with SUSS and FUSSI cavers, where a further several kilometres of cave passages were mapped and three new caves were discovered.






