PRESIDENT'S REPORT

2018 has seen good attendances and interesting speakers throughout the year which is great! I have also noticed a lot of socialising and ongoing informal conversations in the break between General Business and the Speaker. It is clear that members enjoy catching up with each other in different combinations from one meeting to the next, so factoring in some 'chat' time of an evening is something I would like to recommend. Finishing General Business by 8:15 has worked well to encourage this and also relieves general Meetings of business which can be handled by the Committee, where it should be. Gone are the 19th Century days of having meetings for meetings' sake, sitting in straight lines and loading up social time with routine business that can be delegated elsewhere. Great also to see the mingling of several generations of cavers, with younger members reminding the oldies of actual caving activities and in turn learning from the experience of the white-hairs and no-hairs!

Undoubtedly the most high-profile caving event that occurred in 2018 was the miracle rescue of the trapped boys in the flooded cave in Thailand, made so successful by our highly-modest CEGSA member and cave diver, Dr Harry Harris. As I write this, it is the day before the announcement of 'Australian of the Year' for Harry and his co-rescuer, Craig Challen. They have already received other national honours and deservedly so. Harry and Craig - CEGSA would sincerely like to acknowledge and praise the extraordinary efforts you both made! Ironically, the whole event raised the global profile of the obscure and cautiously-regarded sport of cave diving, letting everyone know by example that there are exceptionally-skilled cave divers on this planet who are in a class of their own with regard to experience. I think this has engendered a new respect for the sport, along with a slowly-developing understanding that cavers and cave divers are contributing to understanding about our global environment from within very special places - caves.

At the recent ASF Conference in Tasmania, the three South Australian caving groups offered to host the next ASF Conference in Ceduna at Easter 2021 with a major focus on Nullarbor activities, presentations and field trips. ASF accepted our offer and early planning is under way through our South Australian Speleological Council which has been revived in recent years after a long hibernation. Many thanks in advance to Steve Milner who has already canvassed support across the Ceduna business and local community who keenly support this event. It provides an excellent opportunity to raise speleology's profile in the Nullarbor community and the Co-Management partners from the SA Department of Environment and the Native Title holders of the Far West Coast Aboriginal Corporation, all of whom have a stake in further understanding and appreciation of the caves of the Nullarbor.

LIBRARY AND RECORDS REPORT

The major actions for 2018 were:

OzKarst

Now compiles a link table containing a summary of surface features for use by external software such as ESRI ArcMap GIS.

Bob Kershaw from ISS has created an OzKarst Users Group forum that any OzKarst user is invited to join. He's also expanded and systematized my users help manual into a more professional document.

Peter Dykes is proposing that a national cave and karst database be developed for the ASF that takes on many of the facilities and design features of OzKarst. As the ASF Cave and Karst numbering Coordinator, he's facilitating a forum to gather together all interested parties, especially State cave numberers, to develop this idea. Because Microsoft now insists on a yearly subscription to ACCESS – the database software used by OzKarst – it's expected that OzKarst will be ported to a freeware equivalent and used as the basis for the ASF database. The current ASF KID will continue as a webbased database but be developed so that it can be an extract from this new off-line version.

OzKarst Library

Peter Dykes is proposing that a national coordinator be appointed to oversee the collation of entries into the OzKarst Library. This would greatly improve the ad-hoc cataloguing that now takes place and would help in gathering digital copies for the ASF library. As more clubs use OzKarst to catalogue their own publications and libraries, it will stop a lot of duplicated effort; and because most club libraries contain the same books and journals, the ease of cataloguing will encourage clubs to catalogue what they hold.

Library

Our Physical Library collection increased by fewer this year because many journals and books are now obtained digitally and placed into OzKarst.

Bound Periodicals

In contrast to last year, only one cover was bound (containing the latest SSS Journals), giving a total bound of 59 titles and 485 covers (plus 42 duplicated covers). See last year's Annual Report for a summary. Half of our journal exchanges are now digital and don't need binding! I intend to print and bind some of the more speleological journals (if I can obtain high quality versions) because the "screen" version usually has poor quality images.

<u>Australian Speleological Federation REPRESENTATIVE REPORT</u>

At the 2018-19 ASF AGM, I was re-elected onto the ASF Executive, and assigned the position of Senior Vice-President.

The ASF has reduced their membership fee, excluding Introductory membership, as a one-off for our 2019 financial year by \$5 per membership category (the timing of the reduction in fee has had to be adjusted for each club because of the wildly varying financial years of the clubs).

During the coming year, the ASF Library will probably be moving from its current location in John Dunkley's home in Canberra to a venue in metropolitan Sydney. However, Jeannette Dunkley has volunteered to help catalogue the ASF library, including coordinating OzKarst entries.

From what I hear, the ASF Biennial Conference held in Tasmania in late December to early January 2019 was well attended and successful. We had about 6 members attend, outdone by FUSSI who had a dozen.

It was felt by the Executive that the ASF should represent ALL cavers in Australia. To do this the ASF needs to include clubs that are not exclusively caving clubs. One outcome of the AGM was an agreement to alter the ASF Charter so that Corporate membership is open to any organization that has speleology or caving as a main aim. Previously an organization had to have speleology as its primary aim. This meant that clubs that do multiple activities such as bushwalking, climbing, caving, canyoning etc could never become corporate members of the ASF. Of course, they could change their constitution to a caving club and just happen to do the other activities as well. After becoming a corporate member, they could then change their constitution back to what it was and the ASF Charter does not allow it cancel their membership status!! This juggling act is no longer necessary.

- Discussions with One Forty One and Forestry SA regarding recent access limitations to caves on their property
- Discussion of a potential ASF Conference to be held at Ceduna and the Nullarbor in 2021
- Running a combined clubs Search & Rescue event at Corra-Lynn Cave in September

CAVING ACTIVITIES



ADELAIDE HILLS & FLEURIEU PENINSULA

It never ceases to amaze that such a prospective area so close to Adelaide gets so little attention, although it is pleasing that there are some activities worthy of report.

Probably most noteworthy over the year was a familiarization visit to 5A5 at Sellicks Hill including a mixed group of FUSSI and CEGSA members. When excavation work on this cave was in full swing some years ago a number of ladders were left more or less "permanently" rigged in the interests of efficiency. Despite lack of effort in recent times, several of these pitches remained rigged, and one of the objects of this visit was to recover the now somewhat corroded equipment which had progressed to being a liability rather than an asset.

The consensus of the visiting party was that the cave is interesting and prospective, but no plan has yet been proposed for the regular working visits that would be required to achieve further progress.

Gathering and analysis of cave breathing and meteorological data remains the method of choice for confirming that there is a great deal more to this cave than has yet been entered/surveyed.

Little else has happened on the Fleurieu Peninsula, although discussions with land owners and managers are progressing.

A report has been received of a small cave/rock-shelter in the Adelaide foot-hills north east of Salisbury, known as Ifould's Cave. A copy of an article in The Chronicle, October 21st 1968 has been sighted and shows that the cave at that time (now 50 years ago) included some aboriginal art.

Blackberry spraying around cave entrances remains the main activity at Delamere. Consideration needs to be given to developing a practical plan for preventing hill-side soil from above a main cave entrance slumping into the cave and negating the efforts of diggers.

Dry caving activities were quiet with little activity reported. Only 6 new features were added during the year. A couple of these were recorded some years ago but never added to the system. As One Forty One is progressively felling plantations caves are able to be better documented and photographed. Drone technology also enables some good aerial photos.

L38 was visited a couple of times during the year. The cave is under the control of the minister of Police and the Noorla Yo Long campsite is used as a training venue. The police asked if we could review our position on access to the cave. It was visited by CEGSA members and police representatives. From the site assessment it was determined that the caves could be used for training visits without disturbing the resident bat population. Some additional survey requirements were also identified.

The Kilsby family has opened Kilsby Sinkhole as a commercial enterprise and from all reports is quite successful. Sales of the Sinkhole gin also seem to be doing well. We wish them every success in their venture.

Fred Aslin and Dave Lawson continue to update OxKarst with biological data from various CEGSA records and other publications

Ryan Kaczkowski has discovered an impressive fossil deposit in L230. The location affords good natural protection for the site which should prove to be a valuable addition to the fossil record.

Access to caves under control of One Forty One is still extremely limited. The restrictions have been reportedly imposed following an environmental assessment of the caves. I am not aware of CEGSA being invited to participate in such an assessment. This is an issue that the committee needs to address in discussions with One Forty One.

NULLARBOR PLAINS

The ASF Nullarbor Special Interest Group has still not yet been approved by the ASF because the SIG Charter has not been finalised. Before the idea fades into history, the SIG needs to appoint a person to drive the concept who is not already overwhelmed with other projects.

The annual VSA "flying" trip visited and located features in South Australia. Ken Boland is coming to the end of his piloting days hence drones are being considered to continue the task of systematically scanning for new karst features.

A joint CEGSA-SUSS trip continued the survey of **Webbs Cave** bringing the total COMPASS length to 6.7 km with a depth of 25m; the survey is still not complete. The **Old Homestead Cave** survey continued, mainly in the Spring Series to almost complete that area. Its COMPASS length is now 37.5 km after removal of duplicated surveying but some passages have not yet been surveyed. A new set of passages and very well decorated chambers was found in **Thampanna Cave** adding 0.4 km to the cave length and opening up a new area for exploration.

CEGSA and other Clubs, including ISS (areas near and north of the rail line), MSS (making geophysical measurements), and others, sometimes involving CEGSA members, conducted trips, some supplying data for inclusion in OzKarst.

Little caving activity in the upper south east was reported during the year. Despite the lack of caving activity the upgrade of visitor facilities at Naracoorte Caves National Park continues to proceed. A Nature Playground for big and little kids is being developed with input from local kids.

Work on the Roof Top Walk has now been completed. This provides visitors with a wheel chair accessible walk over the top of Blanche and Bat Caves. Viewing platforms allow a view into the cave entrances. Path treatment highlights where visitors are passing over the top of cave passages. Contributions from CEGSA members and CEGSA records helped to make this possible. The official opening was held on Tuesday 22nd January 2019.

Redevelopment of the surface of Victoria Fossil Cave is also proceeding. This will provide improved parking and facilities. Discussions with the contractors enabled the CEGSA survey datum at the top of the old entrance to be retained.

Another rescue of a lad from the slot in Wet Caves occurred during the year. Having had previous experience the rescue was much easier. The park service has now revised it's guidelines for adventure activities in the cave following these incidents

A visit to the Avenue Range area saw some preliminary survey work in U52 and the relocation of U40. Further work is planned to continue the work in these caves. Skinny cavers welcomed.

Congratulations to Dr Liz Reed on her award in the Science Communications category of the Unsung Heroes of SA awards. Liz spends many hours promoting and nurturing research behind the scenes at Naracoorte Caves.

CAVE DIVING REPORT

I have referred to the amazing cave diving rescue in Thailand in my President's report at the front of this document. The rest of we mere mortals have continued underwater activities in various karstic environments with interesting outcomes through 2018. Tank Cave in the South East near Tantanoola is one of the longest underwater caves in the country at ~7kms and the Cave Divers Association have a lease on the entrance area. In 2018, divers found a connection through a TINY tunnel into nearby Fossil Cave (Green Waterhole) on the side of the highway, where Rod Wells and his 'palaeoteam' had identified vast numbers of megafauna remains in the 1980's with the help of Peter Horne and friends. The new Tank Cave extension also skirts around Fossil Cave into another set of small chambers where more fossils have now been found completely undisturbed, showing that the western end of Fossil Cave was also once open to creatures seeking water when the water table was lower in the past. It's an outstanding discovery with the fossils being examined by Dr Liz Reed and others! Pete Horne and lan dived in Piccaninnie Ponds to examine and report on the underwater sensors which are linked to by telemetry to the Department of Environment's Groundwater Team in Adelaide, with a view to upgrading them. So science is thriving in subterranean submerged South Australia!

INTERSTATE AND OVERSEAS (excluding the Nullarbor plain)

Peter and Janine Kraehenbuehl went cave diving in Belize and Mexico, including in Dos Ojos Cave. Later in the year, Ken Smith went on a trip organised by Bruce Clulow from New Zealand to Mangaia Island in the Cook Islands. Here they explored several caves looking for diving opportunities and they also dived three fresh water resurgences on the rocky coast which have the potential to connect to inland caves. Graham Pilkington and Mark Sefton joined a SUSS trip to the Kimberly region where a program of exploration and mapping was continued and new caves were found. The group then joined Ken Smith and nine others at the subsequent annual Judbarra-Gregory (Bullita) expedition in the Northern Territory. This year, most of the exploration during the first week was focused in the Southern Karst which is on the west side of the East Baines river while during the second week the group switched their focus to the Dingo Cave System. Almost 14 km of surveying was conducted during these two weeks.
