

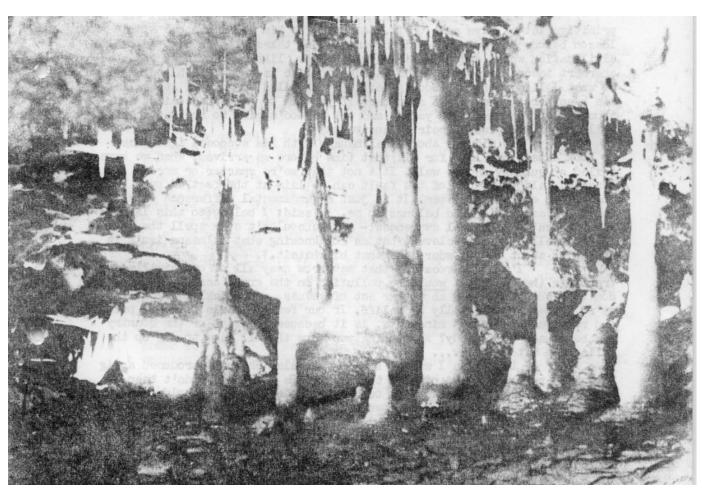

#### Editorial

#### Cave Conservation and You

Last year saw the formation of a conservation sub-committee within CEGSA and, in its infancy, it was moderately successful in initiating steps towards better conservation measures involving South Australia's caves. Attention was drawn in particular to the Lower South-east, and was focussed around water pollution. Submissions were made to the House of Representatives Select Committee on Wildlife Conservation and to the Minister of the Environment, Mr. Broomhill. Now is the time to follow up these steps and also to take new ones. But exactly what should be done? What can each of us, as an ordinary caver, do?

In all too many cases conservation action is not taken until damage has already been done, and it is indeed easier to fight for such causes when evidence is so blatantly obvious. The more ideal situation but the more difficult, however, is to bring about protection before any damage has been done and, therefore, preserve as much as possible the virgin beauty of the environment. But the stone-wall that is continually come up against here is: this needs no legislative protections after all, no adulteration has taken place! And why, indeed, should there be any protective legislation? This is for us to prove.

The question in our minds should now be: what can I do? We can all play a part in the movement for more complete cave conservation without even devoting excessive amounts of time to it. One of the first major moves is to record all salient information regarding our caves. Whether rubbish or perhaps rockfill has been dumped in the entrance, what signs of biological life are present, whether water runs through the cave, and so on; all this information and much more is of value in building an interim dossier for cave conservation if it is recorded.

Don't leave it to the trip leader or record it only in your mind. Even if the trip leader does write a report as he should, he may miss something you have noticed. Make sure that the information <u>in written form</u> is forwarded to the Committee or the Conservation Sub-committee, with your name attached, and remember - any information that is not recorded is worse than useless. By not doing all in your power to rectify an existing, developing or potential conservation problem you are merely condoning it and part of the problem yourself.

Please be an active conservationist before it is too late.

#### And Another Thing or Oops! My Bulldozer Slipped

While on the subject of conservation did you hear the one about the sugar gliders that used to live in the banksias in the Naracoorte Caves Reserve near Mosquito Creek until one day when some big bad men with a bulldozer chopped down their homes and heaped them into big heaps for burning. Now those men weren't really bad men, in fact they were good men, and they didn't want to harm the sugar gliders, in fact they didn't even know that the sugar gliders existed. They do now but it is too late. When they had finished their handiwork they must have stood back and felt proud, because they considered that they were "cleaning up" and therefore beautifying the area, and were motivated only by the highest of ideals. That is the sad sad moral of the story. Nobody can be expected to know everything, but how do we get people to recognise when they don't know and to ask somebody who does? When even major Government departments and Authorities are not geared to do this, how can we expect it of others? Plenty of people have offered advice since the centuries old banksias were flattened. Who would have thought to give it beforehand? We must Learn to recognise situations through the eyes of others and must try to educate others to the point where they at least have a doubt and seek advice.

Nobody can really be blamed in this exercise, not the Naracoorte Council who were trying to be helpful in carrying the work out nor the Tourist Bureau in Adelaide who okayed a reserve clean-up but lot with this outcome in mind. The tragedy is, as is often the case, not one of malicious determination to exterminate sugar gliders, but simple common human misunderstanding.

To make mistakes is human, we all do. It is to be hoped though that once having made those mistakes we are as quick to recognize them and do something about it as the Tourist Bureau has been in this instance. Full marks go to the Bureau who are already making every effort to replant and look after a carefully selected range of native trees and shrubs in the area. This will involve many times the amount of work involved in the clearing procedure but it will be well worth it. In a few years it may again become a haven for the sugar gliders if they can hold out that long, if any at all are left anywhere. In a hundred years our descendants (if anybody still survives on this poor old planet) visiting the area will unconsciously thank the planters of those trees.

And as a closing thought ... How long is a hundred years in scheme of things? Try planting a cave and watch it grow. Deary me rumour has it that it takes a thouwwwzand long years jus' for a hexatite to grew an inch (2.54cm in SI units surveyors please note)!

#### **Distant Horizons**

John Dunkley reports in the SUSS Bulletin that the New Zealand Speleological Society 1971 - 1972 Summer Expedition, which was attended by 11 Australians (a full-scale invasion) and 10 New Zealanders was an outstanding success.

The trip was to Mount Arthur, near Nelson in the north-west of the South Island, and most of the food and equipment was lifted in by helicopter. The expedition saw the discovery, exploration and mapping of a new deep cave, named Gorgoroth for some no doubt perverse mythological reason. When will the CEGSA nomenclacats dream up something to match this? It sounds much more impressive than 'rabbit borough cave' or some other equally wet name, but then again it seems that not only the name is more impressive than the normal South Australian rabbit borough. With a depth of 1140 feet, including an internal sheer drop of 450 feet, it is in world class and only second deepest in the Southern Hemisphere.

Albert Goede, in a letter to Alan Hill mentions in passing that T.C.C. has surveyed Khazad-Dŭm to the bottom last month and found, it to be 1029 feet deep. There's still hope. A new high level system of passages was discovered going off from the top of the last big chamber. It was not fully explored due to lack of time but a big expedition is being planned for next summer. (Surely you don't plan to clash with the ASF Conference, Albert. If you do you will make it very hard for our erstwhile compatriot Norm (cream) Poulter to come down and show you how it ought to be done).

Speaking of Norm, he was last heard to be surveying the unemployment situation around Perth, and about ready to pull out for Sydney.

And another voice from the past, Tom Wigley reports from Canada that he has just abandoned an attempt on the world record in not writing letters, and may even be seen crawling through the odd Australian cave later this year if you happen to be in the right cave. He would have broken the world depth record in the Epos Chasm in Greece a few years back except that just as the cave got going it stopped, and anyway the limestone didn't appear to be as thick as the map suggested it was. He hopes to be taking part in yet another world record depth attempt shortly in Iran. This hole sounds a better proposition. "-2400 feet so far and at that point the next drop was into the main passage. Most of the pitches are less than 150' (but there are 22 so far) and the plan is to use ladders on the first few and ropes thereafter. Even if it doesn't go it will be a fabulous place to visit." Anyone got itchy feet?

The copy of the film viewed is the private property of Brother Nicholas, the biologist on the expedition, and was loaned to Sydney Speleological Society to help them raise money in their fight to save Bungonia Gorge, the latest New South Wales conservation disaster area.

#### The Saga of Sellick's Hill Cave

The numerous unpublished reports of trips to this cave run into so many words, most of them now superfluous, that a summary of the events to the present will be much more digestible. The first report in the Newsletter of October 1971 noted that the cave (which had not been visited for over a year) appeared in July 1971 to be stable so far. Since it was discovered during the creation of a cutting during road works it was decided to go slowly in the cave for a while in case the nearby blasting and rock shifting had stirred the cave up or generated any new stresses which could slowly or quickly cause the cave to alter its shape. The feeling at the passing of a year or so is that the cave is safe from that point of view, but needs some internal stabilizing for other reasons. At that stage the depth stood at about sixty feet (it started originally at three feet) and a succession of small digging trips became more and more exciting with only small gains being made under difficult conditions until a trip on 5 September 1971, attended by G. Gartrell (L), M. Meth, N. Poulter, A. Saar (WASG), P. Chappell, B. Dunn, and D. Hawke saw the plug pulled out. In the excitement, discretion was thrown a little too much to the winds, and Gartrell and Poulter got a graphic lesson in stability when three medium-sized boulders which had been stacked out of the way on the side of the choke (apparently on a dirt plug) shifted and rained down upon them. Norm Poulter also got a cracked rib, partly made up for by the ceremonial presentation of a leather rib at the last Annual Dinner. We were all extremely lucky, and no-one on that trip will ever forget it. We'll try to heed the lesson and recommend that others do too. Needless to say that was the end of caving for the day.

On 7 - 11 - 71 G. Gartrell, N. Poulter and B. Dunn returned to the cave and inserted a loxin ladder belay in the roof above the bottom point of previous trips to the cave. Two lengths of ladder were attached by karabiner to it (40 feet altogether required) and the party descended with caution to a small chamber amongst a large rock-pile. From this chamber a rope descent of 12 feet (preferably a ladder should be used next time) led to a fissure cave in which the floor descended in a series of steps. This ran for approximately 100 feet altogether before being blocked by a rock-choke. Both walls were sound and covered with live white nodular formation and flowstone for most of their length. Quite pretty. Ceiling height of the fissure was uncertain but generally in excess of 30 feet. The floor appeared to be a rock choke of varying width and in one place at least a hole worth excavating could be seen descending at least ten feet below the general floor level.

The cave should be treated with extreme caution, particularly near the ladder drops. It is recommended that party sizes be limited to three or four below the ladder at any one time, and that experienced cavers only be allowed in this cave. Total depth so far is estimated at over 150 feet. A preliminary survey will be conducted on the next trip and may indicate the desirability of reopening and gating the roadside entrance (obviously an upper level continuation of the deep fissure) due to the constricted nature of the present route and the difficulties of ensuring the stability of the ladder drop section. Still, the cave could yet be worth all the work.

#### Easter Bunnies

The R.A.A. reported record enquiries about the south-east for Easter this year and cavers seemed to have the same ideas. It pays to stick to the back tracks and be ready to take to the bush at a moment's notice these days, as somehow the main roads just seem to be filling up with suicidal (if that was all it wouldn't matter) idiots. You really are much safer once you are down the cave. Phew!

Separate groups were caving under the direction of Fred Aslin and John Foulds in the Glenelg River region, and there seems to be a lifetime's work there for all of them. A beautiful and intriguing caving area, well worth the long drive from Adelaide. A select contingent of Victorians, Peter Robertson, Miles Pierce and his wife Rhonwen (Rocky to veterans of the Tasmanian ASF Conference) were also busy in the area.

Meanwhile, (back at the farm) approximately a dozen from the Broken Hill Barrier Rangers, a similar number from Monash University (all good caving 'heavies'), a slightly larger group of geologist surveyor types from Flinders University (also went well underground) and a fair selection from CEGSA (cavers extraordinaire without a doubt naturally) still didn't manage to burst Naracoorte at the seams. Digging work was done in Sand-Funnel Cave by the Barrier Rangers who did a compass survey of the sections of interest and noted a breeze or two. They are keen to return and carry on the good work, but a 1000 mile round trip is a bit much for ordinary weekends. The Monash team enthusiastically dug in all directions in Dennis Carter's back paddock cave. Whether through luck or brilliance we may never know, but one of the company managed to find a hole with a breeze after a number of previous CEGSA trips found no encouragement at all. Subsequent work enlarging the hole by CEGSA shows that with a little persuasion the cave might take off.

Following a five man dig by twelve men, a number of ladies, and Monica, the end sand-chamber in Fox Cave now has a new decoration. (Don't worry Bill, CEGSA has inspected it and finds it to be more than worthy of such a fine cave.) As a reward for their labours the Monash crew were taken through the smallest tightest juiciest squeeze in the cave (all but one who wouldn't fit). They commented that it reminded them of Trog-Dip at Buchan, so be warned if any mad Victorians ever try to get you to visit that cave.

#### Gear Overhaul and Stock take

The Quartermaster, David Hawke, requests that all outstanding Group equipment be returned to him immediately for checking and stock take. Trip leaders are reminded that unless prior arrangements have been made with the Quartermaster all gear on loan should be returned within one week of the conclusion of the trip. Failure to do so may inconvenience others who need to borrow the same equipment and may result in your being liable for further hire charges. While it is the job of the Quartermaster to check the equipment state of repair after each trip and before loan, you are asked to advise him of any damage to or faults developing in the gear when returning it. Please ensure that everyone looks after it. Don't let ropes be packed alongside car batteries in car boots. Don't tread on the rope while belaying (or any other time). Somebody's life (yours perhaps) may depend on that rope - and before you ill-treat a ladder you should attending a working bee and help to make one. You may get the chance yet this winter.

#### Notice of Motion for Alteration of the Constitution

It has been proposed by –J. Foulds (seconder: G. Gartrell) "that Section 3, subsection (a), subsection (i) of the Constitution be altered to read:

"(i) who are over 18 years of age and completed 50 hours as a member of an active caving party in not less than three months of Associate Membership, and satisfy such other requirements as shall be determined by the Committee."

This motion will be put at the General Meeting, Museum Lecture Rooms on 24th May 1972, opening at 8.00 p.m. You are reminded that of the members present who are eligible to vote a 75% majority is required for this motion to be carried, and that no business can be conducted at a meeting without a quorum. Please try to attend.

The purpose of the motion is to empower the Committee to implement a program for upgrading the status of Full Membership of the Group. At present it is possible for an Associate to fulfil the technical requirement of 50 hours underground without learning much at all. Whether a variety of caving techniques is or is not necessary for that person to continue to cave within his or her limited sphere quite successfully, there is a great deal of merit in the proposal that all Full Members should at least be aware of the numerous facets of this pursuit. Only then will they be able to teach others, make balanced decisions should they find themselves on committees or in the voting arena, and be capable of acquitting themselves well should they visit more demanding caves or should they be confronted with an emergency.

These days the caving climate has unfortunately changed. Even at the last frontier, where in the past we could go to get away from it all, we are now confronted with such depressing issues as conservation. It is the responsibility of every member to become conversant with the problems and politics of caving, and with techniques such as surveying which help us to tackle these problems. It is the responsibility of the Group to nurture these responsibilities and skills in its new members. In this way we should all find that we can get more out of caving by giving more to it, and perhaps enjoy it even more than we do at present.

Your support of the above proposed Constitutional change will pave the way for formulation of a reasonably simple training program requirement for Full Membership. Before you vote against it consider carefully whether you would be an asset or a liability in an emergency. Could your incompetence endanger the lives of others? Have <u>you</u> been to one of our training field days yet? In any case try to get to our next one. It's in the program. 23rd July.

It should be well received throughout the world, but is particularly valuable to Australians because of the numerous local karst features explained and used as examples. No. 3 is also recently published and well presented. It is similar in form to No. 2.
