EDITORIAL

The latest cave diving deaths in Piccaninnie Ponds highlight a problem that is very real in dry caving as well as cave diving; IRRESPONSIBILITY.

Those gung-ho types who think they don't need others and the codes they abide by usually end up killing themselves and their sport. Consequently many landowners are becoming more concerned as to their liability if someone injures themselves while caving under their property.

To-date our record in South Australia is good and we have cordial relations with the majority of landowners. It is our <u>responsibility</u> to ensure that we are:

- 1) properly equipped for safe caving.
- 2) have reasonably notified the owner prior to the trip.
- 3) observe all the landowners requests even if they may appear unreasonable.

For many years the majority of caving was done through CEGSA. The situation has now changed with many people caving individually. We now have a responsibility to educate these groups in safe caving practices and ethics. Where possible they should be encouraged to join recognised caving groups. It is also our responsibility to have a programme of events sufficient to cater for the needs of those who want to gain experience and those who want to cave.

Part of our responsibility extends to the conservation of caves. Most caves have a visitor tolerance level. Quite often if a cave or part of a cave is gated it is for this reason. Gates are there to regulate the numbers of visitors through a cave to prevent destruction through over-use. The non-gated section of Blackberry demonstrates this. Despite the gate and minimal CEGSA visitation the gated section is now heading along the same path of destruction.

The best way to ensure that we are able to cave is to visibly demonstrate to other cavers and landowners that we can cave responsibly and still enjoy it.

Trip Reports

CORRA LYNN

CORRA LYNN TRIPS FEB/MARCH 1984

What has been dreamed of for decades came true this year, the wistfully grovelled after DREAMLAND mentioned as a hopeful conjecture in the last Newsletter is REAL! About 8 trips (yes, nearly every weekend) have pushed the length of DREAMLAND from a pie in the sky to about 4.4 km of which 2.8 km is surveyed. The ALBERTA section that leads to DREAMLAND is about 600m long of which 500m is mapped. The "old" cave is 6.3 km long.

To save you the trouble of re-checking the figures you've just totalled, Corra Lynn Cave is now about 11.6 km long (9.6km surveyed) with lots of unexplored leads. On average, each trip extends the known cave by 500m, even though after the third trip we have concentrated on surveying already explored cave. Naturally at 700m of survey a weekend the survey grade is only at M32 level but who cares with all that blackness beckoning?

Technical & Other Articles

AURA - Australian Rock Art Research Association

AURA is an association set up to promote the study of prehistoric rock art. Members of AURA are studying art in caves along the southern coast of Australia. Attention has recently been focused on caves in the Lower South East region where many caves with rock art (as distinct from animal scratches) are being recorded.

In the past many of these sites have been ignored or overlooked as people have simply lumped all scratch marks under the category of animal.

CEGSA members are asked to look out for sites with engravings or possible engravings in their exploration of caves. Any suspected sites can be reported to GEOFF ASLIN of 7 Campbell Street Millicent 5280 (h) 087 33-3277, who will arrange to have site authenticated and appropriate preservation measures taken where necessary.

If any CEGSA member is interested in joining AURA, an application form is included in the Newsletter.

THE AUSTRALIAN ROCK ART RESEARCH ASSOCIATION

An association promoting the study of prehistoric rock art has just been established in Australia. Any person or organisation interested in this area of research is encouraged to request membership.

The principal objectives of the Australian Rock Art Research Association (AURA) are as follows: to provide a forum for the dissemination of research findings; to promote Aboriginal custodianship of sites externalising traditional Australian culture; to co-ordinate studies concerning the significance, distribution and conservation of rock art, both nationally, and with individuals and organisations overseas; to institute a Code of Ethics regarding research in this field and to generally promote awareness and appreciation of Australia's immovable cultural heritage.

Whilst AURA is concerned principally with the Australasian region, it also strives for international contact, communication and involvement. The Association intends holding regular general meetings. A newsletter is already being issued, reporting current developments and matters of immediate importance, and serving as a direct communication channel. A journal will be published twice yearly, commencing in May or June 1984. It will feature research papers, short reports, abstracts, reviews, letters, and a current bibliography.

THE NULLARBOR - WHERE?

In the Adelaide Advertiser 27 March 1984 the Australian Heritage Commission published a list of items that have been included in the register of the National Estate.

One item was described thus:-

"Wilsons Bluff Flint Quarry (State Register Item 4734-1316). Approximately 157 ha; located 6.5 km south of Bordertown and defined as the area above high water within a circle radius 1 km centred at Australian National Grid point (yards) SH52-13 "Coompara" 19350785.

One assumes the map sheet they refer to is in fact the COOMPANA sheet, not COOMPARA. That slight typographical error aside I find myself a little geographically embarrassed. I always understood Bordertown was east of Adelaide. No wonder the Melbourne Express takes so long.

If their description implies the high water is 6.5 km south of Bordertown we have lost 2 life members due to drowning and all the caves I have been relocating at Naracoorte and Mt Gambier don't really exist at all.
