Response to WA State Sustainability Strategy Draft Youth Arts Network WA

CONSULTATION

Consulting Citizens: A Resource Guide identifies young people as a group that require special consideration in consultation processes. Not only do community issues impact massively on young people, they are also less likely to respond to traditional means of consultation. Whilst it fails to provide any guidelines or proposed implementation strategies, the Consulting Citizens guide has also identified that creative consultation processes need to be used with young people

Our concern with the draft strategy is that it may not represent and incorporate young people's views and valuable contributions due to the consultation processes employed. Upon questioning a staff member involved in the draft strategy, we were informed that there had been some opportunities for young people to be involved in the formation of the strategy. These included involvement of Murdoch University students, a workshop at the Student's and Sustainability Conference in July 2002 in Perth, and a workshop at the Youth Affairs conference in May 2002. These are certainly good beginnings or engaging young people in the consultation process. However, these workshops would have attracted a very specific demographic of young people, and thus our concern remains that a wide range of young people did not have the opportunity to be involved due to a lack of appropriate opportunities.

Young people cannot be expected to come to a seminar run by people they may not relate to, in a style they do not enjoy, or if it has been advertised through inappropriate means. We appreciate the difficulties in engaging young people in consultation and other processes – it can require additional resources, but more often than not requires a whole different way of thinking. Ongoing consultation can be integrated with other sustainability goals – as the style that many young people respond to includes more 'hands-on' and creative approaches. Thus actually engaging young people in a myriad of sustainability related activities can provide a natural avenue to also conduct consultation.

Recommendation:

- Develop and implement best practise guides for appropriately consulting with young people.
 - Involve key organisations and young people themselves in the development of these guides
 - Revise them regularly.

Action

In the chapter of Multiculturalism & Sustainability, an objective is stated: "Developing strategies for public sector services to respond to the needs of diverse groups of clients, including newly arrived migrants, refugees, women, seniors and youth".

However, there is neither any actions underway, nor any proposed actions to address the development of these strategies for responding to the needs of *young people*.

Recommendations:

- "Cultural awareness training across the public sector" to specify and include training re: young people's strengths, needs and issues.
- Increased opportunities for the public sector to network and develop partnerships with various government and non-government organisations representing young people (and other multi-cultural groups)

Youth Arts Network Involvement
